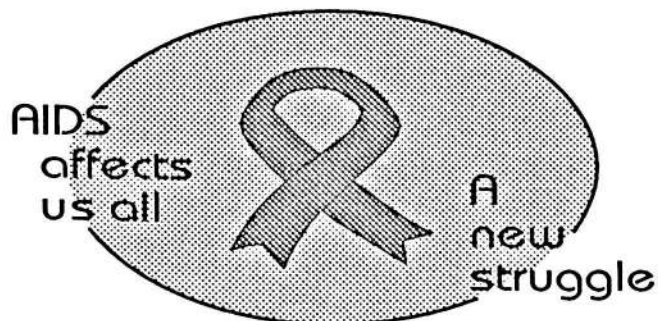

No. 11**30 April 2001****GAMBLING AND BETTING ACT, 1997 (EASTERN CAPE) (ACT No. 5 OF 1997)****AMENDMENT OF EASTERN CAPE GAMBLING AND BETTING REGULATIONS, 1998**

Under the powers vested in me by section 80 of the Gambling and Betting Act, 1997 (Eastern Cape) (Act No. 5 of 1997) (hereinafter "the Act"), I, Enoch Godongwana, in my capacity as member of the Executive Council responsible for the administration of the said Act and financial matters in the province hereby—

- (a) give notice that, after consultation with the Eastern Cape Gambling and Betting Board, intend to amend the Eastern Cape Gambling and Betting Regulations contained in Provincial Notice No. 34 of 1998 promulgated on 25 September 1998 in *Provincial Gazette* No. 338 (hereinafter "the Regulations") as set out in the Schedule;
- (b) determine in terms of section 80 (5) of the Act that the public interest requires the above to be made without delay; and
- (c) determine that the said regulations shall come into operation on the date of publication hereof.

Regulation 44 of the Eastern Cape Gambling and Betting Regulations, 1998 (Provincial Notice No. 34 of 1998), is hereby amended by the insertion after subsection (4) of the following subsection:

- "(5) Notwithstanding the provisions of this regulation, a licence holder may, with the prior written consent of the board, conduct the hard count and soft counts in a single room, in which case such room must comply with the requirements in this regulation for both the hard count room and soft count room."
