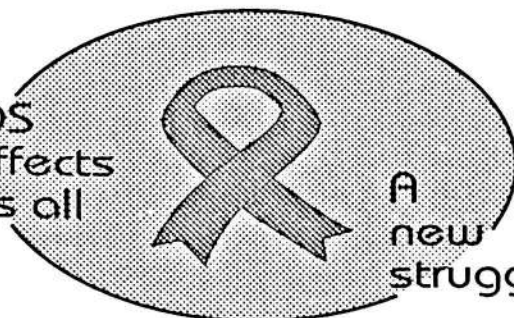

CORRECTION NOTICE**CORRECTION OF PROVINCIAL NOTICE NO. 3 OF 2001**

Provincial Notice No. 3 of 2001 published in Provincial Gazette Extraordinary of 22 February 2001 is hereby amended by the substitution for Act No. 1 of 2001 of the following Act:

"No. 1 of 2001 (E.C.): Provincial Tender Board Amendment Act, 2001 (Eastern Cape).

ACT

To amend the Provincial Tender Board Act, 1994 (Eastern Cape); to determine the date of establishment of the Provincial Tender Board; to validate the actions taken by the members of, or by persons or committees appointed by, the Board since the date so determined; and to provide for matters incidental thereto.

BE IT ENACTED by the Legislature of the Province of the Eastern Cape as follows:-

Amendment of section 2 of Act 2 of 1994

1. Section 2 of the Provincial Tender Board Act, 1994 (Act No. 2 of 1994), is hereby amended-

- (a) by the substitution for subsection (1) of the following subsection:

"(1) There is hereby established, deemed to be with effect from 25 October 1995, a Board known as the Provincial Tender Board.";

- (b) by the insertion after subsection (1) of the following subsections:

"(2) All persons who have, from time to time, since 25 October 1995, been appointed pursuant to the provisions of section 3, shall be deemed to have been validly appointed as members and alternate members of the Board for the periods for which they were appointed to serve, or actually served in the event of having vacated office before the expiry of their terms of office: Provided that the current members and alternate members shall hold office in the capacities to which they have been appointed to the Board for the remainder of the period determined at the time of their appointment as such unless they vacate office sooner.

(3) Notwithstanding anything to the contrary contained in any other law, all powers exercised, duties or obligations performed, directives issued, resolutions and actions taken or anything else done by the persons appointed as members of the Board, or by any committee, person, body of persons or holder of a post designated by the persons purporting to be the Board, on its behalf, since 25 October 1995, shall be deemed to have been validly done by or on behalf of the Board."; and

- (c) by appropriately renumbering subsections (2) and (3) as (4) and (5), respectively.

Short title

2. This Act is called the Provincial Tender Board Amendment Act, 2001 (Eastern Cape)."
