

CANCELLATION OF CERTAIN SERVITUDES AND RESTRICTIVE CONDITIONS RELATING

TO FORMALISED TOWNSHIPS:

I, Gugile Emest Nkwinti, Member of the Executive Council for Housing, Local Government and Traditional Affairs, duly authorised thereto, hereby give notice in terms of section 7 (1) of the Upgrading of Land Tenure Rights Act, 1991 (Act 112 of 1991), of the cancellation of the under-mentioned restrictions, servitudes or conditions which are registered against the title deeds of the land on which the under-mentioned formalised township are situated and for which township registers have not yet been opened which cancellation will come into effect in terms of section 7 (2) (b) 60 days after the date of publication of the notice or, if the township registers are not yet opened after the expiry of the said period, at the opening of the township registers, as well as that such cancellation may be withdrawn prior to the expiry of the said period or prior to the opening of the registers, as the case may be.
