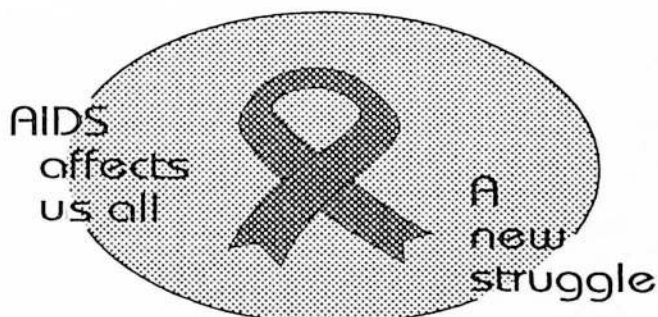

Schedule

In terms of section 18(3) of the Local Government: Municipal Structures Act, 1998 (Act 117 of 1998) the MEC responsible for local government has determined that the municipal council consists of 8 councillors.

After having consulted the Independent Electoral Commission, The Municipal Demarcation Board has delimited the municipality into 4 wards in terms of Schedule 1 to the Act.

The number of registered voters in each ward does not vary by more than fifteen percent from the norm. The norm was determined by dividing the total number of voters on the municipal segment of the national common voters roll, namely 13185 voters on 20 February 2004, by the number of wards in the municipality.

The **Nxuba Municipality** comprises of 4 wards. The ward numbers, the voting districts in each ward, and the number of voters are as follows:

Ward 1 consisting of 3142 registered voters comprising the following voting districts:

- Voting district 10540022 (LINGELETHU LIBRARY) comprising 2304 registered voters
- Voting district 10540055 (TOWN HALL ADELAIDE) comprising 616 registered voters
- Voting district 10760048 (NIEUWELINGS) comprising 222 registered voters

Ward 2 consisting of 3253 registered voters comprising the following voting districts:

- Portion of voting district 10540011 (BEZUIDENHOUTVILLE COMMUNITY CENTRE) comprising 1219 registered voters
- Voting district 10540033 (LINGELETHU COMMUNITY CENTRE) comprising 2034 registered voters

Ward 3 consisting of 3538 registered voters comprising the following voting districts:

- Voting district 10560013 (BEDFORD MUNICIPALITY) comprising **2178** registered voters
- Voting district 10560024 (MSOMBOMVU COMMUNITY HALL) comprising **1360** registered voters
