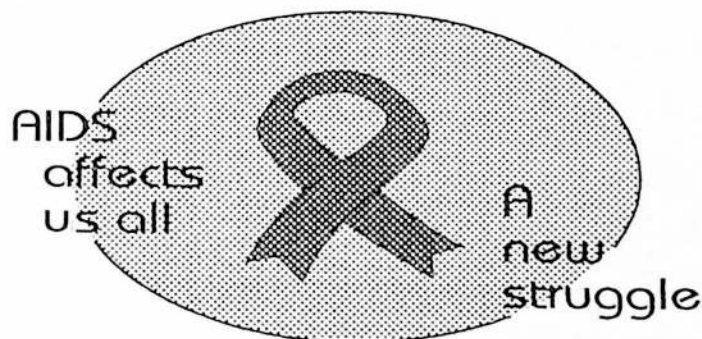

Schedule

In terms of section 18(3) of the Local Government: Municipal Structures Act, 1998 (Act 117 of 1998) the MEC responsible for local government has determined that the municipal council consists of **12** councillors.

After having consulted the Independent Electoral Commission, The Municipal Demarcation Board has delimited the municipality into **6** wards in terms of Schedule 1 to the Act.

The number of registered voters in each ward does not vary by more than fifteen percent from the norm. The norm was determined by dividing the total number of voters on the municipal segment of the national common voters roll, namely **18486** voters on 20 February 2004, by the number of wards in the municipality.

The **Maletswai Municipality** comprises of **6** wards. The ward numbers, the voting districts in each ward, and the number of voters are as follows:
