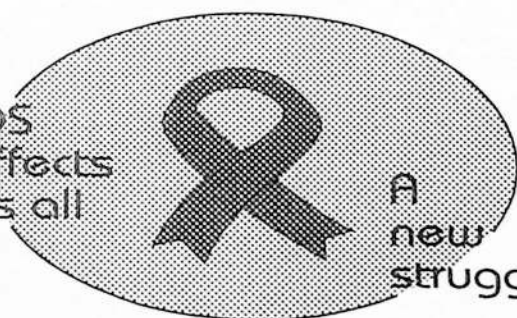



**DEPARTMENT OF ECONOMIC AFFAIRS, ENVIRONMENT & TOURISM****GAMBLING AND BETTING ACT, 1997 (EASTERN CAPE)  
(ACT NO. 5 OF 1997)****AMENDMENT OF EASTERN CAPE GAMBLING  
AND BETTING REGULATIONS, 1998**

Under the powers vested in me by section 80 of the Gambling and Betting Act, 1997 (Eastern Cape) (Act No. 5 of 1997) (hereinafter "the Act"), I, ANDRÉ DE WET, in my capacity as member of the Executive Council responsible for the administration of the said Act and financial matters in the Province hereby —

- (a) after consultation with the Eastern Cape Gambling and Betting Board, amend the Eastern Cape Gambling and Betting Regulations contained in Provincial Notice No. 34 of 1998 promulgated on 25 September 1998 in Provincial Gazette No. 338 (hereinafter "the Regulations") as set out in the Schedule; and
- (b) determine in terms of section 80(5) of the Act that the public interest requires the above amendment to be made without delay; and
- (c) determine that the said regulations shall come into operation on the date of publication hereof.

### SCHEDULE

The following Regulation is hereby substituted for Regulation 137 of the Eastern Cape Gambling and Betting Regulations, 1998 (Provincial Notice No. 34 of 1998) (as amended):

**“Transitional provisions**

137 Notwithstanding the provisions of regulation 111 the computerized betting system of the holder of a bookmaker licence or totalisator licence shall not have to comply with the provisions of regulation 111 until 15 December 2005.”
