# SUNDAYS RIVER VALLEY MUNICIPALITY LIQUOR SELLING HOURS AND WARD COMMITTEE CONSULTATIVE MEETINGS

It is hereby published for general information that the Municipal Council of Sundays River Valley, acting under the authority of Section 11(3) (m) of the Local Government: Municipal Systems Act, 2000 (Act no 32 of 2000), read with sections 22 (2) (d) and 42 (b) of the Eastern Cape Liquor Act, 2003 (Act No 10 of 2003), has taken a decision on, and passed, a by-law on liquor selling hours and ward committee meetings.

#### 1. DEFINITIONS

In these by-laws unless the context otherwise indicates -

- "Act" means the Eastern Cape Liquor Act, 2003 (Act no 10 of 2003);
- "Board" means the Eastern Cape Liquor Board established by Section 4 of the Liquor Act.
- "Council" means the Sundays River Valley Municipality
- "community" means the resident, governing body of schools or Places of Worship within a 100m radius from the premises in respect of which the application for registration is made.
- "hotel" means premises, wherein or whereon the business of supplying lodging and meals for a reward is or is intended to be conducted, and includes a motel, inn, bed and breakfast, caravan and camping park, farmhouse, guest-house, a lodge, boatel boat and a house boat;
- "official" means any person authorized by Council to perform the function of an officer under these regulations and includes any member of the South African Police Services and any person appointed in terms of the Act.
- "premises" includes any place, land, building or any part thereof which is registered or seeking to be registered, to permit trade in liquor.
- "regulations" means the regulations, published as Notice No 1159 of 28 May 2004, made under the Act;
- "residential premises" means premises zoned to permit residential purposes as per the applicable Zoning Scheme Regulations;
- "selling hours" means the time at which a trader must cease to sell liquor to any person in terms of schedule 1.

- "trader" means a person who is registered in terms of section 19 of the Act, and any other words or expression to which a meaning has been assigned in the Act and Local Government: Municipal Systems Act, 2000 (Act No 32 of 2000), carries that meaning;
- "ward committee" means a committee as contemplated in the Local Government: Municipal Structures Act, 1998 (Act No 117 of 1998)

# 1.2 APPLICATION OF BY-LAWS

This by-law shall be applicable in respect of all premises situated within the area of jurisdiction of the Council where trade in liquor is conducted or is intended to the conducted.

### 1.3 LEGISLATIVE FRAMEWORK

These by-laws fall within the legislative framework of the -

- a) Constitution of the Republic of South Africa, 1996 (Act No 108 of 1996)
- b) Local Government: Municipal Systems Act, 2000 (Act No 32 of 2000)
- c) Local Government: Municipal Structures Act, 1998 (Act No 117 of 1998)
- d) Eastern Cape Liquor Act, 2003 (Act No 10 of 2003)

#### 1.4 SELLING HOURS

- 4.1 The Council has determined the selling hours of the different types of registrations listed in the first column of Schedule 1 as the selling hours listed in the second column of the said Schedule.
- 4.2 A departure from the hours stipulated in Schedule 1 shall be upon application and approval by Council.
- 4.3 Council reserves the right to depart from the stipulated selling hours in the interests of the community.
- 4.4 An applicant/owner who apply for the departure in terms of section 4(1) and (2) must follow the following procedures;-
  - (a) The Applicant or owner of the establishment must place an advert in the local news paper for a period of 14 days expressing his/her intention to apply for a departure and provide the hours of which he/she will apply.
  - (b) The Applicant or owner must thereafter apply to the Council for a departure and submit the advert placed in the local new paper and a complete application form to the offices of the Council.
  - (c) The Council shall after thirty (30) days of submission of an application, either reject or approved such application made terms of section 4 (4) (b)
- 4.5 The Council may reduce the hours for selling of liquor of a premises, if a person/owner continuously contravenes sections of this bylaw, contravenes sections of the Liquor act

or and if the conduct of the business has an adverse effect on the rights of the community.

4.6 Before the Council reduced the hours as contemplated in section 4(1) it will give the person/owner 14 days notice of its intention to reduced the hours with full reasons.

## 5 WARD COMMITTEE CONSULTATIVE MEETINGS

- 5.1 The Ward Committees must, upon receipt of a notice of application for registration, in terms of Section 22 (2)(d)(i) of the Liquor Act hold consultative meetings with the community of the area within 100 metres of the premises to discuss and solicit their views with regard to the application that the applicant intends to lodge with the Liquor Board.
- 5.2 The Ward Committee must within 30 days in terms of section 3(2) of the Regulations, Notice 1159 of 28 May 2004, made under the Act) compile a report and submit it to the Liquor Board and Council, stipulating the date, time, names and the addresses of the people who attended, indicate whether it objects to or the recommends the application and what additional conditions it proposes, if any.

#### 6 ENFORCEMENT OF THE BY-LAW

Any non-compliance with the trading hours as stipulated in this By-Law shall be actionable by the Liquor Board in terms of section 28 of the Liquor Act and may be prosecutable in terms of sections 57 and 59 read with section.

## 7. Penalties

Any person who contravenes or fails to comply with the provisions of this By-law is guilty of an offence and upon conviction may be liable to a fine or imprisonment, or to both a fine and imprisonment.

# 8. Short title and commencement

These By-laws may be cited as the liquor Trading By—laws repeals all previous by-law if any and it is effective from the date of publication hereof in the Provincial Gazette.
