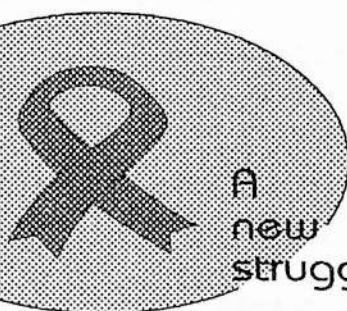

## SCHEDULE A

DISASTER ADJUSTED ESTIMATES FOR NOVEMBER / DECEMBER 2004 STORM HEAVY RAIN AND SHACK FIRE DISASTERS

In terms of section 25(2) of the Division of Revenue Act, 2005, Act No.1 of 2005 a provincial Accounting Officer intending to make an allocation other than an allocation listed in any schedule to the Act, to a municipality from the provincial revenue fund must publish such information in a provincial gazette.
