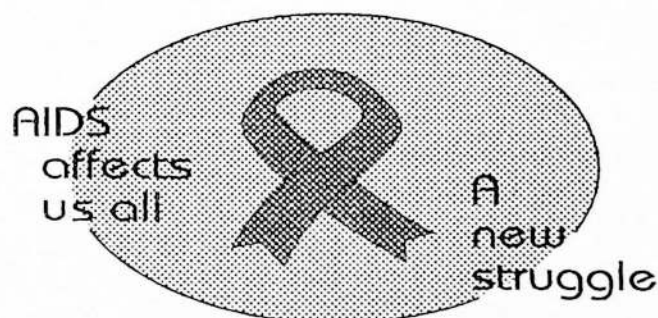



## **SCHEDULE**

### **PURPOSE OF THE ADVISORY BOARD**

1. The purpose of the Advisor Board is to advise the MEC on matters relating to Agricultural Development for the Province of the Eastern Cape.

### **COMPOSITION OF THE COMMITTEE**

2. The Advisory Board shall be composed of 15 members selected and appointed in accordance with paragraph 3.

### **PROCEDURE FOR SELECTION AND APPOINTMENT**

3. Members of the Advisory Board shall be selected by MEC from persons who have knowledge and experience in Agriculture and related development expertise.

### **DURATION OF THE BOARD**

4. The Advisory Board members shall be appointed to serve for a period of 3 years .

## FUNCTIONS

- 1) The Advisory Board shall, either at its own instance the request of the MEC, advise the MEC on any matter connected with the exercise of his powers and the performance of his functions and duties.
  - 2) The Board must submit reports on its activities to the MEC every three months of its duration.
  - 3) The Board will advise the department on Agricultural Economic trends (domestic and global)
  - 4) The Board will devise agricultural Industrial investment strategies for the Department.
  - 5) The Board will advise the MEC on Corporate Governance and compliance issues.
