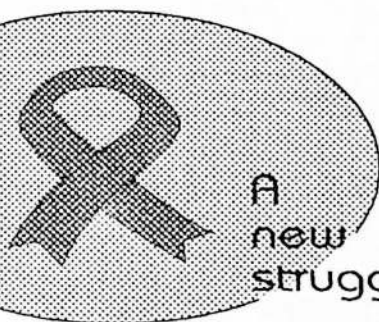

ON THE FARM BANKFONTEIN**

Notice is hereby lodged to invite objections from all interested parties that the above stated road which is 6.4km long be closed in terms of Part III section 5(1) (d) of the Eastern Cape Roads Act, 2003

The owners of Agtersneeuberg Private Game Reserve made an application for the closure of road mentioned above. The following reasons were put as the motivation behind the closure of these routes

- Farm Bankfontein has a dangerous game which poses a threat to the public entering the property
- The road is only used by owners of the Agtersneeuberg and Bankfontein who also access their farms through DR02250 and DR02394. General Public makes use of alternative route DR02394 to get to farms below these two.

The District Roads Engineer for Chris Hani regional office has been approached and is in support of the proposed closure stating that this closure will also increase safety to the public and the department will incur some maintenance cost savings. The Head of the Department has also pronounced her consent of the proposed closure.

The attached map outlines the location of the proposed road to be deproclaimed from point A to B.

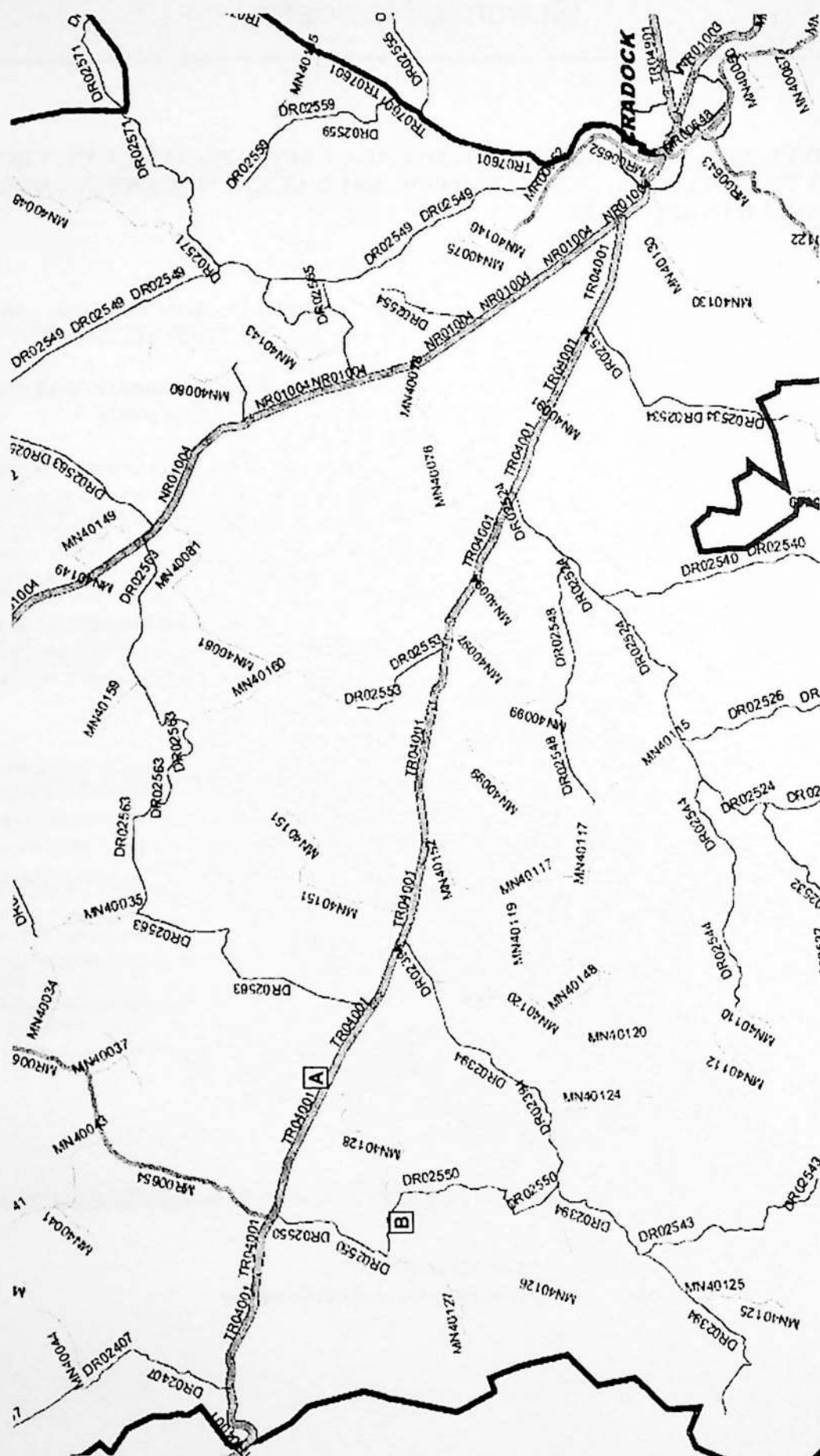
