Adjustment of division of functions and powers by way of allocation, between district and local municipalities,

- In terms of section 85 of the Act and with effect from 1 July 2008, the division of functions and powers between the district municipality and the local municipalities is adjusted by way of allocations in accordance with Part 1 of the Annexure hereto, and for the purposes of the said Part 1, "function" includes "power".
- 2 In terms of section 85(6), any adjustment of the division of functions and powers by way of an allocation in terms of subsection (1) or reallocation in terms of subsection (9) must be reflected in the notices referred to in section 12 which establish the municipalities concerned. Where applicable the legal, practical and other consequences of the allocation or reallocation must be regulated, including:-
 - (a) the transfer of staff;
 - (b) the transfer of assets, liabilities, rights and obligations, and administrative and other records; and
 - (c) the continued application of any bylaws, regulations and resolutions in the area of the municipalities concerned and the extent of such application.
 - It should be noted that if a recommendation is made, for example, the reversal of the section 84(1)(j) function (Fire fighting) from the local municipality back to the district, it does not mean that the local aspect of the function is then automatically adjusted to the district as well.
