# NOTICE TO ALL LIQUOR TRADERS

In terms of Section 9 (c) of the Eastern Cape Liquor Act, No 10 of 2003, a provision is made for the Board to determine conditions applicable to all categories of registration. This therefore serves to notify all liquor license-holders of the conditions applicable to all liquor traders. The following conditions are attached to all registration certificates with immediate effect:

# **GENERAL CONDITIONS APPLICABLE TO ALL LICENSE-HOLDERS**

- ✓ No persons under the age of 18 shall be sold liquor in the registered premises.
- ✓ Valid certificate of registration shall be visibly displayed at all times.
- No loud music shall be played at the outlet. Music played shall not be audible beyond the boundary perimeter of the premises.
- No speakers or audio equipment shall be placed outside the building walls of the premises.
- No person shall be allowed to consume liquor in or around the premises other than in the area demarcated for such purpose; the registrant bears the obligation to report such activities to the nearest police station.
- ✓ The registered person/owner shall apply with the Board for someone to be appointed as a manager to be responsible in the absence of the owner/registered person.

# **ON & OFF CONSUMPTION**

- The liquor outlet shall cease operating at 22H00 during the week and at 24H00 during weekends (Friday and Saturday);
- ✓ No trading in liquor shall take place after the aforementioned hours;

# **ON-CONSUMPTION**

✓ The outlet shall close at 23h00 from Monday to Sunday.

# OFF CONSUMPTION

- ✓ The outlet shall close at 20h00 from Monday to Saturday.
- ✓ On Sunday the outlet shall close at **13h00**.

This notice is issued cognisant of Section 42 (b) of the Act, which stipulates that trading hours are determined by the Municipality in whose area of jurisdiction the premises are situated. Closing times stipulated in the aforementioned conditions are applicable to areas, which have not promulgated liquor trading by- laws.

All liquor license-holders are compelled to adhere to these conditions as attached on their licenses. Failure to comply with these conditions will lead to prosecution, suspension and cancellation of the registration certificate.
