



ACT NO 3 OF 2013 (EC) EASTERN CAPE GENERAL LAW AMENDMENT ACT, 2013 (EASTERN CAPE)

## **ACT**

**To repeal obsolete and old order legislation of the Province of the Eastern Cape; and to provide for matters connected therewith.**

**BE IT ENACTED** by the Legislature of the Province of the Eastern Cape, as follows:-

### **REPEAL OF LAWS**

1. The laws mentioned in the second column of the Schedule are hereby repealed to the extent set out in the third column thereof.

### **SHORT TITLE AND DATE OF COMMENCEMENT**

2. This Act is called the Eastern Cape General Law Amendment Act, 2013 and shall come into operation on a date determined by the Premier by proclamation in the Provincial Gazette.
