



# GENERAL NOTICE

## No. 131

Notice is hereby given that on 15 April 2014 in the High Court of South Africa (East London Circuit Local Division) (under case No. EL213/2014) and Case No. ECD513/2014 at East London Rule Nisi was granted calling upon all interested parties to show cause, if any, why on the 27<sup>th</sup> of May 2014 the order in the following terms should not be made final:

- 1. That condition B (i) (a), (b), (c), (d) and (e) in respect of Erf 17789 East London, contained in Deed of Transfer No.T4222/2007 and reading as follows:
  - "B SUBJECT to the following conditions created in Deed of Transfer No.64/1994:
  - (i) As being in favour of the registered owner of any erf in the township, and subject to amendment or alteration by the Administrator, under the provisions of Section 18(3) of Ordinance No. 33 of 1934, reading:-
    - (a) That this erf be used for residential purposes only;
    - (b) That only one dwelling, together with such outbuildings as are ordinarily required to be used therewith be erected on this erf;

- (c) That not more than half the area of this erf be built upon;
- (d) That no building or structure or any portion thereof, except boundary walls and fences, shall be erected nearer than 4.57 metres to the street line which forms a boundary of this erf.

  No such buildings or structure shall be situated within 1,52 metres of the lateral boundary common to any adjoining erf.
- (e) That this erf be not subdivided except with the consent in writing of the Administrator."

be deleted;

- That Deed of Transfer T4222/2007 be endorsed accordingly by the Registrar of Deeds;
- 3. That the costs of the application be paid, jointly and severally by those parties, if any, who unsuccessfully oppose the application.

- 4. That any interested party may object to the order sought in the *rule nisi* by way of a letter to the Registrar of this Honourable Court, which letter shall reach the said Registrar by no later than 5 (Five) Court days prior to the return day, being Tuesday, 20 May 2014.
- 5. That a copy of the *rule nisi* shall lie for inspection without charge at the office of the Registrar of this Honourable Court and at the office of Bate Chubb and Dickson, Attorneys for the Applicants, at Suite 3, Norvia House, 34 Western Avenue, Vincent, East London, from date of this Order until the return day, being the 27<sup>th</sup> day of May 2014 at 09H30.
