

- 7. Incorrectly completed forms and notices submitted in the wrong format will be rejected to the customer to be corrected and resubmitted. ACT NO 4 OF 2015 (EC) EASTERN CAPE GENERAL LAW AMENDMENT ACT, 2015

#### ACT

To repeal obsolete and old order legislation of the Province of the Eastern Cape; and to provide for matters connected therewith.

**BE IT ENACTED** by the Legislature of the Province of the Eastern Cape, as follows:-

#### REPEAL OF LAWS

1. The laws mentioned in the second column of the Schedule are hereby repealed to the extent set out in the third column thereof.


#### SHORT TITLE AND DATE OF COMMENCEMENT

 This Act is called the Eastern Cape General Law Amendment Act, 2015 and shall come into operation on a date determined by the Premier by proclamation in the Provincial Gazette.
