**NOTICE OF LODGEMENT OF AN APPLICATION FOR AMENDMENT OF LICENCE CONDITION IN TERMS OF THE GAMBLING AND BETTING ACT, 1997 (ACT NO. 5 OF 1997) (EASTERN CAPE) (as amended)**

NOTICE IS HEREBY GIVEN that an application for amendment of licence condition in terms of section 35, of the Gambling and Betting Act, 1997 (Act No. 5 of 1997) (Eastern Cape) (as amended), particulars of which are set out in the Schedule hereunder, has been lodged with the Eastern Cape Gambling and Betting Board.

The application may be inspected by any person at the offices of the Eastern Cape Gambling and Betting Board, ECGBB Building, Quenera Park, Quenera Drive, Beacon Bay, East London and at the Municipality within which the Premises are located as shown in the schedule below.

Any objections, petitions or representations shall be lodged with the Chief Executive Officer of the Board within one (1) month of the date of this notice, commencing on **10 October 2016 until 09 November 2016**.

All objections and comments shall specify: the application to which the objection or comment relates; the grounds on which the objection is founded; in the case of comment; full particulars or facts in substantiation thereof: the name, address, telephone and fax number of the objector or person making the comment and a statement whether the objector or person making the comment wishes to make oral representations when the application is heard.

A person lodging representations may show cause why the Board may determine that his or her identity should not be divulged.

The under-mentioned figures used in brackets in Schedules have the following meanings:

- (1) = The name and address of the applicant;
- (2) = If the applicant is a company or other corporate body, the names of all persons who have a financial or other interest of 5% or more in the applicant;
- (3) = In the case of a company the initials and surnames of all directors of the company;
- (4) = The type of application applied for; and
- (5) = The address of the premises from which the applicant intends to operate from.

- (4) Amendment of Licence Condition as proposed /detailed below:

Current condition of licence the applicant seeks to amend: Clause No. 8

"Roll Out"

Proposed amendment to clause No. 8

Insertion of a new clause 8.13 to read as follows:

"Notwithstanding anything to the contrary contained herein, once the Licensee has rolled out 1000 LPMs, it shall, for the duration of the Licence Period, ensure that the total number of operating LPMs does not drop below 850"

Current condition of licence the applicant seeks to amend: Clause No. 13.1.2

"13.1 The Licensee shall -

13.1.1 be a Level Two Contributor by 31 December 2015; and

13.1.2 may not drop below the aforesaid level for the Licence Period save as provided for below";

Proposed amendment to clause No. 13.1.2

"may not drop below the aforesaid level for the Licence Period, save that in the event of the BEE Codes of Good Practice (09 February 2007) being amended the Licensee shall be considered to have complied with this requirement, provided it attained a Level 2 as at 31 December 2015, until such time that the ECGBB has amended its licence conditions in line with the amended BEE Codes of Good Practice"

Current condition of licence the applicant seeks to amend: Clause No.16.6

"The Licensee undertakes to provide training to Site Licensees and their employees to the satisfaction of the ECGBB"

Proposed amendment to clause No. 16.6

"The Licensee undertakes to provide training to Site Licensees and their employees first in accordance with all relevant legislation; particularly the Labour Relations Act and the Skills Development Act"

Current condition of licence the applicant seeks to amend: Clause No.18.1

"During the Licence Period the Licensee shall continue to employ a minimum of 36 (thirty six) permanent employees, including disabled persons, as set out in its Application"

Proposed amendment to clause No. 18.1

“During the Licence Period the Licensee shall continue to employ a minimum of 20 (twenty) permanent employees, including disabled persons, and transfer the remaining existing positions to APG - to render all services to the Licensee”

Current condition of licence the applicant seeks to amend: Clause No.19.1.1 to 19.1.2

“19.1 To facilitate compliance with control standards as contained in the Act, the Licensee shall establish a compliance committee, the composition of which shall be approved by ECGBB and which shall -

19.1.1 meet a minimum of once every quarter and such meeting shall take place within 2 (two) weeks after the end of each quarter;

19.1.2 submit draft minutes of its meetings to the ECGBB within 10 (ten) Business Days of each such meeting”

Proposed amendment to clause No. 19.1.1 to 19.1.2

“19.1.1 meet with Audit Committee bi-annually as is required in accordance with the Companies Act, 2008;

19.1.2 submit bi-annual reports / minutes to the ECGBB within ten (10) Business Days from such meetings being held”.
