

It is, therefore, made known for general information the removal and derecognition of Nompumelelo Ntombomzi Ndlazi as Inkosi (Senior traditional leader) of AmaZizi traditional community/ tribe resident within the area of jurisdiction of Ndlazi traditional council in the district of Fort Beaufort and the withdrawal of a certificate of recognition issued to her as an acting Inkosi of Ndlazi traditional council in the district of Fort Beaufort.
