NOTICE IS HEREBY GIVEN that application for a bookmaker application in terms of section 53 of the Gambling and Betting Act, 1997 (Act No. 5 of 1997) (Eastern Cape) (as amended), particulars of which are set out in the schedule hereunder, have been lodged with the Eastern Cape Gambling and Betting Board.

Any objections, petitions or representations shall be lodged with the Chief Executive Officer of the Board within one (1) month of the date of this notice, commencing on **06 March 2017 until 05 April 2017**.

All objections and comments shall specify: the application to which the objection or comment relates; the grounds on which the objection is founded; in the case of comment; full particulars or facts in substantiation thereof: the name, address, telephone and fax number of the objector or person making the comment and a statement whether the objector or person making the comment wishes to make oral representations when the application is heard.

A person lodging representations may show cause why the Board may determine that his or her identity should not be divulged.

- (1) = The name and address of the applicant;
