

**NOTICE OF LODGEMENT OF APPLICATION FOR AMENDMENT OF CONDITIONS OF LICENCE IN TERMS OF THE GAMBLING AND BETTING ACT, 1997 (ACT NO. 5 OF 1997) (EASTERN CAPE) (as amended)**

NOTICE IS HEREBY GIVEN that an application for amendment of Licence Conditions in terms of 35 of the Gambling and Betting Act, 1997 (Act No. 5 of 1997) (Eastern Cape) (as amended), particulars of which are set out in the Schedule hereunder, has been lodged with the Eastern Cape Gambling and Betting Board.

The application may be inspected by any person at the offices of the Eastern Cape Gambling and Betting Board, ECGBB Building, Quenera Park, Quenera Drive, Beacon Bay, East London.

Any representations, including objections, petitions or comments shall be lodged with the Chief Executive Officer of the Board within one (1) month of the date of this notice, commencing on **19 June 2017 until 18 July 2017**.

All representations shall specify: the application to which the representation relates; in the case of an objection, the grounds on which the objection is founded; in the case of comment; full particulars or facts in substantiation thereof: the name, address, telephone and fax number of the person making the representations and a statement whether the person making the representation wishes to make oral representations when the application is heard.

A person lodging representations may show cause why the Board may determine that his or her identity should not be divulged.

The under-mentioned figures used in brackets in Schedules have the following meanings:

- (1) = The name and address of the applicant;
- (2) = If the applicant is a company or other corporate body, the names of all persons who have a financial or other interest of 5% or more in the applicant;
