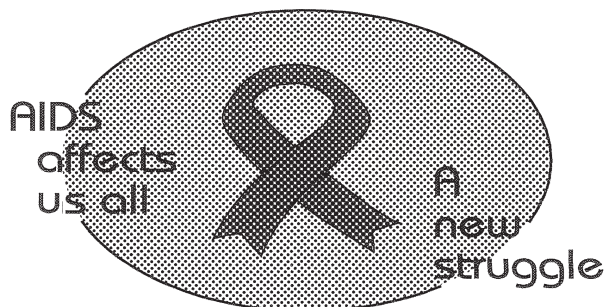

A person lodging representations may show cause why the Board may determine that his or her identity should not be divulged.
