



KOUGA MUNICIPALITY: ADOPTION OF THE SPATIAL DEVELOPMENT FRAMEWORK (2020)

Notice is hereby given in terms of section 20(1) of the Spatial Planning and Land Use Management Act, Act 16 of 2013 (SPLUMA), read with Section 8(8) of The Spatial Planning and Land Use Management By-laws: Kouga Local Municipality, that the Kouga Municipality at its Council meeting held on 26 February 2021 approved and adopted the reviewed Kouga Municipal Spatial Development Framework (SDF) 2020, by way of a resolution No: 21/02/PD11.

As required in terms of SPLUMA, Kouga Municipality published the draft SDF inviting the public to submit written comments in respect of the proposed SDF within 60 days. All comments received were considered by the project steering committee and the SDF was amended taking into consideration the comments received. The SDF details spatial policies, strategies, mechanism for implementation and includes technical components as contemplated in Section 21 of the Act. The approved SDF replaces the current SDF (2015), effective from date of publication of this notice. The approved SDF can be downloaded on the Kouga Municipal Website (www.kouga.gov.za).
