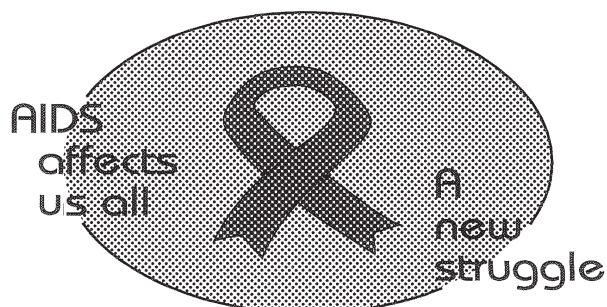

Notice is hereby given in terms of Section 49(1)(a)(i) of the Local Government: Municipal Property Rates Act, 2004 (Act No.6 of 2004), hereinafter referred to as the "Act" that copies of the General Valuation Roll for the financial years 1 July 2023-30 June 2027 is open for public inspection at the various municipal offices within the municipal boundaries and in addition on the municipal website at: www.kouga.gov.za from **6 February 2023 to 14 April 2023**. The certified general valuation roll can be inspected at the valuation office upon appointment.

An invitation is hereby made in terms of section 49(1)(a)(ii) of the Act that any owner of property or other person who so desires should lodge an objection with the municipal manager in respect of any matters reflected in, or omitted from, the supplementary valuation roll within the above-mentioned period.

Attention is specifically drawn to the fact that in terms of Section 50(2) of the Act an objection must be in relation to a specific individual property and not against the valuation roll as such. The official form for the lodging of an objection is obtainable at the various municipal offices within the municipal boundaries or website at: www.kouga.gov.za as of **6 February 2023**.
