



ACT

To effect adjustments to the appropriation of money from the Provincial Revenue Fund for the requirements of the Province of the Eastern Cape in respect of the 2022/23 financial year; and to provide for matters incidental thereto.

BE IT ENACTED by the Legislature of the Province of the Eastern Cape, as follows: -

Appropriation of amounts of money for the requirements of the Province of the Eastern Cape.

- (1) Adjustments to appropriation by the Provincial Legislature of money from the Provincial Revenue Fund for the requirements of the Province of the Eastern Cape in the 2022/23 financial year to votes and the main divisions within a vote and amendments to the purposes that are specified, are set out in the Schedules to this Act.
 - (2) The spending of the appropriation contemplated in subsection (1) is subject to the provisions of this Act, section 31 of the Public Finance Management, 1999 (Act No.1 of 1999) and the Division of Revenue Act, 2022 (Act No. 5 of 2022).
 - (3) An amount within a vote or main division within a vote that is listed as specifically and exclusively appropriated in Schedule B to this Act, may be used only for the purpose indicated, unless the amount or purpose for which it was allocated, is amended in terms of an Act of the Provincial Legislature.

Short title

2. This Act is called the Adjustments Appropriation Act, 2022 (Eastern Cape).

ACT

To provide for the appropriation of money from the Provincial Revenue Fund for the requirements of the Province of the Eastern Cape in the 2022/23 financial year and to provide for matters incidental thereto.

PREAMBLE

WHEREAS section 226(2) of the Constitution of the Republic of South Africa, 1996 provides that money may be withdrawn from the Provincial Revenue Fund only in terms of an appropriation by a Provincial Act;

AND WHEREAS section 26 of the Public Finance Management Act, 1999 (Act No. 1 of 1999) provides that the Provincial Legislature must appropriate money for each financial year for the requirements of the Province;

BE IT THEREFORE ENACTED by the Legislature of the Province of the Eastern Cape, as follows:—

Definitions

1. In this Act, unless the context indicates otherwise, any word or expression to which a meaning has been assigned in the Public Finance Management Act has the meaning assigned to it in that Act and —

"Act" includes the Schedules:

"conditional allocation" means a conditional allocation to the Province, from the national government's share of revenue raised nationally, which is provided for in section 214(1)(c) of the Constitution of the Republic of South Africa, 1996, and whose purpose is specified in the Division of Revenue Act for the 2022/23;

"current payments" means any payment made by a department classified as, or deemed to be, a current payment in terms of the instructions issued in the *Guidelines for Implementing the Economic Reporting Format* (September 2009), issued by National Treasury in terms of section 76 of the Public Finance Management Act;

"MEC for Finance" means the Member of an Executive Council responsible for finance in the Province;

"non-core items" means consultants on business and advisory services, venues and facilities, catering, travel and subsistence and communication;

"payments for capital assets"

means any payments made by a provincial department classified as, or deemed to be, a payment for capital assets in terms of the instructions issued in the *Guidelines for Implementing the Economic Reporting Format* (September 2009) and the Asset Management Framework (April 2004, Version 3.3), in terms of section 76 of the Public Finance Management Act –

 (a) for assets that can be used continuously or repeatedly in production for more than one year, and from which future economic benefits or service potential is expected to flow directly to the provincial department making the payment;

"**Province**" means the Province of the Eastern Cape established by section 103 of the Constitution of the Republic of South Africa, 1996,

"Public Finance Management Act" means the Public Finance Management Act, 1999 (Act No. 1 of 1999); and

"transfers and subsidies" means any payment made by a department classified as, or deemed to be, a transfer or subsidy payment in terms of the instructions issued in the *Guidelines for Implementing the Economic Reporting Format* (September 2009), in terms of section 76 of the Public Finance Management Act.

Appropriation of money for the requirements of the Province

- 2. (a) Appropriations by the Legislature of the Province of money from the Provincial Revenue Fund for the requirements of the Province in the 2022/23 financial year, to votes and main divisions within a vote, and for the specific listed purposes, are set out in the Schedules; and
 - (b) Subject to section 3 of this Act, spending of appropriations is subject to this Act, the Public Finance Management Act and the Division of Revenue Act for the 2022/23 financial year.

Appropriation listed as specifically and exclusively

3. Despite the provisions of any law, appropriations to a vote or main divisions within a vote that are listed as specifically and exclusively in the Schedules may only be utilised for the purpose indicated and may not be used for any other purpose, unless an Act of the Legislature of the Province amends or changes the purpose for which it was allocated.

Conditions for allocations

- 4. (1) The MEC for Finance may, in writing—
 - (a) impose conditions on an allocation in an appropriation listed in the Schedules to this Act, other than a conditional allocation, in order to promote and enforce transparency and effective management in respect of revenue, expenditure, assets and liabilities of departments and public entities as required by section 18(1)(c) of the Public Finance Management Act.
 - (b) instruct a department or public entity to stop utilising an allocation in respect of which conditions have been imposed in terms of paragraph (a), until such conditions are met.
 - (2) The instruction to stop utilising an allocation contemplated in subsection (1)(b) must be disclosed in the Provincial Treasury's report to the relevant Legislature Portfolio Committees in the quarter following the quarter in which the instruction was issued.
 - (3) Any change to the baseline for non-core items that was restored in line with 2015 Medium Term Expenditure Framework plus Consumer Price Index must be approved by the Provincial Treasury.

Use of unspent funds

- (1) Despite section 3 of this Act and section 43(4) of the Public Finance Management Act, the MEC for Finance may, for purposes of expediting service delivery, approve the use of unspent funds, in an amount appropriated for a vote in the Schedules to this Act, in respect of—
 - (a) compensation of employees provided that the amount is used within that vote for transfers and subsidies for the payment of severance or exit packages.
 - (b) payments for capital assets, provided that the amount is used within that vote for the same category of expenditure.
 - (2) The approval of the utilisation of unspent funds in terms of subsection (1) must be disclosed in the Provincial Treasury's report to the relevant Legislature Portfolio Committees in the quarter following the quarter in which the utilisation was approved.

Short title and commencement

This Act is called the Eastern Cape Appropriation Act, 2022.

ACT

To provide for the adjustment of money to the Provincial Revenue Fund for the requirements of the Province of the Eastern Cape; to appropriate additional funding for the requirements of the Provincial Legislature and Department of Transport; to effect adjustments to the appropriation of money from the Provincial Revenue Fund in respect of the 2021/22 financial year; and to provide for matters incidental thereto.

BE IT THEREFORE ENACTED by the Legislature of the Province of the Eastern Cape, as follows:—

Adjustment of amounts of money to the Provincial Revenue Fund for the requirements of the Province of the Eastern Cape.

- 1. (1) Subject to the provisions of the Public Finance Management Act, 1999 (Act No.1 of 1999) there is hereby adjusted an amount of R167 170 000 (one hundred and sixty seven million and one hundred and seventy thousand rand) declared as savings by provincial departments, and such declared savings is surrendered back to the Provincial Revenue Fund:
 - (2) The adjustments to appropriation in votes and the main divisions within a vote and amendments to the purposes that are specified are set out in Schedules to this Act.

Appropriation of an additional funding for the requirements of the Provincial Legislature and Department of Transport.

- 2. (1) Subject to the provisions of the Public Finance Management Act, 1999 (Act No. 1 of 1999), there is hereby appropriated an adjusted amount of—
 - (a) R4 608 000 (four million six hundred and eight thousand rand) allocated for the requirements Provincial Legislature;
 - (b) R96 047 000 (ninety-six million and forty-seven thousand rand) allocated for the requirements of the Department of Transport;
 - in respect to the financial year ending 31 March 2022.
 - (2) The spending of the appropriation contemplated in subsection (1) is subject to the provisions of the Public Finance Management, 1999 (Act No.1 of 1999) and the Division of Revenue Act, 2021 (Act No. 9 of 2021);

- 3. (1) Subject to the provisions of the Public Finance Management Act, 1999 (Act No. 1 of 1999), an amount of R205 122 000 (two hundred and five million and one hundred and twenty two thousand rand) is hereby adjusted from the Provincial Revenue Fund.
 - (2) The adjustment budget changes the main appropriation per vote as set out in Schedules.

PREAMBLE

Whereas the Mnquma Local Municipality has adopted a Credit Control and Debt Management Policy on October 2022;

And whereas Section 98 of the Local Government: Municipal Systems Act, 2000 (Act 32 of 2000), requires a municipal council to adopt By-laws to give effect to the municipality's credit control and debt management policy;

Be it therefore enacted by the Council of the Mnquma Local Municipality, as follows:

1. Definitions

In this By-law any word or expression to which a meaning has been assigned in the Act, shall bear the same meaning in these By-laws, and unless the context indicates otherwise: -

"Act" means the Local Government: Municipal Systems Act, 2000 (Act 32 of 2000), as amended from time to time:

"Council" means the Council of the Mnquma Local Municipality; and

"rate" or "rates" means a rate on property and or services as approved by Council.

2. Objective of the By-law

The objective of this By-law is to: -

- i. ensure that all monies due and payable to the Council are collected;
- ii. provide for customer management, credit control procedures and mechanisms and debt collection procedures and mechanisms;
- iii. provide for indigents in a way that is consistent with rates and tariff policies and any national policy on indigents;
- iv. provide for extension of time for payment of accounts;
- v. provide for charging of interest on arrears, where appropriate;
- vi. provide for termination of services or the restriction of the provision of services when payments are in the arrears;
- vii. provide for matters relating to unauthorised consumption of services, theft and damages

3. Application of By-law

This By-law shall only apply to money due and payable to the Council for: -

- a. assessment rates and taxes levied on the property;
- b. fees, surcharges on fees, charges and tariffs in respect of municipal services, such as: -
 - refuse removal;
 - ii. all other related costs for services rendered in terms of the property;
 - iii. interest which has accrued or will accrue in respect of money due and payable to the Council;
 - iv. collection charges in those cases where the Council is responsible for: -
 - (aa) the rendering of municipal accounts in respect of any one or more of the municipal services;
 - (bb) the recovery of amounts due and payable in respect thereof.

4. Short title and commencement

This By-law is the Credit Control and Debt Management By-law, and takes effect on date of publication.
