PROVINCIAL NOTICES • PROVINSIALE KENNISGEWINGS**PROVINCIAL NOTICE 660 OF 2023****OFFICE OF THE PREMIER****DETERMINATION OF SALARIES AND ALLOWANCES OF MEMBERS OF THE EXECUTIVE COUNCIL AND MEMBERS OF THE PROVINCIAL LEGISLATURE: REMUNERATION OF PUBLIC OFFICE BEARERS ACT, 1998 (ACT NO. 20 OF 1998)**

I, **Lubabalo Oscar Mabuyane**, Premier of the Province of the Eastern Cape, acting in terms of section 6(3) of the Remuneration of Public Office Bearers Act, 1998 (Act No. 20 of 1998) (hereinafter referred to as the “Act”), having regard to Presidential Proclamation No. 129 of 2023 published in Gazette No. 48929 of 10 July 2023, hereby determine that-

1. The total remuneration packages of the positions of office bearers in Column 3 of Schedule 1 shall be as set out in column 4 of Schedule 1 with effect from 1 April 2022, subject to section 6 of the Act, and the conditions set out herein.
2. The total remuneration packages include the following elements:
 - 2.1 A Basic salary component of 60% of the total package, which constitutes the pensionable salary;
 - 2.2 An amount of R120 000 per annum, which is an amount to which section 8(1) (d) of the Income Tax Act, 1962, applies. This amount is included in the basic salary component;

- 2.3 An employer's pension benefit contribution equal to 22, 5% of pensionable salary; and
- 2.4 A flexible portion for the remaining amount of the total remuneration.
3. Provincial Notice No. 324 published in Provincial Gazette No. 4765 of 1 July 2022, is hereby repealed.
