DRAFT REQUEST FOR PROPOSALS IN RESPECT OF THE ZONE 1 CASINO LICENCE

Notice is hereby given that the Draft Request for Proposal in respect of the Zone 1 Casino licence ("the Draft Casino RFP") in the Eastern Cape will be available from **Friday, 01 September 2023** from the Eastern Cape Gambling Board offices or through email sent to compliance@ecgb.org.za and ceo@ecgb.org.za. The cost of the draft Casino RFP, the purchase of which is compulsory for Applicants, is **R1 300.00**.

*Zone 1:

This zone covers the magisterial districts of Aberdeen, Adelaide, Alexandria, Bathurst, Bedford, Despatch, Fort Beaufort, Makhandla, Hankey, Humansdorp, Jansenville, Jeffrey's Bay, Joubertina, Kirkwood, Pearston, Gqeberha, Somerset East, Steytlerville, Kariega, and Willowmore.

The purpose of the Draft Casino RFP is to invite written comments and suggestions from all interested parties and potential bidders, to highlight the requirements of the RFP, to draw attention to the Essential Minimum Requirements ("EMR's"), to explain the consequences of non-compliance and to explain the evaluation process. The draft Casino RFP may be amended by the Board after consideration of the aforesaid written submissions and may culminate in the issue of a final Casino RFP.

Please note that the final Casino RFP will constitute the basis of any evaluation for any proposal for the Casino licence and not the Draft Casino RFP. The Draft Casino RFP may substantially change in format and content when it reaches the final Casino RFP stage and no liability for any change, damage or loss that may be incurred by any person as a result of this shall accrue/lie to the Board. Purchase of the Final Casino RFP will be compulsory in respect of each application to be submitted.
