NOTICE OF A BASIC ASSESSMENT (BA) FOR THE PROPOSED CONSTRUCTION OF A NEW TAXI RANK FACILITY IN WILLOWVALE, MBHASHE LOCAL MUNICIPALITY

Notice is hereby given in terms of the Environmental Impact Assessment (EIA) Regulations, 2014 as published in Government Notice No. 982 as amended, in terms of section 24(5) of the National Environmental Management Act, 1998 (Act No 107 of 1998) (NEMA), that Mbhashe Local Municipality (the Applicant) proposes to develop a taxi rank (centroid: 32° 15' 53.07"S 28° 29' 37.62"E). The proposed development is located along R408 in Ward 25 of the Willowvale (Gatyana) urban node developing town. The developed has a footprint of ~ 1.8 ha and a perimeter of ~550 m. The proposed development consists of the following:

- Mass Earthworks Construction of Layer works for Taxi rank with;
 - (a) Cut and Fill volumes of up to 20 250 Cumecs (150 x 90 x 1,5), and
 - (b) Borrow to Fill volumes of up to 15 150 Cumecs (20250 x 60%) for vehicles platform(s).

2. Potable Water Supply

Construction of water reticulation pipelines, fittings and backup supply.

3. Wastewater Drainage

Constructions of Males and Females ablution buildings, Sceptic Tank, and Greywater reticulation.

4. Stormwater Management

Construction of open channels, underground concrete pipe culverts and outlet structures

5. Roads and parking bays

Construction of access roads and surfaced parking

6. Electricity

Construction of power supply point, and electrification of the Taxi Rank.

7. Miscellaneous and Finishing

The project requires an Environmental Authorization via a Basic Assessment (BA) prior to construction commencement. A WULA has been applied for in terms of NWA (No. 36 of 1998) for water uses s21(c) and (i).


