(P35/30/1/2)

Under the powers vested in me -

- A. by section 3 of the Roads Ordinance, 1968 (Ordinance 4 of 1968), as amended, I hereby declare that the public roads, described below, will be deviated from the date of publication of this proclamation; and
- B. by die Advertising on Roads and Ribbon Development Act, 1940 (Act 21 of 1940), as amended, I hereby declare that the public roads, described below, shall be building restriction roads from the date of publication of this proclamation:
1. Deviation of a Section of the Wolvenhoek - Môrester Secondary Road S45, B-A to run B-C, situated in the Magisterial District of Koppies (Length ± 0,71 km): The section of the road over Marseilles 87 and Môrester 45, between points B and A, to run as follows: From point B on Marseilles 87, where it leaves the existing road; thence over Marseilles 87 and Môrester 45, to point C on Môrester 45, where it joins primary road P30/1.
2. Deviation of a Section of the Heilbron - Môrester Secondary Road S148, D-A to run D-G-C, situated in the Magisterial District of Koppies (Length ± 1,02 km): The section of the road over Môrester 45, between points D and A, to run as follows: From point D on Môrester 45, where it leaves the existing road; thence over Môrester 45, to point C on Môrester 45, where it joins primary road P30/1.
3. Deviation of a Section of the Greenlands North-Eastern Secondary Link Road S998, F-E to run F-G, situated in the Magisterial District of Koppies (Length ± 0,35 km): The section of the road over Môrester 45, between points F and E, to run as follows: From point F on Môrester 45, where it leaves the existing road; thence over Môrester 45, to point G on Môrester 45, where it joins secondary road S148.

The roads concerned are shown approximately on diagram S45/KK/2 in the office of the Head: Public Works, Roads and Transport, Bloemfontein.
