FREE STATE GAMBLING AND RACING BOARD SPECIAL LICENCES

The Free State Gambling and racing board hereby invites applications for interested parties for special Licences in terms of section 38 of the Free State Gambling and Racing Act, Act no. 6 of 1996, for the operation of slot machines in the Province. Application forms are obtainable from the Secretary of the Board at the Board's physical address given below, between 9:00 to 16:00 Monday to Friday.

The cost per application form is R570.00 (Five Hundred and Seventy Rand) inclusive of VAT. The amount must be deposited into the bank account of the board. The bank deposit slip must be handed to the secretary of the board before a form will be issued. (Acc No. 1102508586, NEDBANK, Maitland Street, Bloemfontein, 9301.)

Applicants' attention is drawn to the following specific conditions which are also contained in the application form:

1. The award of Special Licences is a temporary measure pending the preparation for and issue of casino licences in the Free State province. Consequently Special Licences will be of a limited duration.
2. The Board will, in the exercise of its discretion, consider applications and award a limited number of Special Licences only.
3. The award of a Special Licence will under no circumstances give the licensee a vested right or claim to preferential treatment in future applications for casino or other gambling licences.
4. The board, its members, staff and agents shall not be liable for any loss or prejudice suffered by applicants in this process of applying for a Special Licence.
5. Applicants are requested to acquaint themselves fully with all the legal provisions and conditions set out in the application form before completing and submitting their applications.
