REGULASIES OOR GELDE VIR GESONDHEIDSDIENSTE IN DIE VRYSTAAT

Kragtens artikel 16 van die Wet op die Vrystaatse Hospitale, 1996 (Wet No 13 van 1996), vaardig ek, Senorita Ntlabati, Lid van die Uitvoerende Raad van die Provinsie verantwoordelik vir Gesondheid, hierby die regulasies in die Bylae uiteengesit, uit.

Bylae

Woordomskrywing

1. In hierdie Regulasies, tensy uit die samehang anders blyk, beteken –

“aankoopkoste” die jongste bekende aankoopprys van ‘n artikel wat deur ‘n hospitaal verkry is en waarby belasting op toegevoegde waarde soos bepaal deur die Wet op Belasting op Toegevoegde Waarde, 1991 (Wet No 89 van 1991), ingesluit is;

“afhanklike” ‘n persoon wat geheel en al vir sy of haar onderhoud van iemand anders afhanklik is;

“amptelike geneesheer” ‘n geneesheer wat in die voltydse of deeltydse diens van die Departement van Gesondheid is, uitgesluit ‘n geneesheer van die beperkte privaat praktyk wanneer hy of sy in daardie hoedanigheid optree;

“ander hulpmiddel” enige hulpmiddel anders as ‘n ortopediese hulpmiddel en krukke, wat deur ‘n gestremde persoon benodig word om fisiese handeling te vergemaklik;

“beperkte privaat praktyk” die praktykvoering waarvoor goedkeuring ingevolge Uitvoerende Komitee-besluit No 548 van 19 Augustus 1992, verleen is;

“binnepasiënt” ‘n pasiënt wat vir behandeling tot ‘n hospitaal toegelaat is en ‘n bed beset;

“binnepasiënt behandeling” die mediese behandeling wat ‘n binnepasiënt in ‘n hospitaal ontvang;

“buitelandse maatskappy” ‘n buitelandse maatskappy soos omskryf in artikel 1 van die Inkomstebelastingwet, 1962 (Wet No 58 van 1962);

“buitelandse pasiënt” ‘n pasiënt wat gewoonlik buite die grense van die Republiek woonagtig is, insluitende ‘n buitelandse toeris of ‘n werknemer van ‘n buitelandse maatskappy wat die Republiek besoek, maar uitgesluit die volgende :

- (a) buitelanders wat wettig langer as 6 maande in die Republiek woonagtig is;
- (b) persone wat die Republiek onwettig binnegekom het vanaf naburige state; en
- (c) swanger vroue en kinders onder 6 jaar wat gewoonlik buite die grense van die Republiek woonagtig is, maar wat ‘n gesondheidsprobleem ontwikkel terwyl hulle in die Republiek aanwesig is;

“buitepasiënt” ‘n pasiënt wat in die buitepasiëntafdeling van ‘n hospitaal behandel word;

“buitepasiëntbehandeling” die mediese behandeling wat ‘n buitepasiënt ontvang;

“die Wet” die Wet op die Vrystaatse Hospitale, 1996 (Wet No 13 van 1996);

PROVINCIAL NOTICE

[No. 62, 1999]

REGULATIONS ON FEES FOR HEALTH SERVICES IN THE FREE STATE

Under section 16 of the Free State Hospitals Act, 1996 (Act No 13 of 1996), I, Seniorita Ntlabati, Member of the Executive Council of the Province responsible for Health, hereby make the regulations as set out in the Schedule.

Schedule

Definitions

1. In these Regulations, unless the context otherwise indicates –

“annual income” means a person’s annual gross income as determined in terms of the Income Tax Act, 1962 (Act No 58 of 1962);

“Benefit Scale Tariffs” means the latest Recommended Scales of Benefits of the Representative Association of Medical Schemes;

“boarder” means a person who, with the consent of the chief executive officer, is admitted to a hospital because his or her presence is, in the opinion of a medical practitioner, essential for the recuperation of a patient in such hospital;

“casualty” means any injury or acute medical condition that will probably bring about death, retardation, a serious or permanent scar or illness if not treated immediately;

“casualty patient” means a patient who receives emergency treatment –

- (a) in a casualty division on an emergency basis; or
- (b) in an outpatient division outside normal working hours;

“casualty treatment” means the emergency treatment a casualty patient receives;

“chief executive officer” means the person referred to in section 2(3) of the Act, or someone who has been authorised by him or her to act on his or her behalf;

“dependant” means a person who is entirely dependent on someone else for his or her maintenance;

“district hospital” means –

- (a) the hospitals at Bothaville, Botshabelo, Clocolan, Ficksburg, Frankfort, Harrismith, Heilbron, Hoopstad, Jagersfontein, Ladybrand, Odendaalsrus, Parys, Reitz, Sasolburg, Senekal, Smithfield, Virginia, Vrede, Winburg and Zastron;
- (b) the Elizabeth Ross hospital at Namahali;
- (c) the Moroka hospital at Thaba Nchu; and
- (d) the National hospital at Bloemfontein;

“distrikshospitaal” –

- (a) die hospitale te Bothaville, Botshabelo, Clocolan, Ficksburg, Frankfort, Harrismith, Heilbron, Hoopstad, Jagersfontein, Ladybrand, Odendaalsrus, Parys, Reitz, Sasolburg, Senekal, Smithfield, Virginia, Vrede, Winburg en Zastron;
- (b) die Elizabeth Ross hospitaal te Namahali;
- (c) die Moroka hospitaal te Thaba Nchu; en
- (d) die Nasionale hospitaal te Bloemfontein;

“eenvoudige behandeling” die roetine behandeling wat ‘n pasiënt oor ‘n tydperk van 30 dae ontvang (byvoorbeeld opvolg van bloeddruk lesings, vervanging van verbande, ensovoorts);

“gesinseenheid” –

- (a) ‘n egpaar (ongegag of hulle binne of buite gemeenskap van goedere getroud is) met of sonder ‘n afhanklike; of
- (b) ‘n enkelopende ouer of persoon met ‘n afhanklike;

“gesondheidswerker” ‘n individu wat gesondheidsdienste lewer en wat by ‘n toepaslike raad of liggaam geregistreer is;

“hoërsorgkompleks” ‘n spesiaal toegeruste kompleks in ‘n hospitaal waar spesiaal opgeleide verpleegkundiges op ‘n voltydse grondslag aan diens is, en op ‘n bystandgrondslag deur mediese personeel ondersteun word;

“hoof uitvoerende beampte” die persoon bedoel in artikel 2(3) van die Wet, of iemand wat deur hom of haar gemagtig is om namens hom of haar op te tree;

“hospitaal” ‘n tersiêre, streek- of distrikshospitaal wat ‘n provinsiale hospitaal is bedoel in artikel 1 van die Wet;

“hospitaalpasiënt” ‘n pasiënt bedoel in regulasie 2(3);

“intensiewesorgkompleks” ‘n spesiaal toegeruste kompleks in ‘n hospitaal wat ingestel is vir die intensiewe versorging van ernstige siek pasiënte en waar spesiaal opgeleide mediese en verpleegkundige personeel op ‘n voltydse grondslag aan diens is;

“inwonende baba” ‘n pasgebore suigeling wat nie mediese behandeling of babasorg benodig nie, maar wie se moeder nog ‘n kraampasiënt is;

“inwonende kind” ‘n suigeling wat geen mediese of verpleegsorg ontvang nie, en deur sy of haar moeder, wat ‘n pasiënt is, versorg en gevoed word;

“jaarlikse inkomste” ‘n persoon se jaarlikse bruto inkomste soos bepaal ingevolge die Inkomstebelastingwet, 1962;

“loseerder” ‘n persoon wat, met die goedkeuring van die hoof uitvoerende beampte, in ‘n hospitaal opgeneem word omdat sy of haar teenwoordigheid, na die mening van ‘n geneesheer, vir die herstel van ‘n pasiënt in sodanige hospitaal noodsaaklik is;

“mondgesondheidsdienste” die voorsiening van behandeling aan pasiënte wat aan mondsiektes ly deur deeltydse of voltydse mondgesondheidspersoneel;

“netto bates” die totale waarde van ‘n persoon se onroerende, roerende en finansiële bates, uitgesluit huishoudelike artikels en sy of haar totale laste;

"donor" means a person admitted to a hospital specifically for the donation of an organ for transplant purposes, or a person who dies in a hospital and who obtained donor-status by the permission given by his or her relatives for the donation of one or more of his or her organs : Provided that the expression "organ" shall also include blood, mother's milk or tissue;

"external company" means an external company as defined in section 1 of the Income Tax Act, 1962;

"family unit" means –

- (a) a married couple (irrespective of whether they are married in or out of community of property) with or without a dependant; or
- (b) a single parent or a person with a dependant;

"foreign patient" means a patient who is ordinarily resident outside the borders of the Republic, including a foreign tourist or an employee of an external company visiting the Republic, but excluding the following :

- (a) foreigners who have been legally residing in the Republic for longer than 6 months;
- (b) persons who have illegally entered the Republic from neighbouring states; and
- (c) pregnant women and children under 6 years, who are ordinarily resident outside the borders of the Republic, but develop a health problem while in the Republic;

"government department" means a department referred to in section 1(1)(viii) of the Public Service Act, 1994;

"health worker" means an individual providing health services who is registered with an appropriate board or council;

"high-risk complex" means a specially equipped complex in a hospital where specially trained nurses are on duty on a full-time basis, and are supported by medical personnel on standby;

"hospital" means a tertiary, regional or a district hospital which is a provincial hospital referred to in section 1 of the Act;

"hospital patient" means a patient referred to in regulation 2(3);

"inpatient" means a patient who has been admitted to a hospital for treatment and occupies a bed;

"inpatient treatment" means the medical treatment received by an inpatient in a hospital;

"intensive care complex" means a specially equipped complex in a hospital established for the intensive care of seriously ill patients, and where specially trained medical and nursing staff are on duty on a full-time basis;

"limited private practice" means the practice for which approval was granted in terms of Executive Council resolution No 548 of 19 August 1992;

"local authority" means a municipality as defined in section 10B of the Local Government Transition Act, 1993 (Act No 209 of 1993);

"net assets" means the total value of a person's fixed, movable and financial assets, excluding domestic articles and his or her total liabilities;

"normal working hours" means the hours from 07:00 to 17:00 on a Monday to Friday, excluding a public holiday;

“normale werkure” die ure vanaf 07:00 tot 17:00 op ‘n Maandag tot Vrydag, uitgesluit ‘n openbare vakansiedag;

“ongeval” enige besering of akute mediese toestand wat waarskynlik dood, gestremdheid of ‘n ernstige permanente letsel of siekte sal meebring indien dit nie dadelik mediese aandag kry nie;

“ongevalle pasiënt” ‘n pasiënt wat noodbehandeling ontvang –

- (a) in ‘n ongevalle-afdeling op ‘n ongevallebasis; of
- (b) buite normale werkure in ‘n buitepasiëntafdeling;

“openbare vakansiedag” ‘n openbare vakansiedag bedoel in artikel 2 van die Wet op Openbare Vakansiedae, 1994 (Wet No 36 van 1994);

“pasiënt” ‘n hospitaalpasiënt of privaat pasiënt, na gelang van die geval;

“plaaslike owerheid” ‘n munisipaliteit soos omskryf in artikel 10B van die Oorgangswet op Plaaslike Regering, 1993 (Wet No 209 van 1993);

“privaat geneesheer” ‘n geneesheer wat nie in die voltydse of deeltydse diens van die Departement Gesondheid is nie : Met dien verstande dat ‘n geneesheer van die beperkte privaat praktyk, wanneer hy of sy in daardie hoedanigheid optree, as ‘n privaat geneesheer beskou word;

“privaat pasiënt” ‘n pasiënt bedoel in regulasie 2(4);

“prosedurekamer” ‘n lokaal in ‘n tersiêre- of streekhospitaal waar chirurgiese ingrepe en prosedurebehandelings plaasvind in omstandighede wat nie aan die streng aseptiese vereistes wat op ‘n teater van toepassing is, voldoen nie;

“prostese” ‘n gefabriceerde kunsmatige substituuat vir ‘n deel van die liggaam wat siek is of ontbreek, heelkundig ingeplant en sluit alle samestellende dele soos penne, stawe, skroewe, plate of gelyksoortige items wat ‘n integrale en noodsaaklike deel van die inplanting is, in en word as ‘n enkele eenheid gehêf;

“Republiek” die Republiek van Suid-Afrika bedoel in artikel 1 van die Grondwet van die Republiek van Suid-Afrika, 1996 (Wet No 108 van 1996);

“skenker” ‘n persoon wat spesifiek vir die skenking van ‘n orgaan vir oorplantingsdoeleindes in ‘n hospitaal opgeneem word of ‘n persoon wat in ‘n hospitaal te sterwe kom en skenkerstatus verkry deurdat sy of haar familie toestemming tot die skenking van een of meer van sy of haar organe verleen het : Met dien verstande dat die uitdrukking “orgaan” ook bloed, moedersmelk of weefsel omvat;

“staatsdepartement” ‘n departement bedoel in artikel 1(1)(ii) van die Staatsdienswet, 1994;

“streekhospitaal” –

- (a) die Boitumelo-hospitaal te Kroonstad;
- (b) die Goudveldse-streekhospitaal te Welkom;
- (c) die Pelonomi-hospitaal te Bloemfontein;
- (d) die Provinsiale hospitaaleenheid te Bethlehem;
- (e) die Manapo-hospitaal te Phuthaditjaba;

“teater” ‘n lokaal in ‘n hospitaal waar chirurgiese ingrepe en prosedurebehandelings in ‘n steriele omgewing plaasvind;

"official medical practitioner" means a medical practitioner who is in the full-time or part-time employ of the Department of Health, excluding a medical practitioner of the limited private practice acting in that capacity;

"oral health services" means the provision of treatment to patients suffering from oral diseases by part-time or full-time oral health personnel;

"other appliance" means any appliance other than an orthopaedic appliance and crutches, which is required by a handicapped person to facilitate physical movement;

"outpatient" means a patient who is treated in the outpatient division of a hospital;

"outpatient treatment" means the medical treatment received by an outpatient;

"patient" means a hospital patient or private patient, as the case may be;

"private medical practitioner" means a medical practitioner who is not in the full-time or part-time employ of the Department of Health : Provided that a medical practitioner of the limited private practice, when he or she acts in that capacity, shall be regarded as a private medical practitioner;

"private patient" means a patient referred to in regulation 2(4);

"procedure room" means a room in a tertiary or regional hospital, where surgery and procedural treatments take place in conditions that do not meet the strict aseptic requirements applicable to a theatre;

"prosthesis" means a fabricated artificial substitute for a part of the body that is diseased or missing, surgically implanted, and shall include all constituent parts like pins, rods, screws, plates or similar items which are an integral and essential part of the implantation, and shall be charged as a single unit;

"public holiday" means a public holiday referred to in section 2 of the Public Holidays Act, 1994 (Act No 36 of 1994);

"purchase cost" means the latest known purchase price of an article obtained by a hospital, and which includes value-added tax, as determined by the Value-Added Tax Act, 1991 (Act No 89 of 1991);

"referral letter" means an official document issued by a health worker giving a patient access to the appropriate level of care and which can be on an I1301 form or appropriate letter indicating the health worker's registered or practice number;

"regional hospital" means –

- (a) the Boitumelo hospital at Kroonstad;
- (b) the Goldfields regional hospital at Welkom;
- (c) the Pelonomi hospital at Bloemfontein;
- (d) the Provincial hospital unit at Bethlehem;
- (e) the Manapo hospital at Phuthaditjaba;

"relative" means a family member of a patient who, with the authorisation of the chief executive officer, is admitted to a hospital for an examination to assist in diagnosing such a patient;

"Republic" means the Republic of South Africa referred to in section 1 of the Constitution of the Republic of South Africa, 1996 (Act No 108 of 1996);

"resident baby" means a newborn baby who does not need medical treatment as nursery care but whose mother is still a maternity patient;

“terapeutiese behandeling” die reeks behandeling, onderrig- en voorligtingssessies wat aan ‘n pasiënt gelewer word om sy of haar siektetoestand of ander probleme te verbeter;

“tersiêre dienste” beteken die dienste gelewer te Universitas hospitaal te Bloemfontein, insluitende vlak III en vlak IV dienste gelewer by afdelings van die volgende hospitale :

- (a) die Nasionale hospitaal te Bloemfontein;
- (b) die Pelonomi hospitaal te Bloemfontein;
- (c) die Provinsiale hospitaaleenheid te Bethlehem; en
- (d) die Goudveldse streekhospitaal te Welkom;

“tersiêre hospitaal” beteken die Universitas hospitaal ingesluit die Nasionale hospitaal waar vlak III en vlak IV dienste gelewer word;

“verwant” ‘n familielid van ‘n pasiënt wat met die goedkeuring van die hoof uitvoerende beampte in ‘n hospitaal opgeneem word vir ‘n ondersoek ten einde behulpsaam te wees by die diagnose van sodanige pasiënt;

“verwysingsbrief” ‘n amptelike dokument uitgereik deur ‘n gesondheidswerker wat aan ‘n pasiënt toegang bied tot die toepaslike gesondheidsorgvlak en wat gedoen kan word op ‘n H301-vorm of op ‘n toepaslike brief waarop die gesondheidswerker se geregistreerde- of praktyknommer aangedui word;

“Voordeleskaal Tariewe” die jongste Aanbevole Voordeleskale van die Verteenwoordigende Vereniging van Mediese Skemas,

en het enige ander woord of uitdrukking waaraan ‘n betekenis in die Wet geheg is, die betekenis aldus daaraan geheg.

Klassifikasie van pasiënte

2. (1) ‘n Pasiënt word by opname in ‘n hospitaal deur die hoof uitvoerende beampte as ‘n buitelandse pasiënt, hospitaalpasiënt of privaat pasiënt geklassifiseer.
- (2) ‘n Pasiënt moet sodanige inligting verstrek en bewyse voorlê as wat die hoof uitvoerende beampte van hom of haar mag verlang ten einde ‘n klassifikasie kragtens subregulasie (1) te kan doen.
- (3) (a) ‘n Hospitaalpasiënt is ‘n pasiënt wat –
 - (i) kragtens paragraaf (b) as ‘n H1-, H2-, H3- of H4-hospitaalpasiënt geklassifiseer word; en
 - (ii) behoudens die voorbehoudsbepaling by subregulasie (4), deur ‘n amptelike geneesheer in ‘n hospitaal behandel word.
- (b) ‘n Pasiënt word geklassifiseer –
 - (i) as ‘n H1-hospitaalpasiënt indien –
 - (aa) hy of sy as ‘n enkelopende persoon sonder ‘n afhanklike –
 - (aaa) ‘n jaarlikse inkomste van nul tot R15 000 het; of
 - (bbb) die eienaar is van netto bates met ‘n waarde van minder as R59 000; of

- (bb) hy of sy 'n lid van 'n gesinseenheid is wat –
 - (aaa) 'n jaarlikse inkomste van nul tot R26 000 het; of
 - (bbb) die eienaar is van netto bates met 'n waarde van minder as R26 000; of
- (cc) hy of sy bewys lewer dat hy of sy 'n maatskaplike pensioen ontvang en nie deur 'n privaat geneesheer behandel word nie;
- (ii) as 'n H2-hospitaal pasiënt indien –
 - (aa) hy of sy as 'n enkellopende persoon sonder 'n afhanklike –
 - (aaa) 'n jaarlikse inkomste van R15 001 tot R22 000 het; of
 - (bbb) die eienaar is van netto bates met 'n waarde van R50 000 tot R76 000; of
 - (bb) hy of sy 'n lid van 'n gesinseenheid is wat –
 - (aaa) 'n jaarlikse inkomste van R26 001 tot R38 000 het; of
 - (bbb) die eienaar is van netto bates met 'n waarde van R98 000 tot R141 000;
- (iii) as 'n H3-hospitaal pasiënt indien –
 - (aa) hy of sy as 'n enkellopende persoon sonder 'n afhanklike –
 - (aaa) 'n jaarlikse inkomste van R22 001 tot R30 000 het; of
 - (bbb) die eienaar is van netto bates met 'n waarde van R76 000 tot R114 000; of
 - (bb) hy of sy 'n lid van 'n gesinseenheid is wat –
 - (aaa) 'n jaarlikse inkomste van R38 001 tot R49 000 het; of
 - (bbb) die eienaar is van netto bates met 'n waarde van R141 000 tot R190 000; of
 - (cc) hy of sy nie lid is van 'n mediese fonds nie, maar geregtig is op die voordeel van 'n hospitaalplan : Met dien verstande dat die pasiënt nie geklassifiseer was as 'n privaat- of H4-hospitaal pasiënt nie;
- (iv) as 'n H4-hospitaal pasiënt indien –
 - (aa) (i) hy of sy as 'n enkellopende persoon sonder 'n afhanklike –
 - (aaa) 'n jaarlikse inkomste van meer as R30 000 het; of
 - (bbb) die eienaar is van netto bates met 'n waarde van meer as R114 000; of

- (bb) he or she is a member of a family unit which –
 - (aaa) has an annual income of nil to R26 000; or
 - (bbb) is the owner of net assets with a value of less than R98 000; or
- (cc) he or she submits proof that he or she receives a social pension or allowance and is not treated by a private medical practitioner;
- (ii) as an H2 hospital patient if –
 - (aa) he or she as a single person without a dependant –
 - (aaa) has an annual income of R15 001 to R22 000; or
 - (bbb) is the owner of net assets with a value of R59 001 to R76 000; or
 - (bb) he or she is a member of a family unit which –
 - (aaa) has an annual income of R26 001 to R38 000; or
 - (bbb) is the owner of net assets with a value of R98 001 to R141 000;
- (iii) as an H3 hospital patient if –
 - (aa) he or she as a single person without a dependant –
 - (aaa) has an annual income of R22 001 to R30 000; or
 - (bbb) is the owner of net assets with a value of R76 001 to R114 000; or
 - (bb) he or she is a member of a family unit which –
 - (aaa) has an annual income of R38 001 to R49 000; or
 - (bbb) is the owner of net assets with a value of R141 001 to R190 000; or
 - (cc) he or she is not a member of a medical fund, but is entitled to the benefits of a hospital plan : Provided that the patient has not been classified as a private or an H4-hospital patient;
- (iv) as an H4 hospital patient if –
 - (aa) (i) he or she as a single person without a dependant –
 - (aaa) has an annual income of more than R30 000; or
 - (bbb) is the owner of net assets with a value of more than R114 000; or

- (ii) hy of sy 'n lid van 'n gesinseenheid is wat -
 - (aaa) 'n jaarlikse inkomste van meer as R49 000 het; of
 - (bbb) die eienaar is van netto bates met 'n waarde van meer as R190 000; en
- (iii) die hoof uitvoerende beamppte toestemming verleen het dat hy of sy as 'n H4-hospitaalsiënt behandel mag word; of
- (bb) hy of sy op rekening van 'n staatsdepartement, 'n plaaslike owerheid of 'n buitelandse regering in 'n hospitaal behandel word; of
- (cc) hy of sy 'n lid is van 'n mediese hulp- of bystandskema wat kragtens wet geregistreer is : Met dien verstande dat so 'n pasiënt se lidmaatskap van 'n mediese hulp- of bystandskema nie vir klassifikasiedoeleindes in aanmerking geneem word nie in 'n geval waar -
 - (i) hy of sy ten tye van sy toelating tot die hospitaal nog nie op voordeel ingevolge die mediese hulp- of bystandskema geregtig is nie;
 - (ii) hy of sy nie voordele ingevolge die mediese hulp- of bystandskema sal ontvang ten opsigte van die behandeling van die siekte of prosedure waarvoor hy of sy tot die hospitaal toegelaat word nie; of
 - (iii) sy of haar voordele ingevolge die mediese hulp- of bystandskema ten tye van sy of haar toelating tot die hospitaal uitgeput was.

Free medical treatment and provision of free lodging

8. (1) Notwithstanding any provisions to the contrary contained in these regulations, medical treatment shall be provided free of charge by an official medical practitioner in a hospital to the following patients, excluding foreign patients :
- (a) a resident baby, but only if the mother has been classified as an H1, H2 or H3 hospital patient;
 - (b) a relative;
 - (c) a donor;
 - (d) a person who is specifically admitted for tertiary examination purposes for the continuous evaluation of students in practical and clinical work;
 - (e) school children who can be classified as H1 hospital patients, and who are referred by school nursing services or oral health services with a school authorisation certificate, for all treatment arising from such authorisation certificate;
 - (f) a person who, as a suspected or confirmed case, is admitted to a hospital for one or more of the following diseases :
 - (i) venereal diseases, which include the following : syphilis, gonorrhoea, chancroid, lymphogranuloma venereum, urethritis (non-specific), venereal warts, granuloma inguinale, ulcus molle and herpes genitalis;
 - (ii) pulmonary tuberculosis;
 - (iii) leprosy;
 - (iv) cholera;
 - (v) diphtheria;
 - (vi) plague;
 - (vii) typhoid and paratyphoid fever;
 - (viii) haemorrhagic fever diseases; and
 - (ix) meningococcus meningitis,

Met dien verstande dat indien daar tydens die behandeling van 'n pasiënt wat vir 'n ander siekte in die hospitaal opgeneem is, ontdek word dat hy of sy aan een van die voormelde siektes ly, die pasiënt steeds, in soverre dit die behandeling van die siekte waarvoor hy of sy oorspronklik toegelaat is betref, aanspreeklik is vir die betaling van die hospitaalgelde wat op hom of haar van toepassing is : Met dien verstande verder dat in die geval van 'n siekte in subparagraaf (i) bedoel, slegs die behandeling wat in die buitepasiëntafdeling toegepas word, gratis is;

- (g) enige beampte of werknemer in diens van die Departement van Gesondheid wat –
 - (i) tydens die verrigting van sy of haar amptelike pligte enige geneesmiddel, gif, gas, radioaktiewe stof, radioterapeutiese of diagnostiese toerusting of ander elektroniese toerusting hanteer het of daarmee in aanraking gekom het en om hierdie rede verplig is om 'n mediese ondersoek te ondergaan en behandeling te ontvang;
 - (ii) aan diens bescer word; of
 - (iii) as 'n diensvoorwaarde gedurende sy of haar dienstydsperk op gratis mediese behandeling geregtig is;
- (h) 'n persoon wat vir gesinsbeplanningsdoeleindes behandel word as deel van 'n gesinsbeplanningsprogram –
 - (i) as 'n buitepasiënt by 'n gesinsbeplanningskliniek (ingesluit servikale smere vir III-, II2- of II3-hospitaalpasiënte);
 - (ii) om 'n sterilisasieoperasie te ondergaan;
 - (iii) om kraambehandeling te ontvang nadat sodanige pasiënt ten spyte van 'n sterilisasieoperasie onder die gesinsbeplanningsprogram, weer swanger geraak het;
 - (iv) om nadat sodanige pasiënt gekraam het, 'n post partumsterilisatieoperasie as deel van die gesinsbeplanningsprogram te ondergaan;
 - (v) vir komplikasies wat voortvloei uit 'n sterilisasieoperasie wat sodanige pasiënt onder die gesinsbeplanningsprogram ondergaan het; of
 - (vi) om 'n spermtellingondersoek te ondergaan nadat 'n vasektomie op sodanige pasiënt uitgevoer is (uitgesluit tersiêre dienste);
- (i) 'n persoon wat as 'n buitepasiënt verwys word vir 'n ondersoek ingevolge die bepaling van artikel 37 van die Strafproseswet, 1977 (Wet No 51 van 1977);
- (j) 'n geestesongestelde persoon wat 'n voor-opname ondersoek benodig voor toelating tot 'n psigiatrisie inrigting;
- (k) 'n II1-, II2- of II3-hospitaalpasiënt aan wie 'n tuisbesoek gebring word deur geneeskundige, paramediese of verplegingspersoneel wat in diens van die Departement van Gesondheid is;
- (l) 'n persoon aan wie algemene gesondheidsvoorligtingsdienste en siftingsondersoeke (insluitende mondgesondheidsdienste maar uitgesluit spesiale ondersoeke en laboratoriumondersoeke) verskaf word;
- (m) 'n persoon wat hom of haar by 'n hospitaal aanmeld vir immunisering en ander maatreëls ter bekamping van aanmeldbare siektes binne primêre gesondheidsorg fasiliteite;

Provided that if it is discovered during the treatment of a patient who has been admitted to the hospital for another disease, that he or she suffers from one of the aforementioned diseases, the patient shall remain liable, in so far as the treatment of the disease for which he or she was originally admitted is concerned, for payment of the hospital fees applicable to him or her : Provided further that, in the case of a disease mentioned in subparagraph (i), only the treatment applied in the outpatient division, shall be free of charge;

- (g) any officer or employee in the service of the Department of Health who –
 - (i) in the performance of his or her official duties, handled or came into contact with any drug, poison, gas, radio-active substance, radio-therapeutic or diagnostic equipment or other electronic equipment, and is for this reason compelled to undergo a medical examination and to receive treatment;
 - (ii) is injured on duty; or
 - (iii) as a condition of service, is entitled to free medical treatment during his or her period of service;
- (h) any person treated for family planning purposes as part of a family planning programme –
 - (i) as an outpatient at a family planning clinic (including cervical smears for H1, H2 or H3 hospital patients);
 - (ii) to undergo a sterilisation operation;
 - (iii) to receive maternity treatment after the patient, despite a sterilisation operation under the family planning programme, became pregnant again;
 - (iv) after giving birth, to undergo a post-partum sterilisation operation as part of the family planning programme;
 - (v) for complications resulting from a sterilisation operation which such patient underwent under the family planning programme; or
 - (vi) to undergo a scheduled sperm count after a vasectomy was performed on such patient (excluding tertiary services);
- (i) a person who is referred as an outpatient for an examination in terms of the provisions of section 37 of the Criminal Procedure Act, 1977 (Act No 51 of 1977);
- (j) a mentally ill person who needs pre-admission examination before admission to a psychiatric institution;
- (k) an H1, H2 or H3 hospital patient to whom a home visit is paid by medical, paramedical or nursing staff who are in the employ of the Department of Health;
- (l) a person to whom general health counselling services and screening examinations (including oral health but excluding special examinations and laboratory examinations) are provided;
- (m) a person who reports at a hospital for immunisation and other measures to combat notifiable diseases within primary health care facilities;

- (n) sekere geselekteerde afgetrede medici, bekend as ere-mediese konsultante, wat nie aan 'n mediese hulp- of bystandskema behoort nie;
- (o) swanger vroue en kinders onder 6 jaar, ingesluit buitelandse pasiënte, wat nie aan 'n mediese hulp- of bystandskema behoort nie : Met dien verstande dat indien hierdie pasiënte deur 'n privaat geneesheer behandel word, slegs die hospitalisasie gratis is;
- (p) 'n persoon wat 'n aborsie ondergaan;
- (q) kinders wat kragtens artikel 15 van die Wet op Kindersorg, 1983 (Wet No 74 van 1983), aan 'n kinderhuis, nywerheidsskool, veiligheidsplek of aan die sorg van pleegouers toevertrou is; en
- (r) in die geval van die volgende ondersoeke wat deur 'n verantwoordelike owerheidsinstansie aangevra word :
 - (i) die ondersoek van die beweerde slagoffer van 'n aanranding, verkragting of seksuele molesting en die neem en ontleding van monsters;
 - (ii) die ondersoek van gevangenes en aangehouenes vir regs geneeskundige doeleinde met die oog op hul verwysing vir waarneming ingevolge die Wet op Geestesgesondheid, 1973 (Wet No 18 van 1973);
 - (iii) die uitvoer van lykskouings en die bywoning van opgrawings;
 - (iv) voorondersoeke vir die toediening van lyfstraf by aanhoudingselle van die Suid-Afrikaanse Polisie dienste en die bywoning van lyfstraf toediening in gevangenis.

(2) Ondanks die bepalings van hierdie regulasies kan –

- (a) 'n inwonende hospitaalpersoneelid wat aan 'n geringe ongesteldheid ly, gratis as 'n binnepasiënt in 'n hospitaal opgeneem word vir 'n tydperk van nie langer as drie dae nie :

Met dien verstande dat die hoof uitvoerende beampte in elke geval sertifiseer dat die betrokke persoon gerieflikheidshalwe, en nie om mediese redes nie, in die hospitaal in plaas van die tehuis behandel moet word : Met dien verstande verder dat die betrokke personeelid volle losies en inwoning in die tehuis betaal;

- (b) buitepasiëntbehandeling gratis aan hospitaalpersoneel verskaf word in die volgende gevalle :
 - (i) verpligte roetine ondersoeke;
 - (ii) immuniseringsmaatreëls ter voorkoming van aansteeklike siektes;
 - (iii) ondersoeke ter kontrolering van siekteverlof;
 - (iv) ondersoeke en bloedtoetse waar vermoed word dat 'n personeelid onder die invloed van sterk drank of ander verdowingsmiddels aan diens is; en
 - (v) geringe ongesteldhede waarvoor eenvoudige behandeling en medikasie vir 'n tydperk van nie langer as 24 uur nie, vereis word;

- (n) certain selected retired physicians, known as honorary medical consultants, who do not belong to a medical aid or provident scheme;
- (o) pregnant women and children under the age of 6 years, including foreign patients, who are not members of a medical aid or provident scheme : Provided that if these patients are treated by a private medical practitioner, only the hospitalisation shall be free of charge;
- (p) a person who undergoes an abortion;
- (q) children who, in terms of section 15 of the Child Care Act, 1983 (Act No 74 of 1983), are committed to the care of a children's home, school of industries, place of safety or foster parents; and
- (r) in the case of the following examinations which are requested by a responsible government institution :
 - (i) the examination of the alleged victim of an assault, rape or sexual molesting and the taking and analysing of samples;
 - (ii) the examination of prisoners and detainees for medico - legal purposes with a view to their referral for observation in terms of the Mental Health Act, 1973 (Act No 18 of 1973);
 - (iii) the carrying out of autopsies and the attendance of exhumations;
 - (iv) preliminary examinations for the administration of corporal punishment in detaining cells of the South African Police Services and the attendance of the administration of corporal punishment in prisons.

(2) Notwithstanding the provisions of these regulations –

- (a) a member of the resident hospital staff who suffers from a minor ailment, may be admitted to a hospital as an inpatient free of charge for a period of not longer than three days :

Provided that the chief executive officer certifies in every case that the person concerned is treated in the hospital instead of the hostel, for reasons of convenience and not for medical reasons : Provided further that the staff member concerned shall pay full board and lodging in the home;

- (b) outpatient treatment may be rendered free of charge to hospital staff in the following cases :
 - (i) compulsory routine examinations;
 - (ii) immunisation measures for the prevention of contagious diseases;
 - (iii) examinations for monitoring sick leave;
 - (iv) examinations and blood tests where it is suspected that a staff member is on duty under the influence of intoxicating liquor or other drugs; and
 - (v) minor ailments for which uncomplicated treatment and medication are required for a period of not longer than 24 hours;

(c) gratis inwoning in 'n hospitaal verskaf word aan –

- (i) 'n loseerder, maar slegs in 'n geval waar die pasiënt in wie se belang hy of sy toegelaat is, as 'n II1-, II2- of II3-hospitaalpasiënt geklassifiseer is;
- (ii) 'n inwonende kind, maar slegs in 'n geval waar die moeder as 'n II1-, II2- of II3-hospitaalpasiënt geklassifiseer is.

Gelde in verband met buitelandse pasiënte

9. 'n Buitelandse pasiënt wat –

- (a) op 'n tydelike besoek in die Republiek is en noodmediese behandeling benodig, word beskou as 'n privaat pasiënt;
- (b) spesiaal en op eie verantwoordelikheid die Republiek uitsluitlik vir mediese behandeling besoek (ingesluit swanger vroue en kinders onder 6 jaar), sowel as toeriste wat verlang dat elektiewe prosedures by 'n hospitaal op hulle toegepas word, is aanspreeklik vir die betaling van sodanige behandeling teen dubbel die tarief van toepassing op 'n privaat pasiënt.

Gelde vir medisyne

10. (1) Medisyne om gratis uit 'n hospitaal weg te neem, kan verskaf word aan –

- (a) 'n II1-, II2- of II3-hospitaalpasiënt;
- (b) 'n privaat pasiënt of 'n II4-hospitaalpasiënt, maar slegs in die geval waar –
 - (i) die medisyne wat hy of sy ontvang, benodig word vir tuisverbruik na ontslag uit 'n ongevalle-afdeling en die hoeveelheid medisyne aldus uitgereik nie vir meer as 24 uur se gebruik is nie; of
 - (ii) hy of sy aan 'n siekte ly bedoel in regulasie 8(1)(f), en die medisyne wat hy of sy ontvang, direk met die betrokke siekte in verband staan.

(2) (a) Medisyne op die amptelike kodelys kan teen betaling verskaf word aan 'n privaat pasiënt of 'n II4-hospitaalpasiënt om uit 'n hospitaal weg te neem indien –

- (i) sodanige medisyne van die onkoterapie-, peritoneale of haemo dialisemiddels of ander middels is wat van tyd tot tyd deur die Hoof: Departement van Gesondheid bepaal word;
- (ii) sodanige medisyne deur 'n oorplantingspasiënt benodig word;
- (iii) die hoof uitvoerende beampte van die hospitaal goedkeur dat die medisyne, wat voorgeskryf moet word deur 'n amptelike geneesheer, aan sodanige pasiënt verskaf word weens sy of haar finansiële en ander persoonlike omstandighede; of
- (iv) die hoof uitvoerende beampte van die hospitaal homself of haarself oortuig het dat die pasiënt nie redelikerwys die betrokke medisyne wat dringend vir die behandeling van sy of haar toestand benodig word, plaaslik uit 'n ander bron kan bekom nie.

(b) 'n Pasiënt aan wie medisyne kragtens die bepalings van paragraaf (a) verskaf word, moet die aankoopkoste van sodanige medisyne plus 50 % aan die hospitaal vergoed.

- (c) free lodging can be provided in a hospital to –
 - (i) a boarder, but only if the patient in whose interest he or she has been admitted, has been classified as an II1, II2 or II3 hospital patient;
 - (ii) a resident child, but only if the mother has been classified as an II1, II2 or II3 hospital patient.

Fees in respect of foreign patients

9. A foreign patient who –

- (a) is on a temporary visit to the Republic and requires emergency medical treatment, shall be regarded as a private patient;
- (b) specially and on his or her own responsibility visits the Republic exclusively for medical treatment (including pregnant women and children under 6 years), as well as tourists who wish that they be given elective medical treatment at a hospital, shall be liable for payment of such treatment at double the tariff applicable to a private patient.

Fees for medicine

10. (1) Medicine to be taken out of a hospital free of charge, may be supplied to –

- (a) an II1, II2 or II3 hospital patient;
- (b) a private patient or an II4 hospital patient, but only in a case where –
 - (i) the medicine which he or she receives, is required for home consumption after discharge from a casualty division, and the quantity of medicine thus issued is for use for a period not exceeding 24 hours; or
 - (ii) he or she suffers from a disease referred to in regulation 8(1)(f) and the medicine he or she receives, is directly related to the disease concerned.

(2) (a) Medicine on the official code list may be supplied on payment to a private patient or an II4 hospital patient to be taken out of a hospital, if –

- (i) such medicine is of the oncotherapy, peritoneal or haemo dialysis substances or other substances determined by the Head : Department of Health from time to time;
- (ii) such medicine is needed by a transplant patient;
- (iii) the chief executive officer of the hospital approves that the medicine, which must be prescribed by an official medical practitioner, be supplied to such patient on account of his or her financial and other personal circumstances; or
- (iv) the chief executive officer of the hospital has satisfied himself or herself that the patient cannot reasonably obtain the medicine concerned, which is urgently required for the treatment of his or her condition, locally from another source.

(b) A patient to whom medicine is issued in terms of the provisions of paragraph (a), shall remunerate the hospital for the purchase cost of such medicine, plus 50 %.

- (3) (a) (i) Geen gelde word teen 'n H1-, H2- of H3-hospitaalsiënt gehef ten opsigte van medisyne wat tydens binnepasiënt- of ongevallebehandeling aan hom of haar toegedien word nie.

Gelde vir bloed en bloedprodukte

11. (1) Geen gelde is betaalbaar vir bloed en bloedprodukte wat aan 'n H1-, H2- of H3-hospitaalsiënt verskaf is nie.
- (2) Die koste van bloed en bloedprodukte, wat deur die Suid-Afrikaanse Bloedoortappingsdiens verskaf is en tydens behandeling in 'n hospitaal aan 'n privaat pasiënt of 'n H4-hospitaalsiënt toegedien word, moet deur die betrokke pasiënt direk aan die voormelde Bloedoortappingsdiens vergoed word : Met dien verstande dat indien sodanige bloed en bloedprodukte deur 'n ander bloedoortappingsdiens verskaf is, die pasiënt die aankoopkoste daarvan aan die betrokke hospitaal moet vergoed.
- (3) Ondanks die bepalings van subregulasie (2) is 'n privaat pasiënt of 'n H4-hospitaalsiënt wat faktor VIII, faktor IX en propleks of 'n ekwivalent as 'n binne- of buitepasiënt ontvang die volgende tarief verskuldig per besoek :

- (3) (a) (i) No fees shall be levied against an II1, II2 or II3 hospital patient in respect of medicine administered to him or her during inpatient or casualty treatment.
- (ii) The following fees is payable by an II1, II2 or II3 hospital patient in respect of a prescription issued to him or her during outpatient or casualty treatment:

- Provided that where casual medication (including pre-operative medicine) is provided from ward supplies to a private patient or an II4 hospital patient receiving inpatient treatment, no fees shall be payable.
- (ii) Notwithstanding the provisions of subregulation (3)(b)(i), a private patient or an II4 hospital patient who receives substances which appear on the list referred to in subregulation (2)(a)(i), during inpatient treatment, shall pay for such substances at purchase cost plus 50 %.
- (c) No fees shall be levied against a private patient or an II4 hospital patient in respect of medicine administered to him or her during outpatient or casualty treatment : Provided that if oncotherapy, transplant or peritoneal dialysis substances or other substances, as determined in terms of subregulation (2)(a)(i), are administered, such patient shall pay for such substances at purchase cost plus 50 %.

Fees for blood and blood products

11. (1) No fees shall be payable for blood and blood products supplied to an II1, II2 or II3 hospital patient.
- (2) The cost of blood and blood products, which are supplied by the South African Blood Transfusion Service and are administered to a private patient or an II4 hospital patient during treatment in a hospital, shall be paid by the patient concerned, directly to the aforementioned Blood Transfusion Service : Provided that where such blood and blood products were supplied by another blood transfusion service, the patient shall remunerate the purchase cost thereof to the hospital concerned.
- (3) Notwithstanding the provisions of subregulation (2), a private patient or an II4 hospital patient who receives factor VIII, factor IX and proplex or an equivalent as an in- or outpatient, shall be liable for the following tariff per visit:

In alle hospitale R210,00,

Gelde vir X-straalfoto's vir diagnosering van pneumokoniose

12. (1) X-straalfoto's in verband met pneumokoniose-ondersoek kan op aanvraag van die Buro vir Bedryfsiektes, landdroste, mediese beamptes en amptenare van 'n staatsdepartement van persone geneem word teen die onderstaande tarief :

- (i) In 'n distrikshospitaal R 60,00;
- (ii) In 'n streekhospitaal R 95,00;
- (iii) In 'n tersiêre hospitaal R105,00,

Met dien verstande dat geen gelde gehef word vir die besoek aan die buitepasiëntafdeling nie.

- (2) Die Buro vir Bedryfsiektes is verantwoordelik vir die betaling van die tarief vermeld in subregulasie (1).

Gelde vir ortopediese hulpmiddels, prosteses, ander hulpmiddels en krukke

13. (1) (a) 'n Pasiënt aan wie 'n ortopediese hulpmiddel, protese, ander hulpmiddels of krukke deur 'n hospitaal voorsien word, is aanspreeklik vir die betaling van die gelde soos in Aanhangsel A teenoor die betrokke item uiteengesit.
- (b) Ondanks die bepalings van paragraaf (a) kan daar in 'n geval waar 'n amptelike geneesheer sertifiseer dat die uitreiking van 'n paar krukke -
- (i) sal verhoed dat 'n persoon as 'n III-hospitaalpasiënt vir binnepasiëntbehandeling in 'n hospitaal opgeneem word; of
 - (ii) sal meebring dat so 'n pasiënt se verblyf in 'n hospitaal as 'n binnepasiënt verkort word,

'n paar krukke gratis aan die betrokke persoon uitgereik word.

- (c) Geen stappe word gedoen om die krukke wat ingevolge die bepalings van paragraaf (a) of (b) uitgereik is, terug te vorder nie.

- (2) Waar 'n ortopediese hulpmiddel of 'n ander hulpmiddel deur 'n amptelike geneesheer vir 'n II4-hospitaalpasiënt, of, waar sodanige hulpmiddel nie in die privaat sektor bekombaar of vervaardig word nie, deur 'n privaat geneesheer vir 'n privaat pasiënt, voorgeskryf word en dit in 'n hospitaal vervaardig of herstel word, word die volgende gelde teen die betrokke pasiënt gehef :

- (a) arbeidskoste bereken teen R37,00 per uur; plus
- (b) die aankoopkoste van die materiaal verbruik; plus
- (c) 'n heffing van 15 % op die totaal van die bedrae bereken volgens paragrawe (a) en (b),

Met dien verstande dat die pas van alle hulpmiddels gratis is.

In all hospitals R210,00,

Provided that these substances will only be made available to foreign patients with the consent of the chief executive officer of the hospital concerned.

Fees for X-rays for the diagnosis of pneumoconiosis

12. (1) X-rays in connection with pneumoconiosis examinations may be taken of persons at the request of the Bureau for Occupational Diseases, magistrates, medical officers and officers of a government department, at the undermentioned tariff :

- (i) In a district hospital R 60,00;
- (ii) In a regional hospital R 95,00;
- (iii) In a tertiary hospital R105,00,

Provided that no fees shall be charged for the visit to the outpatient division.

- (2) The Bureau for Occupational Diseases shall be liable for the payment of the tariff mentioned in subregulation (1).

Fees for orthopaedic appliances, prosthesis, other appliances and crutches

13. (1) (a) A patient to whom an orthopaedic appliance, prosthesis, other appliances or crutches are provided by a hospital, shall be liable for the payment of the fees as set out opposite the item concerned in Annexure A.
- (b) Notwithstanding the provisions of paragraph (a), if an official medical practitioner certifies that the issuing of a pair of crutches –
- (i) will obviate the admission of a person as an III hospital patient to a hospital for inpatient treatment; or
 - (ii) will shorten such a patient's stay in hospital as an inpatient,
- a pair of crutches may be issued to such a person free of charge.
- (c) No steps shall be taken to recover crutches issued in terms of the provisions of paragraph (a) or (b).
- (2) If an orthopaedic appliance or other appliance is prescribed for an II4 hospital patient by an official medical practitioner, or by a private medical practitioner to a private patient in a case where such appliance is not obtainable or manufactured in the private sector, and it is manufactured or repaired in a hospital, the following fees shall be levied against the patient concerned :
- (a) labour costs calculated at R37,00 per hour; plus
 - (b) the purchase cost of the material used; plus
 - (c) a levy of 15% on the total of the amounts, calculated according to paragraphs (a) and (b),

Provided that the fitting of all appliances shall be free of charge.

Gelde vir implantings

14. (1) Tydelike en permanente implantings word –

Gelde vir doodsklere

Fees for implantations

14. (1) Temporary and permanent implantations shall be supplied –
- (a) free of charge to an H1, H2 or H3 hospital patient;
 - (b) at purchase cost plus 15 % to a private patient or an H4 hospital patient.
- (2) The cost for the borrowing of a set of instruments which is required to perform the operation referred to in subregulation (1), must be paid by a private patient or an H4 hospital patient to the hospital concerned.

Fees in respect of mortuaries

15. The fees payable for the storage of a corpse in a mortuary at a hospital shall be as follows :
- (a) In a case where the deceased died in the hospital or on the hospital grounds as an inpatient, outpatient or casualty patient, or was brought to the hospital as an emergency case and was certified dead on arrival at the hospital –
 - (i) no fees shall be payable if the deceased was an H1, H2 or H3 hospital patient;
 - (ii) the fees payable by all other patients shall be R90,00 per 24 hours or part thereof : Provided that no fees shall be charged for the first 24 hours : Provided further that where a corpse is placed in a mortuary on –
 - (aa) a Friday or Saturday, it shall be deemed that the corpse was placed in the mortuary on a Sunday;
 - (bb) any day of a long week-end, it shall be deemed that the corpse was placed in the mortuary on the last day of the long week-end;
 - (b) If the deceased died in circumstances other than those mentioned in paragraph (a), the fees payable shall be R95,00 per 24 hours or part thereof;
 - (c) If a corpse is preserved for training purposes, no fees shall be payable.

Fees for shrouds

16. No fees shall be payable when a shroud is supplied for any person who died in a hospital or on the hospital grounds as an inpatient, outpatient or casualty patient.

Fees for post-mortems

17. The fees payable in respect of a post-mortem shall be the following :
- (a) If the deceased died in the hospital or on the hospital grounds as an inpatient, outpatient or casualty patient, no fees shall be charged for a post-mortem carried out at the hospital: Provided that this provision shall not apply in the case of unnatural deaths;
 - (b) If the deceased died in circumstances other than those mentioned in paragraph (a), R95,00 shall be charged per post-mortem and, if the body stays in the mortuary for longer than 24 hours, R95,00 shall be charged for every subsequent 24 hours or part thereof, and all fees determined in this paragraph, shall be payable by the institution that requested the post-mortem;

- (c) Waar 'n lykskouing vir opleidingsdoeleindes uitgevoer word, is geen gelde betaalbaar nie.

- (ii) medico-legal services in connection with –
 - (aa) assault;
 - (bb) rape;
 - (cc) driving a vehicle under the influence of intoxicating liquor or drugs;
 - (dd) a mentally ill person, with a view to referral for observation in terms of the Mental Health Act, 1973;
 - (ee) a certification or confirmation of death;
 - (ff) a post-mortem; and
 - (gg) corporal punishment;

- (iii) an application for an original sick-leave certificate;

- (b) a medical report is issued by a medical practitioner in respect of –

- (i) a private inpatient or outpatient; or
- (ii) a case in terms of the Compensation for Occupational Injuries and Diseases Act, 1993 (Act No 130 of 1993),

who was treated by an official medical practitioner.

- (2) If a report or certificate other than those mentioned in subregulation (1), is requested by an authorised person or organisation, such report or certificate may be made available on payment of an amount of R190,00 per item.
- (3) If only copies are made of hospital records, a report or a certificate, the person or organisation who requested such copies, shall pay an amount of R95,00, before those copies will be made available.
- (4) The following fees shall be payable for certificates issued for cremation purposes :
- (a) medical certificate R95,00;
 - (b) verifying medical certificate R95,00.

- (5) Upon completion of a report for a patient's hospital insurance plan in respect of his or her period of hospitalisation, a non-recurrent tariff of R190,00 shall be charged.

Fees payable for a visit to a primary health care centre or a community health centre

19. A patient who receives treatment, excluding level III and level IV oral health services in a primary health care centre or a community health centre of a hospital, shall be liable for the payment of the following fees in respect of every visit :
- (a) In a community health centre where full-time medical treatment by a medical practitioner is available :
 - (i) As an outpatient :
An I11, H2, H3 or H4 hospital patient Free of charge;
 - (ii) As an inpatient :
An I11, H2, H3 or H4 hospital patient Free of charge.
 - (b) In a primary health care centre where medical treatment by a medical practitioner is not available on a full-time basis, but services are rendered full-time by professional nurses :
 - (i) As an outpatient :
An I11, H2, H3 or H4 hospital patient Free of charge;
 - (ii) As an inpatient :
An I11, H2, H3 or H4 hospital patient Free of charge.
 - (c) In a case where a home visit is paid :
An I11, H2, H3 or H4 hospital patient Free of charge.
 - (d) In a case where a mobile clinic or an occasional visiting point of a hospital which is not served on a full-time basis, is visited :
An I11, H2, H3 or H4 hospital patient Free of charge.
 - (e) In a case where a mobile radiological unit of a hospital is visited :
An I11, H2, H3 or H4 hospital patient Free of charge.

Fees payable for after-care service operated from a hospital

20. The fees payable for an after-care service operated from a hospital are as follows :
- An I11, H2, H3 or H4 hospital patient Free of charge.

25. 'n Privaat pasiënt of 'n II4-hospitaalpasiënt wat 'n hartkaterisasie ondergaan betaal 'n addisionele fooi van R1080,00 : Met dien verstande dat alle mediese verbruikbare voorraad soos uiteengesit in Aanhangsel D wat vir hierdie prosedure gebruik word, per item voor betaal word.

Herroeping

26. Die Regulasies oor Gelde vir Gesondheidsdienste in die Vrystaat, 1998, afgekondig by Provinsiale Kennisgewing No 76 van 8 Mei 1998, word hierby herroep.

Kort titel en inwerkingtreding

27. Hierdie Regulasies staan bekend as die Regulasies oor Gelde vir Gesondheidsdienste in die Vrystaat, 1999, en tree op 1 Mei 1999 in werking.

Other tariffs**21. (a) Oxygen :**

If oxygen is in exceptional cases with the consent of the chief executive officer, dispensed from a hospital to a private patient or an H4 hospital patient, the patient shall pay the following amount per cylinder plus 30 % handling fees :

In all hospitals R150,00,

Provided that the cylinder shall remain the property of the supplier.

(b) Medical consumables :

(i) Medical consumable items on the official list may be supplied to a private patient or an H4 hospital patient on payment of the purchase cost plus 30 % thereof, to be taken out of the hospital.

(ii) If a private- or H4 hospital patient receives any of the consumables set out in Annexure B, the patient shall pay the purchase cost thereof.

Fees payable for non-pharmaceutical substances

22. If non-pharmaceutical substances are in exceptional cases with the consent of the chief executive officer, dispensed from the hospital to a private patient or an H4 hospital patient, the patient shall pay the purchase cost thereof plus 30 %.

Fees payable with regard to the use of specialized oncotherapy treatment apparatus

23. A private patient who during inpatient treatment or during a visit to the outpatient division at a hospital, receives radiation oncology services by private radiotherapists, shall pay for the use of such apparatus at $66 \frac{2}{3}$ % of the amount, as prescribed in the Benefit Scale Tariffs in respect of such apparatus.

Fees for oral health

24. A patient who receives oral health services, shall be liable for the payment of the fees as set out opposite the item concerned in Annexure C.

Fees for cardiac catheterisation

25. A private patient or an H4 hospital patient who undergoes a cardiac catheterisation shall pay an additional amount of R1080,00 : Provided that all medical consumables as set out in Annexure D which are used for this procedure shall be paid for per item.

Repeal

26. The Regulations on Hospital Fees in the Free State, 1998, promulgated by Provincial Notice No 76 of 8 May 1998, are hereby repealed.

Short title and commencement

27. These Regulations shall be called the Regulations on Fees for Health Services in the Free State, 1999, and shall come into operation on 1 May 1999.

REGULATIONS ON AMBULANCE FEES IN THE FREE STATE

Under section 16(2) of the Health Act, 1977 (Act No 63 of 1977), I, Senorita Ntlabati, Member of the Executive Council of the Province responsible for Health, hereby make the regulations as set out in the Schedule.

Schedule

Definitions

1. In these Regulations, unless the context indicates otherwise –

“ambulance” means a motor vehicle specially constructed or adapted for the conveyance of sick or injured persons to or from a place for medical treatment and which is registered as an ambulance;

“H1 hospital patient” means a patient classified in terms of regulation 2(3)(b)(i) of the Regulations as an H1 hospital patient;

“H2 hospital patient” means a patient classified in terms of regulation 2(3)(b)(ii) of the Regulations as an H2 hospital patient;

“H3 hospital patient” means a patient classified in terms of regulation 2(3)(b)(iii) of the Regulations as an H3 hospital patient;

“H4 hospital patient” means a patient classified in terms of regulation 2(3)(b)(iv) of the Regulations as an H4 hospital patient;

“motor vehicle” means any self-propelled vehicle;

“normal working hours” means the hours from 07:00 to 17:00 on a Monday to Friday, excluding a public holiday;

“patient” means a hospital patient or a private patient, as the case may be;

“private patient” means a patient classified in terms of regulation 2(4) of the Regulations as a private patient;

“public holiday” means a public holiday referred to in section 2 of the Public Holidays Act, 1994 (Act No 36 of 1994);

“Regulations” means the Regulations on Hospital Fees in the Free State, 1999;

“vehicle” means a vehicle as defined in the Road Traffic Act, 1989 (Act No 29 of 1989).

Gelde vir gebruik van ambulans

2. (1) 'n Pasiënt wat per ambulans vervoer word, is aanspreeklik vir die betaling van die volgende gelde ten opsigte van elke 50 (vyftig) kilometer of gedeelte daarvan, afgelê:

(a)	'n I11-hospitaalpatiënt	R 15,00;
(b)	'n I12-hospitaalpatiënt	R 50,00;
(c)	'n I13-hospitaalpatiënt	R 70,00;
(d)	'n Privaat pasiënt en 'n I14-hospitaalpatiënt	R190,00:

Met dien verstande dat ambulansvervoer tussen hospitale gratis is vir alle I11-, I12- en I13-hospitaalpasiente: Met dien verstande verder dat waar 'n privaat pasiënt en 'n I14-hospitaalpatiënt buite normale werkure aldus vervoer word, die tarief R310,00 vir elke 50 (vyftig) kilometer of gedeelte daarvan, afgelê is.

- (2) Waar 'n ambulans op versoek op 'n bystandbasis ontplooi word, is 'n bedrag van R190,00 per uur of gedeelte daarvan, betaalbaar.

Herroeping

3. Die Regulasies oor Ambulansgelde in die Vrystaat, 1997, afgekondig by Provinsiale Kennisgewing No 145 van 1 Augustus 1997, word hierby herroep.

Kort titel en inwerkingtreding

4. Hierdie Regulasies staan bekend as die Regulasies oor Ambulansgelde in die Vrystaat, 1999, en tree op 1 Mei 1999 in werking.

Fees for use of ambulance

2. (1) A patient conveyed per ambulance shall be liable for the payment of the following fees in respect of every 50 (fifty) kilometres or part thereof, travelled:

(a)	An H1 hospital patient	R 15,00;
(b)	An H2 hospital patient	R 50,00;
(c)	An H3 hospital patient	R 70,00;
(d)	A private patient and an H4 hospital patient	R190,00;

Provided that ambulance transport between hospitals shall be free of charge for all H1, H2 and H3 hospital patients: Provided further that where a private patient and an H4 patient are thus conveyed outside normal working hours, the tariff shall be R310,00 for every 50 (fifty) kilometres or part thereof, travelled.

- (2) Where an ambulance is deployed on a standby basis on request, an amount of R190,00 per hour or part thereof, shall be payable.

Repeal

3. The Regulations on Ambulance Fees in the Free State, 1997, promulgated by Provincial Notice No 145 of 1 August 1997, are hereby repealed.

Short title and commencement

4. These Regulations shall be called the Regulations on Ambulance Fees in the Free State, 1999, and shall come into operation on 1 May 1999.
