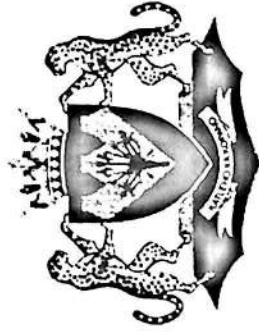

In terms of section 21 of the Local Government: Municipal Demarcation Act, 1998 (Act No. 27 of 1998) the Municipal Demarcation Board, has considered all objections and has confirmed, varied or withdrawn its determination of the municipal boundaries of category B (local) and category C (district) municipalities. The Board's redeterminations in terms of section 21(1)(b) are reflected in Schedule 1.
