Under the powers vested in me by section 3 of the Roads Ordinance, 1968 (Ordinance 4 of 1968), as amended, I hereby declare that the public roads, described below, will be closed and be changed in name and number from the date of publication of the proclamation:

1. **CLOSING OF A SECTION OF THE VAALBANK – WILDE ALS KOP TERTIARY ROAD T2288, C-B, SITUATED IN THE MAGISTERIAL DISTRICTS OF LINDLEY AND HEILBRON (LENGTH ± 2,45 km):**

From point C on Sterling 136, where tertiary road T2289 branches off; thence over Sterling 136, to point B on the boundary line between Sterling 136 and Utile Dulci 719.

2. **DECLARATION OF A SECTION OF THE VAALBANK – WILDE ALS KOP TERTIARY ROAD T2288 AS A SECTION OF THE STERLING – WELTEVREDEN TERTIARY ROAD T2289, A-C, SITUATED IN THE MAGISTERIAL DISTRICT OF LINDLEY (LENGTH ± 1,73 km):**
