Appropriation of amounts of money for requirements of the Province

1. Subject to the provisions of the Exchequer Act, 1994 (Act No 1 of 1994), there are hereby appropriated out of the Provincial Revenue Fund for the requirements of the Province in respect of the financial year ending 31 March 2001, the amounts of money as set out in column "Voted" of column 1 of the Schedule.
