**MUNICIPAL DEMARCATION BOARD
DELIMITATION OF MUNICIPAL WARDS IN TERMS OF THE LOCAL GOVERNMENT:
MUNICIPAL STRUCTURES ACT, 1998**

MUNICIPALITY : FS182

In terms of item 5(2) of Schedule 1 of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998) the Municipal Demarcation Board considered written objections to its delimitation of wards for the above-mentioned municipality and has confirmed, varied or withdrawn its determination as indicated in the Schedule.

Provincial Gazette No 38 of 8 May 2000 is hereby withdrawn.

SCHEDULE

In terms of section 18(3) of the Local Government: Municipal Structures Act, 1998 (Act 117 of 1998) the MEC for local government has determined that the municipal council consists of 7 councillors. After having consulted the Independent Electoral Commission, The Municipal Demarcation Board has delimited the municipality into 4 wards in terms of Schedule 1 of the Act.

The number of registered voters in each ward does not vary by more than fifteen percent from the norm. The norm was determined by dividing the total number of voters on the municipal segment of the national common voters roll, namely 11338 voters on 31 March 2000, by the number of wards in the municipality.

Ingevolge item 5(2) van Bylae 1 van die Wet op Plaaslike Regering: Munisipale Strukture, 1998 (Wet No. 117 van 1998) het die Munisipale Afbakeningsraad, na oorweging van skriftelike besware, sy afbakening van wyke bevestig, gewysig of ingetrek soos aangedui in die Skedule.

Provinsiale Koerant Nr 38 van 8 Mei 2000 word hiermee teruggetrek.

SKEDULE

Ingevolge artikel 18(3) van die Wet op Plaaslike Regering: Munisipale Strukture, 1998 (Wet 117 van 1998) het die LUR vir plaaslike regering bepaal dat die munisipale raad bestaan uit 7 raadslede. Na oorlegpleging met die Onafhanklike Verkiesingskommissie het die Munisipale Afbakeningsraad die munisipaliteit in 4 wyke afgebaken ingevolge Bylae 1 van die Wet.

Die getal geregistreerde kiesers in elke wyk, wyk nie meer as vyftien persent van die norm af nie. Die norm is bepaal deur die getal geregistreerde kiesers op die munisipale segment van die nasionale gemeenskaplike kieserslys, naamlik 11338 kiesers op 31 Maart 2000, deur die getal wyke in die munisipaliteit te deel.

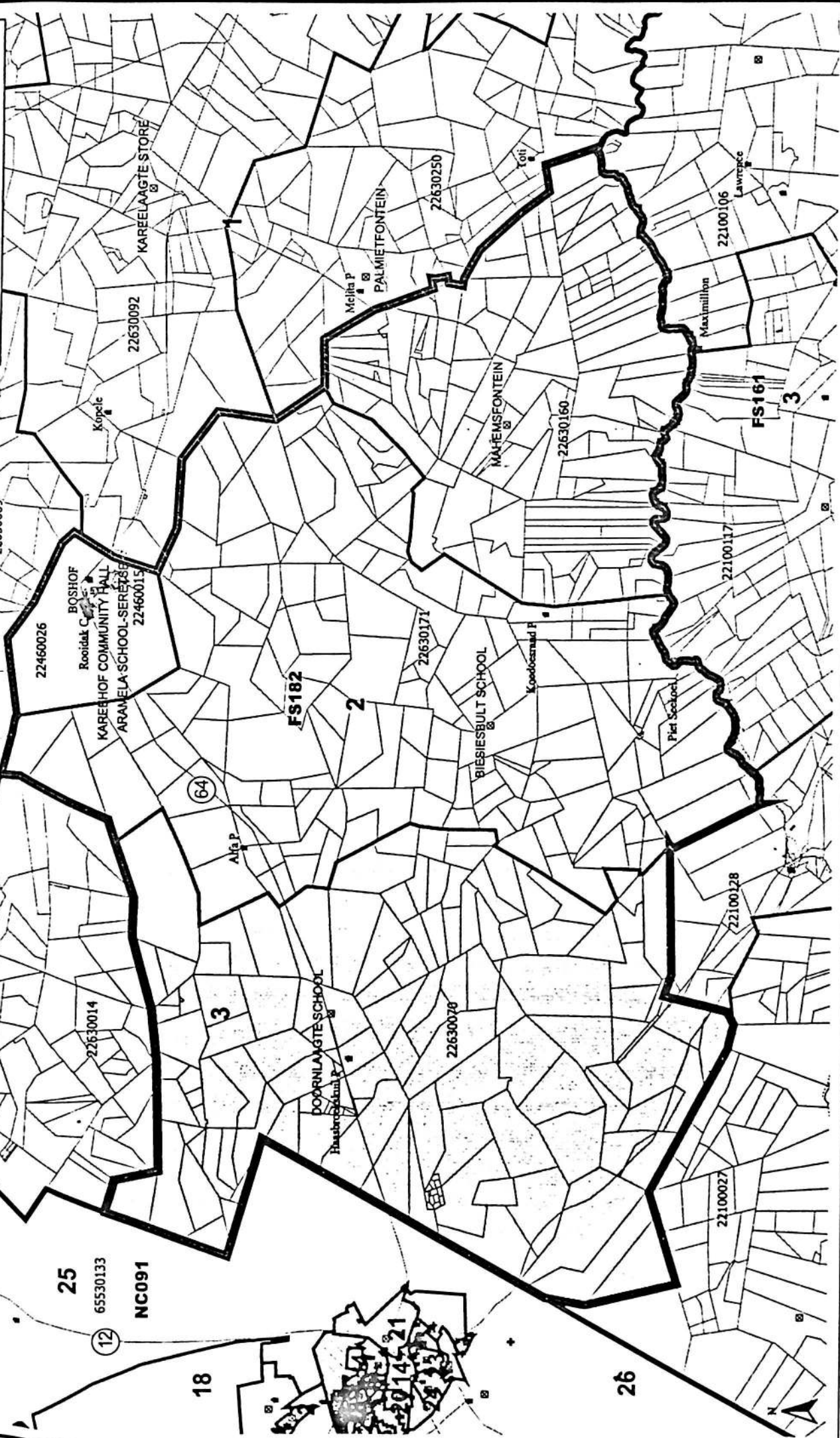

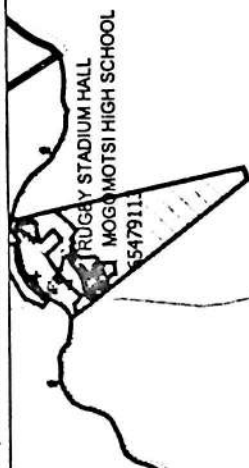
