Under the powers vested in me by section 2 of the Removal of Restrictions Act, 1967 (Act No. 84 of 1967), I, S L Tsenoli, Member of the Executive Council of the Province responsible for Local Government and Housing, hereby amend the Town-Planning Scheme of Bloemfontein by the rezoning of Erf No. 239, Bloemfontein (Westdene) from "Special Residential 2" to "Restricted Business 2".
