In terms of the Division of Revenue Act, Act No. 2 of 2006 Section29(1) & (2) for the 2006/2007 financial year and the Public Finance Management Act, 1999 Section 38(1) (I-n), the Provincial Treasury hereby publishes the information set out in Schedule 1 that relates to the allocation of the amounts as stated in Schedule 2 relating to the allocation of funds from the Provincial Revenue Fund by the Accounting Officer of the Department of Local Government and Housing to municipalities.

INTEGRATED DEVELOPMENT PLANNING SUPPORT PROGRAMME

Transferring Provincial Department	Department of Local Government and Housing
2. Purpose	To financially assist municipalities with the planning and surveying of erven with applicable reports and rudimentary services.
3. Measurable Outputs	 (a) The provision of limited financial assistance to municipalities facing financial problems with the planning and surveying of erven and; (b) The Installation of Storm water drainage and regravelling of roads in respect of Grassland Phase 2 and 3. (c) The opportunity to make use of professional experts in specialized fields within the Free State boundaries. (d) The planning and surveying oferven would have a positive impact on the service delivery of housing in the province to the previous disadvantaged areas of municipalities.
4. Conditions	 (a) The municipality can only use this financial assistance for the planning and surveying of erven, Storm water drainage and re-gravelling of roads in respect of Grassland Phase 2 and 3. (b) Monthly and quarterly reports to be submitted before the 3rd of each month on the status, expenditure and commitments. (c) The submission of a detailed action plan approved by Municipal Manger and cash flow projections before implementation. (d) The Municipal Manager must certify the expenditures were spent in respect of the approved action plan, that sufficient evidence to substantiate all payments is available and that activities were successfully implemented. (e) Council must make use of the services of registered professional service providers within the Free State boundaries. (f) Appointment of Consultants must be according to the Municipal Financial Management Act. (g) Payment to the Municipalities on planning and Surveying of erven will only be done on invoices authorized by the Municipal Manager on submission of detail design and actual pegging of erven. (h) The payment of Consultants claims must be on the following basis: (i) 25% after a full application for township establishment has been submitted to the Townships Board, (j) 25% after the General Plans have been submitted to the Surveyor General, and (l) 15% after the opening of the Township Register.
