## PROCLAMATION

**[No. 66 of 2008]**

### **HUNTING SEASON: 2009**

By virtue of the powers vested in me by section 4 of the Nature Conservation Ordinance, 1969 (Ordinance No. 8 of 1969), I, MA Dukwana, Member of the Executive Council responsible for Tourism, Environmental and Economic Affairs in the Province, hereby declare that any person may hunt/capture ordinary game as follows:

<b>Free State Province Hunting Season for the Year 2009</b>	
<b>Species of ordinary game in accordance with Schedule 2</b>	<b>Period during which hunting may take place and bag limits for terrestrial game birds and waterfowl</b>
Helmeted Guineafowl, Swainson's Francolin [Swainson's Spurfowl] Grey-winged Francolin, Orange River Francolin and Common Quail.  Egyptian Goose, Spur-winged Goose, Yellow-billed Duck and Red-billed Teal.	1 <sup>st</sup> May 2009 up to and including 31 <sup>st</sup> August 2009.  A maximum of ten (10) terrestrial gamebirds, and ten (10) waterfowl per hunter per day (including wounded birds and those not retrieved). Any Ordinary gamebird, except for Common Quail, may be hunted only if in groups of three or more birds (pairs and single birds may be breeding).
Rock Pigeon, Cape Turtle Dove, Laughing Dove and Red Knobbed Coot.  <b>Birds not mentioned above are listed as protected species in accordance with Schedule 1 of Ordinance No. 8 of 1969.</b>	1 <sup>st</sup> January 2009 to 31 <sup>st</sup> December 2009
Blesbok, Steenbok, Common Duiker, Blue Wildebeest, Bushbuck, Nyala, Gemsbuck, Giraffe, Red Hartebeest, Impala, Burchell Zebra, Waterbuck, African Buffalo, Warthog and Springbuck.  <b>All species not listed on proclamation are seen to be protected game.</b>	1 <sup>st</sup> April 2009 up to and including 30 <sup>th</sup> September 2009. 1 <sup>st</sup> January 2009 up to and including 31 <sup>st</sup> December 2009 if farm has been issued with an adequate fencing certificate in terms of section 2(2)(a) of the Game Theft Act, 1991 (Act No. 105 of 1991) or is a declared Private Nature Reserve.

## PROKLAMASIE

### JAGSEISOEN: 2009

Kragtens die bevoegdheid aan my verleen volgens artikel 4 van die Ordonnansie op Natuurbewaring 1969 (Ordinansie No. 8 van 1969), verklaar ek, MA Dukwana, Lid van die Uitvoerende Raad verantwoordelik vir Toerisme, Omgewing- en Ekonomiese Sake in die Provincie, hiermee dat enige persoon gewone wild as volg mag jag/vang:

<b>Soort gewone wild soos gelys in Bylae 2</b>	<b>Tydperk wanneer gejag mag word en jagbuit beperkings vir grond- en watervoëls</b>
Gewone Tarentaal, Bosveldfisant, Bergpatrys, Kalaharipatrys en Afrikaanse Kwartel (Gewone kwartel).  Kolgans, Wildemakou, Geelbekeend, Rooibekende.	1 <sup>ste</sup> Mei 2009 tot en met 31 Augustus 2009.  'n Maksimum van tien (10) grond-jagvoëls, en tien (10) watervoëls per jagter per dag (met inbegrip van voëls wat gewond is en daardie wat nie opgespoor word nie). Alle gewone wildevoëls, behalwe Gewone Kwartels, kan gejag word wanneer hulle deel uitmaak van 'n groep van drie of meer (pare of enkel voëls kan dalk besig wees om te broei). Gewone Kwartels kan gejag word ongeag die getalle wat opgespoor word.
Kransduif (Bosduif), Gewone Tortelduif, Rooiborsduif en Bleshoender.	1 Januarie 2009 tot en met 31 Desember 2009
<b>Voëls nie hierbo genoem, is gelys as beskermde spesies volgens Bylae 1 van Ordinansie No 8 van 1969.</b>	
Blesbok, Steenbok, Duiker, Blouwildebees, Bosbok, Nyala, Gemsbok, Kameelperd, Rooihartebeest, Rooibok, Burchell Sebra, Waterbok, Afrika Buffel, Vlakvark en Springbok.  <b>Alle spesies nie gelys in proklamasie, is beskermde wild.</b>	1 <sup>ste</sup> April 2009 tot en met 30 <sup>ste</sup> September 2009. 1 <sup>ste</sup> Januarie 2009 tot en met 31 <sup>ste</sup> Desember 2009 as die plaas geregistreer is met 'n sertifikaat van voldoende omheining volgens artikel 2(2)(a) van die Wet op Wilddiefstal, 1991 (Wet No. 105 of 1991) of 'n verklaarde Private Natuurreservaat.

**Klipspringer, **Mountain Reedbuck, **Kudu, **Eland and **Grey Rhebuck.	1 <sup>st</sup> January 2009 up to and including 31 <sup>st</sup> December 2009. Animals may only be hunted on farms that have valid certificates of adequate fencing in terms of section 2(2)(a) of the Game Theft Act, 1991 (Act No. 105 of 1991) or a declared Private Nature Reserve.
Cape Hare and Scrub Hare.	1 <sup>st</sup> April 2009 up to and including 30 <sup>th</sup> September 2009. Cape Hare and Scrub Hare will have a joint bag limit of three (3) hares per hunter per day.
**Klipspringer, **Kudu, **Mountain Reedbuck, **Grey Rhebuck, **Common Duiker, **Steenbok, Cape Hare and Scrub Hare.	May not be hunted at night as per Ordinance No. 8 of 1969.
**Black Wildebeest, ##Bontebok, **Hartman Zebra, **Roan, **Tsessebe and **Common Reedbuck. <b>All species not listed on proclamation are seen to be protected game.</b>	In terms of the National Biodiversity Act, 2004 (Act No. 10 of 2004) Threatened or Protected Species Regulations, permits are required to hunt these species.
Capturing of all game species.	1 <sup>st</sup> March 2009 to the 31 <sup>st</sup> October 2009 as per capturing guidelines and regulations. ** Means capturing may only take place on farms that have valid certificates of adequate fencing in terms of section 2(2)(a) of the Game Theft Act, 1991 (Act No. 105 of 1991) or are declared as Private Nature Reserves. Species not marked with ** may be captured on any land. ## Means only herds registered by this Department may be captured and traded. No new Bontebok farms will be registered by this Department.
Culling of game	1 <sup>st</sup> April 2009 up to and including 30 <sup>th</sup> September 2009. <b>Certificates of adequate fencing in terms of section 2(2)(a) of the Game Theft Act, 1991 (Act No. 105 of 1991), does not exempt farm from hunting season.</b>

Diere mag slegs gejag word op plase wat geregistreer is met 'n sertifikaat van voldoende omheining volgens artikel 2(2)(a) van die Wet op Wilddiefstal, 1991 (Wet No. 105 of 1991) of as 'n verklaarde Private Natuurreervaat.
Vlakhaas and Kolhaas.	1 <sup>ste</sup> April 2009 tot en met 30 <sup>ste</sup> September 2009. 'n Getal van 3 Vlakhase en 3 Kolhase per jagter per dag word toegelaat.
**Klipspringer, **Koedoe, **Rooirabbok, **Vaalrabbok, **Grys Duiker, **Steenbok, Vlakhaas en Kolhaas.	Geen jag gedurende nag toegelaat volgens Ordinansie No. 8 of 1969.
**Swartwildebees, ##Bontebok, **Hartman Sebra, **Bastergemsbok, **Tsessebe en **Rietbok. <b>Alle spesies nie gelys in proklamasie, is beskermde wild.</b>	Volgens die Biodiversiteit Wet, 2004 (Wet No. 10 van 2004, Bedreigde of Beskermde Spesies Regulasies), word permitte vereis vir die jag van hierdie spesies.
Vang van alle wildsoorte.	1 <sup>ste</sup> Maart 2009 tot en met die 31 <sup>ste</sup> Oktober 2009 volgens translokasie riglyne en regulasies. ** Vangste mag slegs plaasvind op plase wat geregistreer is met 'n sertifikaat van voldoende omheining volgens artikel 2(2)(a) van die Wet op Wilddiefstal, 1991 (Wet No. 105 of 1991) of as 'n verklaarde Private Natuurreervaat . Spesies nie gemerk met ** mag op enige plaas gevang word. ## Slegs kuddes wat deur die Departement geregistreer is, mag gevang en verhandel word. Geen nuwe Bontebok plase sal deur die Departement geregistreer word nie.
Uitdunning van wild (Oesspanne)	1 <sup>ste</sup> April 2009 tot en met 30 <sup>ste</sup> September 2009. <b>Sertifikaat van voldoende omheining volgens artikel 2(2)(a) van die Wet op Wilddiefstal, 1991 (Wet No. 105 of 1991) stel plaas nie vry van jagseisoen.</b>
