Hospital Board is established in terms of the Free State Hospital Health Act, (No 13 of 1996) to advise the responsible Member of the Executive Council for Health (MEC), the Head of department and the Chief Executive Officer of the provincial hospital with regard to the control and management of such hospital and to represent community needs and priorities in the Hospital.

(Detailed functions of the Hospital Board are set out in section 12 of the Free State Hospital Act 13 of 1996)

REQUIREMENTS

In order to be considered for appointment, nominees must meet one or more of the following criteria:

Nominee should have proven experience or applicable knowledge of matters connected with the functions of the Hospital board and of whom have expertise in one or more of the following:

The nominated candidate should be a South African citizen aged 21 years or older, and a resident within the catchment area of the Hospital where the vacancies have arisen.
