No. 23 (Premier's), 1994

LOCAL GOVERNMENT TRANSITION ACT, 1993  
(ACT No. 209 OF 1993)

#### TRANSITIONAL LOCAL COUNCIL OF GREATER GERMISTON

Under section 10 of the Local Government Transition Act, 1993 (Act No. 209 of 1993), I hereby, with the concurrence of the Provincial Committee, make the enactments in the Schedule.

#### SCHEDULE

##### Establishment of Transitional Local Council

1. A transitional local council, hereunder called the Transitional Local Council of Greater Germiston, is hereby established as contemplated in section 7 (1) (b) (i) of the Local Government Transition Act, 1993 (Act No. 209 of 1993), with effect from the date upon which this Proclamation shall come into operation (hereunder

#### BYLAE

##### Instelling van Plaaslike Oorgangsraad

1. 'n Plaaslike oorgangsraad, hieronder die Plaaslike Oorgangsraad van Groter Germiston genoem, word hierby, soos beoog in artikel 7 (1) (b) (i) van die Oorgangswet op Plaaslike Regering, 1993 (Wet No. 209 van 1993), vanaf die datum van inwerkingtreding van hierdie Proklamasie (hieronder die

called the effective date), comprising the City Council of Germiston, the City Council of Katlehong, the Town Council of Bedfordview, the Management Committee of Palm Ridge, the area of Zonkezizwe and Portions 24 and 28 of the farm Tamboekiesfontein 173 IR, which Transitional Local Council of Greater Germiston shall be deemed to be a local authority in terms of the Local Government Ordinance, 1993 (Ordinance No. 17 of 1939).

#### **Dissolution of local government bodies**

**2.** (1) The City Council of Germiston, the Town Council of Katlehong, the Town Council of Bedfordview, and the Management Committee of Palm Ridge are hereby dissolved on the effective date.

(2) Administrator's Notice No. 547 of 6 December 1993 is as from the effective date withdrawn under section 13 (6) (a) of the Local Government Transition Act, 1993, in so far as it applies to the area of Zonkezizwe.

(3) Administrator's Proclamation No. 3 of 1993, as amended or extended, is withdrawn on the effective date.

#### **Area of Transitional Local Council of Greater Germiston**

**3.** The area of the Transitional Local Council of Greater Germiston comprises the existing jurisdiction of the dissolved City Council of Germiston as defined in Administrator's Proclamation No. 86 of 11 June 1994 as amended or extended, including the area of the former Town Council of Elsburg as defined in Administrator's Proclamation No. 18 of 23 February 1938 as amended or extended, and also including the area of the dissolved Management Committee of Palm Ridge as defined in Administrator's Notice No. 421 of 11 March 1987, the dissolved City Council of Katlehong as defined in *Government Notice* No. 2039 of 16 September 1983 as amended or extended, the dissolved Town Council of Bedfordview as defined in Administrator's Proclamation No. 150 of 15 October 1941 as amended or extended, the area of Zonkezizwe being an area outside a local authority area as defined in Administrator's Notice No. 547 of 6 December 1993 and Portions 24 and 28 of the farm Tamboekiesfontein 173 IR.

#### **Councillors**

**4.** (1) The Transitional Local Council of Greater Germiston comprises 66 Councillors.

(2) The terms of office of the Councillors of the dissolved local government bodies mentioned in section 2 shall be terminated on the effective date.

#### **Ontbinding van plaaslike overheidsliggome**

**2.** (1) Die Stadsraad van Germiston, die Stadsraad van Katlehong, die Stadsraad van Bedfordview en die Bestuurskomitee van Palm Ridge word hierby op die effektiewe datum ontbind.

(2) Administrateurskennisgewing No. 547 van 6 Desember 1993 word vanaf die effektiewe datum kragtens artikel 13 (6) (a) van die Oorgangswet op Plaaslike Regering, 1993, teruggetrek in soverre dit van toepassing is op die gebied van Zonkezizwe.

(3) Administrateursproklamasie No. 3 van 1993, soos gewysig of uitgebrei, word op die effektiewe datum teruggetrek.

#### **Gebied van Plaaslike Oorgangsraad van Groter Germiston**

**3.** Die gebied van die Plaaslike Oorgangsraad van Groter Germiston bestaan uit die bestaande regsgebied van die ontbinde Stadsraad van Germiston soos omskryf in Administrateursproklamasie No. 86 van 11 Junie 1941 soos gewysig of uitgebrei, insluitend die gebied van die voormalige Dorpsraad van Elsburg soos omskryf in Administrateursproklamasie No. 18 van 23 Februarie 1938 soos gewysig of uitgebrei en ook insluitend die gebied van die ontbinde Bestuurskomitee van Palm Ridge soos omskryf in Administrateurskennisgewing No. 421 van 11 Maart 1987, die ontbinde Stadsraad van Katlehong soos omskryf in Goewermentskennisgewing No. 2039 van 16 Desember 1983 soos gewysig of uitgebrei, die ontbinde Stadsraad van Bedfordview soos omskryf in Administrateursproklamasie No. 150 van 15 Oktober 1941 soos gewysig of uitgebrei, die gebied van Zonkezizwe synde 'n gebied buite 'n plaaslike bestuursgebied soos omskryf in Administrateurskennisgewing No. 547 van 6 Desember 1993 en Gedeeltes 24 en 28 van die plaas Tamboekiesfontein 173 IR.

#### **Raadslede**

**4.** (1) Die Plaaslike Oorgangsraad van Groter Germiston bestaan uit 66 Raadslede.

(2) Die ampstermyne van die Raadslede van die ontbinde plaaslike overheidsliggome in artikel 2 vermeld, word op die effektiewe datum beëindig.

(3) The persons mentioned in Annexure A, and duly nominated in terms of paragraph 5 of Schedule 1 to the Local Government Transition Act, 1993, are hereby appointed as Councillors of the Transitional Local Council of Greater Germiston.

(4) Any casual vacancy arising on the Transitional Local Council of Greater Germiston after the effective date shall be reported to the member for Housing and Local Government of the Provincial Executive Council within thirty (30) days, which vacancy shall, notwithstanding the provisions of sections 20 and 36 of the Municipal Elections Ordinance, 1970 (Ordinance No. 16 of 1970) be filled by the competent authority from the list of additional candidates in order of preference as contemplated in paragraph 5 of Schedule 1 to the Local Government Transition Act, 1993, as contained in Annexure B.

#### **Chairperson and Vice-Chairperson**

5. (1) The Transitional Local Council of Greater Germiston shall, in the manner prescribed for the election of a mayor and deputy mayor in sections 16 and 17 respectively of the Local Government Ordinance, 1939, elect as soon as possible by a two thirds majority as from the effective date, at a special meeting of the Council, a Chairperson and Vice-Chairperson from the Councillors mentioned in section 4 (3): Provided that if the Chairperson is from the statutory component the Vice-Chairperson shall be from the non-statutory component and vice versa.

(2) The Council may, notwithstanding the provisions of section 17 of the Local Government Ordinance, 1939, within three months as from the effective date elect a second Vice-Chairperson for the Council.

(3) The Chairperson, Vice-Chairperson and the second Vice-Chairperson contemplated in subsection (2) shall perform all the functions and duties of a mayor and deputy mayors as contemplated in any law applicable to local authorities.

#### **Allowances of Councillors, Chairperson and Vice-Chairperson**

6. (1) All the Councillors shall, as from the effective date, receive the same allowances as the allowances paid to the Councillors of the dissolved City Council of Germiston.

(2) The Chairperson and the Vice-Chairpersons shall, as from the effective date, receive the same allowances as the allowances paid to the Mayor and Deputy Mayor of the dissolved City Council of Germiston.

#### **Executive Committee**

7. (1) The Transitional Local Council of Greater Germiston shall, notwithstanding the provisions of the Local Government (Administration and Elections) Ordinance, 1960 (Ordinance No. 40 of 1960), under section 16 (6) of the Local Government Transitional Act, 1993, elect from its members an Executive Committee.

(3) Die persone in Aanhangel A vermeld, wat behoorlik kragtens paragraaf 5 van Bylae 1 by die Oorgangswet op Plaaslike Regering, 1993, benoem is, word hierby as Raadslede van die Plaaslike Oorgangsraad van Groter Germiston aangestel.

(4) Enige toevallige vakature wat na die effektiewe datum op die Plaaslike Oorgangsraad van Groter Germiston ontstaan, moet binne dertig (30) dae aan die Lid vir Behuisig en Plaaslike Regering van die Proviniale Uitvoerende Raad gerapporteer word, welke vakture, ondanks die bepalings van artikel 20 en 36 van die Ordonnansie op Municipale Verkiesings, 1970 (Ordonnansie No. 16 van 1970), deur die bevoegde gesag gevul word uit die lys van bykomende kandidate in orde van voorkeur soos beoog in paragraaf 5 van Bylae 1 by die Oorgangswet op Plaaslike Regering, 1993, in Aanhangel B vervat.

#### **Voorsitter en Visevoorsitter**

5. (1) Die Plaaslike Oorgangsraad van Groter Germiston verkie, so spoedig moontlik na die effektiewe datum op 'n spesiale vergadering van die Raad met 'n tweederdemeerdeerdheid, 'n Voorsitter en 'n Ondervoorsitter uit die Raadslede in artikel 4 (3) vermeld op die wyse voorgeskryf vir die verkiesing van 'n Burgemeester en 'n Onderburgemeester by artikels 16 en 17 onderskeidelik van die Ordonnansie op Plaaslike Bestuur, 1939: Met dien verstande dat as die Voorsitter uit die statutêre komponent afkomstig is, die Vise-voorsitter uit die nie-statutêre komponent afkomstig moet wees en vice versa.

(2) Die Raad kan, ondanks die bepalings van artikel 17 van die Ordonnansie op Plaaslike Bestuur, 1939, binne drie maande vanaf die effektiewe datum, 'n tweede Visevoorsitter vir die Raad verkies.

(3) Die Voorsitter, Visevoorsitter en die tweede Visevoorsitter beoog in subartikel (2) voer al die funksies en pligte van 'n burgemeester en onderburgemeesters soos beoog in enige wet van toepassing op plaaslike owerhede, uit.

#### **Toelaes van Raadslede, Voorsitter en Visevoorsitter**

6. (1) Al die Raadslede ontvang vanaf die effektiewe datum dieselfde toelaes as wat aan die Raadslede van die ontbinde Stadsraad van Germiston betaal is.

(2) Die Voorsitter en Visevoorsitters ontvang vanaf die effektiewe datum dieselfde toelaes as wat aan die Burgemeester en Onderburgemeester van die ontbinde Stadsraad van Germiston betaal is.

#### **Uitvoerende Komitee**

7. (1) Die Plaaslike Oorgangsraad van Groter Germiston verkie, ondanks die bepalings van die Ordonnansie op Plaaslike Bestuur (Administrasie en Verkiesings), 1960 (Ordonnansie No. 40 van 1960), kragtens artikel 16 (6) van die Oorgangswet op Plaaslike Regering, 1993, uit sy lede 'n Uitvoerende Komitee.

(2) The Council shall elect one member of the Executive Committee as Chairperson and one member as Vice-Chairperson of the Executive Committee: Provided that if the Chairperson is from the statutory component the Vice-Chairperson shall be from the non-statutory component and *vice versa*.

(3) The provisions of sections 1 and 53 to 61 of the Local Government (Administration and Elections) Ordinance, 1960, shall, when exercising the provisions of this Proclamation, be applicable *mutatis mutandis* to the Executive Committee contemplated in subsection (1).

(4) In carrying out its functions, powers and duties the Executive Committee shall seek to achieve consensus, and should consensus not be achieved on any matter, such matter shall be decided by a majority of two thirds of the members of the Executive Committee, or if the majority of the Committee so decides, submit a report and recommendations on such matter to the Council for a decision.

#### **Transfer of assets, liabilities, rights, obligations and successor-in-law**

8. (1) All assets, liabilities, rights and obligations of the dissolved local government bodies mentioned in section 2 shall, after the effective date, be transferred to the Transitional Local Council of Greater Germiston.

(2) The Transitional Local Council of Greater Germiston shall as from the effective date for the purposes of this Proclamation be the successor-in-law of the dissolved local government bodies mentioned in section 2.

#### **By-laws, regulations, resolutions, prescribed notices and delegations**

9. (1) Subject to the provisions of this Proclamation, all by-laws, regulations, resolutions, prescribed notices and delegations of the dissolved local government bodies mentioned in section 2 which immediately before the effective date were in force in any area of the said dissolved local government bodies, shall remain in force in such area, subject to any repeal or amendment of such by-laws, regulations, resolutions, prescribed notices and delegations by the Transitional Local Council of Greater Germiston: Provided that the Standard Standing Orders, Financial Standing Orders and Delegation of Powers to Committees and Officials as it was applicable immediately prior to the effective date within the area of the dissolved City Council of Germiston shall apply to the exclusion of any equivalent or conflicting provisions of any of the other local government bodies mentioned in section 2.

(2) The by-laws and regulations mentioned in Annexure C are hereby repealed on the effective date and the by-laws mentioned in Annexure D shall as from the effective date be regarded as by-laws of the Transitional Local Council of Greater Germiston.

(2) Die Raad verkies een lid van die Uitvoerende Komitee as Voorsitter en een lid as Visevoorsitter van die Uitvoerende Komitee: Met dien verstande dat as die Voorsitter uit die statutêre komponent afkomstig is, die Visevoorsitter uit die nie-statutêre komponent afkomstig moet wees en *vice versa*.

(3) Die bepalings van artikels 1 en 53 tot 61 van die Ordonnansie op Plaaslike Bestuur (Administrasie en Verkiesings), 1960, is by die toepassing van hierdie Proklamasie, *mutatis mutandis* op die Uitvoerende Komitee in subartikel (1) bedoel, van toepassing.

(4) In die uitvoering van sy funksies, bevoegdhede en pligte poog die Uitvoerende Komitee om konsensus te bereik en sou konsensus nie bereik word ten opsigte van enige aangeleentheid nie, word só 'n aangeleentheid deur 'n tweederde meerderheid van die lede van die Uitvoerende Komitee beslis, of sou die meerderheid van die Komitee so besluit, word 'n verslag en aanbevelings oor so 'n aangeleentheid aan die Raad voorgelê vir 'n beslissing.

#### **Oordra van bates, laste, regte, verpligtinge en regsopvolger**

8. (1) Alle bates, laste, regte en verpligtinge van die ontbinde plaaslike owerheidsliggame vermeld in artikel 2 word vanaf die effektiewe datum aan die Plaaslike Oorgangsraad van Groter Germiston oorgeda.

(2) Die Plaaslike Oorgangsraad van Groter Germiston word vir die doeleindes van hierdie Proklamasie vanaf die effektiewe datum dieregsopvolger van die plaaslike owerheidsliggame vermeld in artikel 2.

#### **Verordeninge, regulasies, besluite, voorgeskrewe kennisgewings en delegasies**

9. (1) Behoudens die bepalings van hierdie Proklamasie, bly alle verordeninge, regulasies, besluite, voorgeskrewe kennisgewings en delegasies van die ontbinde plaaslike owerheidsliggame vermeld in artikel 2 wat onmiddellik voor die effektiewe datum van krag was in enige gebied van genoemde plaaslike owerheidsliggame, van krag in so 'n gebied, onderhewig aan enige herroeping of wysiging van sulke verordeninge, regulasies, besluite, voorgeskrewe kennisgewings en delegasies deur die Plaaslike Oorgangsraad van Groter Germiston: Met dien verstande dat die Standaard Reglement van Orde, the Finansiële Reglement van Orde en die Delegasie van Bevoegdhede aan Komitees en Beampies soos dit onmiddellik voor die effektiewe datum binne die gebied van die ontbinde Stadsraad van Germiston van toepassing was, van krag bly tot uitsluiting van enige gelykwaardige of botsende bepalings van enige van die plaaslike owerheidsliggame vermeld in artikel 2.

(2) Die verordeninge en regulasies vermeld in Aanhengsel C word hierby op die effektiewe datum herroep en die verordeninge vermeld in Aanhengsel D word vanaf die effektiewe datum geag verordeninge van die Plaaslike Oorgangsraad van Groter Germiston te wees.

**Budget**

**10.** The 1994/95 budget of the local government bodies mentioned in section 2 shall, notwithstanding the provisions of section 58 of the Local Government Ordinance, 1939, be deemed to be the 1994/95 budget of the Transitional Local Council of Greater Germiston: Provided that the book entries for the 1994/95 financial year shall be handled separately by the Transitional Local Council of Greater Germiston until a single consolidated budget is approved.

**Representation on Regional Services Council**

**11.** (1) Representation of the dissolved local government bodies mentioned in section 2 before the effective date in terms of the Regional Services Councils Act, 1985 (Act No. 109 of 1985), on the East Rand Regional Services Council, shall be terminated on the effective date.

(2) The Transitional Local Council of Greater Germiston shall, as from the effective date, in terms of section 3 (1) of the Regional Services Councils Act, 1985, be represented on the East Rand Regional Services Council.

(3) The Council shall, until representatives have been appointed in terms of section 6 (2) of the Regional Services Councils Act, 1985, be represented on the East Rand Regional Services Council by the Chairperson and Deputy-Chairperson mentioned in section 5 (1).

**Authorized local authority**

**12.** (1) The Transitional Local Council of Greater Germiston shall, under section 2 of the Town-planning and Townships Ordinance, 1986 (Ordinance No. 15 of 1986), as from the effective date be an authorized local authority for the purposes of Chapters II, III and IV of the said Ordinance.

(2) The Transitional Local Council of Greater Germiston shall, under section 3 of the Division of Land Ordinance, 1986 (Ordinance No. 20 of 1986), as from the effective date be an authorized local authority for the purposes of Chapter IV of the said Ordinance.

**Local authority contemplated in Sixth Schedule to Local Government Ordinance, 1939**

**13.** The Transitional Local Council of Greater Germiston is hereby, as from the effective date, deemed to be a local authority as contemplated in Part I of the Sixth Schedule to the Local Government Ordinance, 1993.

**Single Local Administration for Transitional Local Council of Greater Germiston**

**14.** (1) A Single Local Administration is hereby established for the Transitional Local Council of Greater Germiston.

**Begroting**

**10.** Die 1994/95 begroting van die plaaslike owerheidsliggame vermeld in artikel 2 word, ondanks die bepalings van artikel 58 van die Ordonnansie op Plaaslike Bestuur, 1939, geag die 1994/95 begroting van die Plaaslike Oorgangsraad van Groter Germiston te wees: Met dien verstande dat die boekinskrywings vir die 1994/95 finansiële jaar afsonderlik deur die Plaaslike Oorgangsraad van Groter Germiston hanteer word totdat 'n enkele gekonsolideerde begroting goedgekeur is.

**Verteenwoordiging op Streeksdiensteraad**

**11.** (1) Verteenwoordiging wat die ontbinde plaaslike owerheidsliggame vermeld in artikel 2 kragtens die Wet op Streeksdiensterade, 1985 (Wet No. 109 van 1985), voor die effektiewe datum op die Oos-Rand Streeksdiensteraad gehad het, word op die effektiewe datum beëindig.

(2) Die Plaaslike Oorgangsraad van Groter Germiston word vanaf die effektiewe datum kragtens artikel 3 (1) van die Wet op Streeksdiensterade, 1985, op die Oos-Rand Streeksdiensteraad verteenwoordig.

(3) Die Plaaslike Oorgangsraad van Groter Germiston word, totdat verteenwoordigers kragtens artikel 6 (2) van die Wet op Streeksdiensterade, 1985, aangestel is, deur die Voorsitter en Ondervoorsitter vermeld in artikel 5 (1), op die Oos-Rand Streeksdiensteraad verteenwoordig.

**Gemagtigde plaaslike bestuur**

**12.** (1) Die Plaaslike Oorgangsraad van Groter Germiston word, kragtens artikel 2 van die Ordonnansie op Dorpsbeplanning en Dorpe, 1986 (Ordonnansie No. 15 van 1986), vanaf die effektiewe datum 'n gemagtigde plaaslike bestuur vir doeleindes van Hoofstukke II, III en IV van genoemde Ordonnansie.

(2) Die Plaaslike Oorgangsraad van Groter Germiston word, kragtens artikel 3 van die Ordonnansie op die Verdeling van Grond, 1986 (Ordonnansie No. 20 van 1986), vanaf die effektiewe datum 'n gemagtigde plaaslike bestuur vir doeleindes van Hoofstuk IV van genoemde Ordonnansie.

**Plaaslike bestuur in Sesde Bylae by Ordonnansie op Plaaslike Bestuur, 1939, bedoel**

**13.** Die Plaaslike Oorgangsraad van Groter Germiston word hierby, vanaf die effektiewe datum, geag 'n plaaslike bestuur soos bedoel in Deel I van die Sesde Bylae by die Ordonnansie op Plaaslike Bestuur, 1939, te wees.

**Enkele Plaaslike Administrasie vir Plaaslike Oorgangsraad van Groter Germiston**

**14.** (1) 'n Enkele Plaaslike Administrasie word hierby vir die Plaaslike Oorgangsraad van Groter Germiston ingestel.

(2) A permanent organisational structure for the Single Local Administration shall be constituted by the Transitional Local Council of Greater Germiston as soon as possible after the effective date.

**Chief Executive Officer/Town Clerk and Deputy Chief Executive Officer/Deputy Town Clerk**

**15.** (1) The Town Clerk of the dissolved City Council of Germiston shall for the purposes of this Proclamation, and subject to the provisions of the Remuneration of Town Clerks Act, 1984 (Act No 115 of 1984), and the Profession of Town Clerks Act, 1988 (Act No. 75 of 1988), be deemed to be the acting Chief Executive Officer/Town Clerk of the Transitional Local Council of Greater Germiston as contemplated in section 62 of the Local Government Ordinance, 1939.

(2) The Chief Executive Officer/Town Clerk shall, for the purposes of this Proclamation perform all the functions, powers and duties assigned to a Town Clerk in terms of the Local Government Ordinance, 1939, the Local Government (Administration and Elections) Ordinance, 1960, the Municipal Elections Ordinance, 1970, or any other law, by-law or resolution of the dissolved local government bodies mentioned in section 2.

(3) Notwithstanding the provisions of the Local Government Ordinance, 1939, two temporary positions of Deputy Chief Executive Officer/Deputy Town Clerk are hereby created with a remuneration package equal to level 3a of the salary structure of a grade 12 local authority, of which one post shall be filled by the Town Clerk of the dissolved Town Council of Bedfordview and one post by a person nominated by the non-statutory component: Provided that when his appointment to the new personnel structure is finalised pursuant to section 14 (2), the remuneration received by the Town Clerk of the dissolved Town Council of Bedfordview for acting in this position shall be disregarded.

**Employees and officers of Transitional Local Council of Greater Germiston**

**16.** (1) After a permanent organisational structure as contemplated in section 14 (2) has been constituted, all employees and officers in the service of the dissolved local government bodies mentioned in section 2 and the employees and officers employed by the Transitional Local Council of Greater Germiston prior to the constitution of such permanent organisational structure, shall be transferred to the Single Local Administration contemplated in section 14 (1) in accordance with the provisions of section 10 (3) (f) (i) and (j) of the Local Government Transition Act, 1993.

(2) Until the employees and officers contemplated in subsection (1) have been transferred to the Single Local Administration, the employees and officers concerned shall, for the purposes of this Proclamation, be deemed to be in the service of the Single Local Administration.

(2) 'n Permanente Organisatoriese Struktuur vir die Enkele Plaaslike Administrasie moet so spoedig moontlik na die effektiewe datum deur die Plaaslike Oorgangsraad van Groter Germiston saamgestel word.

##### Establishment of Transitional Metropolitan Substructures

Where the railway line crosses Jules Street the boundary goes west until it reaches the Highway intersection. It goes south along the Highway and then along Heidelberg Road until it crosses Turffontein Road. It goes south along Turffontein Road and then west along Eastwood Street. At Heronmere Road the boundary goes north and then follows Long Street until it gets to Booysens Road. At Booysens Road it goes west and follows the Soweto Highway until Barangwanath Road where it goes north. At Main Reef Road, south of Paarlshoop, the boundary goes east until Church Street where it goes north. The boundary then follows the southern township boundaries of Mayfair and Fordsburg. The boundary follows the eastern boundary of Fordsburg and includes Burgersdorp. At the railway line it goes north,

(d) the North-Eastern Metropolitan Substructure: The north and east boundaries are the outer Greater Johannesburg Transitional Metropolitan Council's boundary. The western boundary runs along Jan Smuts Avenue until Republic Road where it goes east until the William Nichol. It follows the William Nichol until it intersects with the old Sandton boundary, which it follows until the Greater Johannesburg Transitional Metropolitan Council's Boundary. All of these roads are included into the North-Eastern Area. The southern boundary runs from west to east, along Empire Road until Clarendon Place. It goes south along Clarendon Place and then along King George Street. It runs east along Essel Street for one block and then goes south down Klein Street. At Joubert Park it goes east along Wolmarans Street and then south along Twist Street which becomes Troye Street. At Commissioner Street it goes east until the railway line. The boundary then follows the railway line (the railway line being excluded from the boundary) until it reaches the Greater Johannesburg Transitional Metropolitan Council's boundary;

(e) the South-East Metropolitan Substructure: The northern boundary from east to west runs along the railway line, including the railway line. Where the railway line crosses Jules Street the boundary goes west until it reaches the Highway intersection. It goes south along the Highway and then along Heidelberg Road until it crosses Turffontein Road. It goes south along Turffontein Road and then west along Eastwood Street. At Heronmere Road the boundary goes north and then follows Long Street until it gets to Booysens Road. At Booysens Road it goes west and follows the Soweto Highway until Baragwanath Road where it goes south until it intersects with the Golden Highway. The boundary follows the Golden Highway South until it intersects with the N1 Highway and then it runs along the N1 Highway until it reaches the Greater Johannesburg Transitional Metropolitan Council's southern boundary. Baragwanath Road, the Golden Highway and the N1 are excluded from this Metropolitan Substructure. The southern and eastern boundaries are the Greater Johannesburg Transitional Metropolitan Council's boundary;

(f) the South-West Metropolitan Substructure: The southern and western boundaries follow the Greater Johannesburg Transitional Metropolitan Council's boundary. The eastern boundary runs along and includes the N1 Highway from its intersection with the Golden Highway. The northern boundary runs west, from the intersection, excluding Devland until it intersects with the old Soweto boundary. It runs along the old

(f) die Suid-Wes Metropolitaanse Substruktur: Die suidgrens en die wesgrens volg die Groter Johannesburg Metropolitaanse Oorgangsraad-grens. Die oosgrens volg die N1-hoofweg en sluit dié pad in vanaf sy kruising met die Goue Hoofweg. Die noordgrens strek weswaarts vanaf die kruising, met die uitsluiting van Devland, tot by die kruising met die ou Soweto-

(g) the Western Metropolitan Substructure: The northern boundary of this Metropolitan Substructure follows the old Soweto boundaries, excluding Dobsonville and including Diepmeadow and Meadowlands. When it intersects with the southern boundary of Riverlea Extension 1 it follows the township boundary until it gets to Baragwanath Road where it goes south until it intersects with the Golden Highway. Baragwanath Road and the Golden Highway are included into the Western Metropolitan Substructure. At the intersection with the N1 Highway the boundary goes west including Devland until it intersects with the old Soweto boundary. It runs along the old southern boundary of Soweto until it intersects with the R29 (Moroka Bypass), which it then follows until it intersects the Greater Johannesburg Transitional Metropolitan Council's boundary. The section of the R29 is included into the Western Metropolitan Substructure,

which Transitional Metropolitan Substructures shall be deemed to be local authorities in terms of the Local Government Ordinance, 1939 (Ordinance No. 17 of 1939).

(2) A map reflecting the areas of jurisdiction of the Metropolitan Substructures, as described in subsection (1), is contained in Annexure A.

#### **Dissolution of local government bodies**

2. (1) The following local government bodies are hereby dissolved on the effective date:

- (a) The City Council of Johannesburg;
- (b) the City Council of Roodepoort;
- (c) the City Council of Soweto;
- (d) the City Council of Diepmeadow;
- (e) the City Council of Dobsonville;
- (f) the City Council of Alexandra;
- (g) the City Council of Randburg;
- (h) the City Council of Sandton;
- (i) the Management Committee of Ennerdale;
- (j) the Management Committee of Lenasia South East;
- (k) the Management Committee of Lenasia;
- (l) the South-Western Management Committee; and
- (m) the Davidson/Fleurhof Management Committee.

- (c) die Stadsraad van Soweto;
- (d) die Stadsraad van Diepmeadow;
- (e) die Stadsraad van Dobsonville;
- (f) die Stadsraad van Alexandra;
- (g) die Stadsraad van Randburg;
- (h) die Stadsraad van Sandton;
- (i) die Bestuurskomitee van Ennerdale;
- (j) die Bestuurskomitee van Lenasia Suid-Oos;
- (k) die Bestuurskomitee van Lenasia;
- (l) die Suid-Westelike Bestuurskomitee; en
- (m) die Davidson/Fleurhof Bestuursomitee

(2) Administrator's Notices No. 310 of 6 July 1993, No. 546 of 6 December 1993, No. 633 of 27 November 1991 read with No. 311 of 6 July 1993, No. 32 of 3 February 1993 and No. 272 of 24 June 1992, are as from the effective date repealed under section 13 (6) (a) of the Local Government Transition Act, 1993, in so far as they apply to the areas of the townships known as Doornkop/West of Soweto, Finetown/Thembalihle (Lenasia Transit Area), Alexandra Far East Bank and Diepsloot/Nietgedacht, respectively.

#### **Absolvement of functions, powers and duties of Local Government Affairs Council**

3. (1) The Local Government Affairs Council shall, notwithstanding any provisions contained in the Local Government Affairs Council Act (House of Assembly), 1989 (Act No. 84 of 1989), and the Transvaal Board for the Development of Peri Urban Areas Ordinance, 1943 (Ordinance No. 20 of 1943), as from the effective date be absolved from exercising any of its functions, powers and duties in respect of the areas described in the Schedule to Administrator's Notice No. 314 of 14 July 1993 and in paragraphs 1 and 2 of the Schedule to Administrator's Notice No. 156 of 1 April 1993 as corrected in Administrator's Notice No. 88 of 9 March 1994.

(2) In the event of the apportionment of any assets, rights and liabilities, including the taking over by the Greater Johannesburg Transitional Metropolitan Council of any employees in respect of the areas mentioned in subsection (1) the provisions of section 159bis of the Local Government Ordinance, 1939, shall, subject to the provisions of sections 15 (1) (f), 16 and 25 (2) *mutatis mutandis* apply.

(3) The provisions of section 12 shall *mutatis mutandis* apply to the taking over of any employees mentioned in subsection (2).

(4) The Greater Johannesburg Transitional Metropolitan Council shall, subject to the provisions of section 15 (1) (f) for the purposes of this Proclamation as from the effective date be deemed to be the successor-in-law of the Local Government Affairs Council relating to any power, duty, assets, obligation, right or liability within the areas described in subsection (1).

(5) Notwithstanding the provisions of section 159bis (2) of the Local Government Ordinance, 1939, all resolutions, by-laws, delegations and statutory notices of the Local Government Affairs Council pertaining to the areas described in subsection (1), shall as from the effective date be in force in the areas mentioned in subsection (1), until amended or repealed by the Greater Johannesburg Transitional Metropolitan Council.

#### **Functions, powers and duties**

4. (1) The functions, powers and duties of the Metropolitan Substructures shall be as follows:

(a) The responsibility for the implementation in their areas of the Reconstruction and Development Programme.

#### **Kwytkelding van funksies, bevoegdhede en pligte van Raad op Plaaslike Bestuursaangeleenthede**

3. (1) Die Raad op Plaaslike Bestuursaangeleenthede word, ondanks enige bepalings vervat in die Wet op die Raad op Plaaslike Bestuursaangeleenthede (Volksraad), 1989 (Wet No. 84 van 1989), en die Ordonnansie op die Transvaalse Raad vir die Ontwikkeling van Buitestadelike Gebiede, 1943 (Ordonnansie No. 20 van 1943), vanaf die effektiewe datum kwytkelding van die uitvoering van enige van sy funksies, bevoegdhede en pligte ten opsigte van die gebiede beskryf in die Bylae by Administrateurskennisgiving No. 314 van 14 Julie 1993 en in paragraue 1 en 2 van die Bylae by Administrateurskennisgiving No. 156 van 1 April 1993 soos verbeter by Administrateurskennisgiving No. 88 van 9 Maart 1994.

(2) In die geval van 'n verdeling van enige bates, regte en verpligte, insluitend die oorname deur die Groter Johannesburg Metropolitaanse Oorgangsaad van enige werknemers ten opsigte van die gebiede vermeld in subartikel (1) sal die bepalings van artikel 159bis van die Ordonnansie op Plaaslike Bestuur, 1939, behoudens die bepalings van artikels 15 (1) (f), 16 en 25 (2) *mutatis mutandis* van toepassing wees.

(3) Die bepalings van artikel 12 is *mutatis mutandis* van toepassing op die oorname van enige werknemers vermeld in subartikel (2).

(4) Die Groter Johannesburg Metropolitaanse Oorgangsaad word by die toepassing van hierdie Proklamasie, behoudens die bepalings van artikel 15 (1) (f), vanaf die effektiewe datum geag dieregsopvolger van die Raad op Plaaslike Bestuursaangeleenthede betreffende enige bevoegdheid, pligte, bate, verpligting, reg of las binne die gebiede beskryf in subartikel (1) te wees.

(5) Ondanks die bepalings van artikel 159bis (2) van die Ordonnansie op Plaaslike Bestuur, 1939, is alle besluite, verordeninge, delegasies en statutêre kennisgewings van die Raad op Plaaslike Bestuursaangeleenthede wat betrekking het op die gebiede beskryf in subartikel (1), vanaf die effektiewe datum van krag in die gebiede vermeld in subartikel (1) totdat dit deur die Groter Johannesburg Metropolitaanse Oorgangsaad gewysig of herroep word.

#### **Funksies bevoegdhede en pligte**

4. (1) Die funksies, bevoeghede en pligte van die Sentraal Witwatersrand Metropolitaanse Substrukture is soos volg:

(a) Verantwoordelikheid vir die implementering van die Heropbou en Ontwikkelingsoprogram in hulle gebiede.

- (b) The performance of certain metropolitan functions as delegated or allocated under section 16.
  - (c) The performance of functions of or with other Metropolitan Substructures as agreed upon on an appropriate basis.
  - (d) To ensure maximum direct participation in government at grassroots level in respect of planning, decisions and service delivery.
  - (e) Such residual local government powers and duties as may be allocated, as contemplated in section 16.
  - (f) The general powers necessary to function as decision making bodies and to exercise the functions, powers and duties conferred by or under this Proclamation.
- (2) The functions, powers and duties mentioned in subsection (2) shall, subject to section 16, be exercised initially by the Greater Johannesburg Transitional Metropolitan Council.

#### Councillors and designated persons

5. (1) The Central Business District Metropolitan Substructure comprises 100 Councillors, the North-Western Metropolitan Substructure comprises 42 Councillors, the Northern Metropolitan Substructure comprises 26 Councillors, the North-Eastern Metropolitan Substructure comprises 42 Councillors, the South-East Metropolitan Substructure comprises 24 Councillors, the South-West Metropolitan Substructure comprises 28 Councillors and the Western Metropolitan Substructure comprises 78 Councillors: Provided that the 100 persons nominated as Councillors for the Greater Johannesburg Transitional Council established in section 12 shall act as Councillors of the Central Business District Metropolitan Substructure.

(2) The terms of office of the Councillors of the dissolved local government bodies referred to in section 2 shall be determined on the effective date.

(3) The designation as administrator of the City Council of Soweto and Diepmeadow under Premier's Proclamation No. 14 of 5 October 1994 of persons to exercise, perform or fulfill all the rights, powers, functions, duties and obligations assigned to the said dissolved local government bodies is hereby as from the effective date repealed.

(4) The persons mentioned in Annexures B, C, D, E, F, G and H and duly nominated under paragraph 5 of Schedule 1 to the Local Government Transition Act, 1993, are hereby as from the effective date appointed as Councillors of the Central Business District, the North-Western, the Northern, the North-Eastern, the South-East, the South-West and the Western Metropolitan Substructures, respectively.

- (b) Uitvoering van sekere metropolitaanse funksies soos goedgekeur of opgedra kragtens artikel 16.
- (c) Uitvoering van funksies van of met ander Metropolitaanse Substrukture soos ooreengekom, op 'n doelmatige grondslag.
- (d) Verseker maksimum direkte deelname in regering op grondvlak betreffende beplanning, besluite en dienslewering.
- (e) Sodanige residuale plaaslike regeringsbevoegdhede en pligte as wat opgedra mag word, soos beoog in artikel 16.
- (f) Die algemene bevoegdhede nodig om as besluitnemende liggeme te funksioneer en om die funksies, bevoegdhede en pligte uit te oefen wat deur kragtens hierdie Proklamasie toege wys word.

(2) Die funksies, bevoegdhede en die pligte in subartikel (1) vermeld word, behoudens artikel 16, aanvanklik deur die Grobler Johannesburg Metropolitaanse Oorgangsraad uitgeoefen.

#### Raadslede en aangewese persone

5. (1) Die Sentraal Besigheid Distrik Metropolitaanse Substruktuur bestaan uit 100 Raadslede, die Noordwestelike Metropolitaanse Substruktuur bestaan uit 42 Raadslede, die Noordelike Metropolitaanse Substruktuur bestaan uit 26 Raadslede, die Noordoostelike Metropolitaanse Substruktuur bestaan uit 42 Raadslede, die Suid-Oos Metropolitaanse Substruktuur bestaan uit 24 Raadslede, die Suid-Wes Metropolitaanse Substruktuur bestaan uit 28 Raadslede en die Westelike Metropolitaanse Substruktuur bestaan uit 78 Raadslede: Met dien verstande dat die 100 persone genomineer as Raadslede van die Groter Johannesburg Metropolitaanse Oorgangsraad ingestel by artikel 12 optree as Raadslede van die Sentraal Besigheid Distrik Metropolitaanse Substruktuur.

(2) Die ampstermyne van die Raadslede van die ontbinde plaaslike owerheidsliggame in artikel 2 vermeld, word op die effektiewe datum beëindig.

(3) Die aanwysiging as administrator van die Stadsrade van Soweto en Diepmeadow kragtens Premiersproklamasie No. 14 van 5 Oktober 1994 van persone om al die regte, bevoegdhede, werksaamhede, pligte en verpligtinge wat aan die gemelde ontbinde plaaslike owerheidsliggame opgedra is, uit te oefen, te verrig of na te kom, word hierby vanaf die effektiewe datum herroep.

(4) Die persone in Aanhangsels B, C, D, E, F, G en H vermeld, wat behoorlik kragtens paragraaf 5 van Bylae 1 by die Oorgangswet op Plaaslike Regering, 1993, benoem is, word hierby as Raadslede van onderskeidelik die Sentraal Besigheid Distrik, die Noordwestelike, die Noordelike die Noordoostelike, die Suid-Oos, die Suid-Wes, en die Westelike Metropolitaanse Substrukture aangestel.

(5) Any casual vacancy arising on any of the Metropolitan Substructures after the effective date shall be reported to the Member for Housing and Local Government of the Provincial Executive Council within 30 days, which vacancy shall, notwithstanding the provisions of sections 20 and 36 of the Municipal Elections Ordinance, 1970 (Ordinance No. 16 of 1970), be filled by the competent authority from the list of additional candidates in order of preference as contemplated in paragraph 5 of Schedule 1 to the Local Government Transition Act, 1993, as contained in Annexures I, J, K, L, M, N and O, respectively.

#### **Chairpersons and Deputy Chairpersons**

6. Each of the Central Business District, the North-Western, the Northern, the North-Eastern, the South-East, the South-West and the Western Metropolitan Substructures shall, within seven days after the effective date, at a special meeting of such Metropolitan Substructure, in the manner prescribed for the election of a mayor and a deputy mayor in section 16 of the Local Government Ordinance, 1939, elect a Chairperson and a Deputy Chairperson from the Councillors mentioned in section 5 (4).

#### **Executive Committee**

7. (1) The Central Business District, the North-Western, the Northern, the North-Eastern, the South-East, the South-West and the Western Metropolitan Substructures shall, at the special meeting contemplated in section 6, notwithstanding the provisions of the Local Government (Administration and Elections) Ordinance, 1960 (Ordinance No. 40 of 1960), under section 16 (6) of the Local Government Transition Act, 1993, each elect from its members an Executive Committee.

(2) The Metropolitan Substructures shall at the special meeting contemplated in section 6 each elect from the members of the Executive Committee a Chairperson and a Deputy Chairperson for the Executive Committee.

(3) The provisions of sections 1 and 55 to 61 of the Local Government (Administration and Elections) Ordinance, 1960, shall, for the purposes of this Proclamation, be applicable *mutatis mutandis* to the respective Executive Committees contemplated in subsection (1).

#### **Principles and procedure of meetings**

8. The provisions of sections 20, 21, 22, 23, 24, 26, 27, 31, 32 and 33 of the Local Government Ordinance, 1939, shall *mutatis mutandis* apply to the principles and procedure of meetings of the Metropolitan Substructures.

#### **Transfer of assets, liabilities, rights, obligations and legal succession (succesor-in-law)**

9. (1) All assets, liabilities, rights and obligations of the dissolved local government bodies mentioned in section 2 shall, subject to the provisions of section 16, as from the effective date, be transferred to the Greater Johannesburg Transitional Metropolitan Council.

(5) Enige toevallelike vakature wat na die effektiewe datum op enige van die Metropolitaanse Substrukture ontstaan moet binne 30 dae aan die Lid vir Behuising en Plaaslike Regering van die Proviniale Uitvoerende Raad gerapporteer word, welke vakture, ondanks die bepalings van artikels 20 en 36 van die Ordonnansie op Munisipale Verkiesings, 1970 (Ordonnansie No. 16 van 1970), deur die bevoegde gesag gevul moet word uit die lys van bykomende kandidate in orde van voorkeur soos beoog in paragraaf 5 van Bylae 1 by die Oorgangswet op Plaaslike Regering, 1993, in onderskeidelik Aanhangsels I, J, K, L, M, N en O vervat.

#### **Voorsitters en Ondervoorsitter**

6. Elkeen van die Sentraal Besigheid Distrik, die Noordwestelike, die Noordelike, die Noordoostelike, die Suid-Oos, die Suid-Wes en die Westelike Metropolitaanse Substrukture verkies, binne sewe dae na die effektiewe datum op die spesiale vergadering van die Metropolitaanse Substruktur, op die wyse voorgeskryf vir die verkiesing van 'n burgemeester en 'n onderburgemeester in artikel 16 van die Ordonnansie op Plaaslike Bestuur, 1939, 'n Voorsitter en 'n Ondervoorsitter uit die Raadslede in artikel 5 (4) vermeld.

#### **Uitvoerende Komitee**

7. (1) Die Sentraal Besigheid Distrik, die Noordwestelike, die Noordelike, die Noordoostelike, die Suid-Oos, die Suid-Wes en die Westelike Metropolitaanse Substrukture verkies tydens die spesiale vergadering beoog in artikel 6, ondanks die bepalings van die Ordonnansie op Plaaslike Bestuur (Administrasie en Verkiesings), 1960 (Ordonnansie No. 40 van 1960), kragtens artikel 16 (6) van die Oorgangswet op Plaaslike Regering, 1993, elk uit sy lede 'n Uitvoerende Komitee.

(2) Die Metropolitaanse Substrukture verkies elkeen tydens die spesiale vergadering beoog in artikel 6 uit die lede van die Uitvoerende Komitee 'n Voorsitter en 'n Ondervoorsitter vir die Uitvoerende Komitee.

(3) Die bepalings van artikels 1 en 55 tot 61 van die Ordonnansie op Plaaslike Bestuur (Administrasie en Verkiesings), 1960, is, by die toepassing van hierdie Proklamasie, *mutatis mutandis* op die Uitvoerende Komitees in subartikel (1) bedoel van toepassing.

#### **Beginsels en prosedure van vergaderings**

8. Die bepalings van artikels 20, 21, 22, 23, 24, 26, 27, 31, 32 en 33 van die Ordonnansie op Plaaslike Bestuur, 1939, is *mutatis mutandis* van toepassing op die beginsels en prosedures van vergaderings van die Metropolitaanse Substrukture.

#### **Oordra van bates, laste, regte, verpligtinge en regssopvolging (regssopvolger)**

9. (1) Alle bates, laste, regte en verpligtinge van die ontbinde plaaslike owerheidsliggame vermeld in artikel 2 word vanaf die effektiewe datum aan die Groter Johannesburg Metropolitaanse Oorgangsaad oorgeda.

(2) The Greater Johannesburg Transitional Metropolitan Council shall, subject to the provisions of section 16, for the purposes of this Proclamation as from the effective date be deemed to be the successor-in-law of the duties, assets, obligations, rights and liabilities of the local government bodies mentioned in section 2.

#### **Single Local Administration for Greater Johannesburg Metropolitan Substructures**

10. (1) A Temporary Single Local Administration for each of the Metropolitan Substructures is, subject to the provisions of subsection (2), hereby established as from the effective date.

(2) A permanent integrated organisational structure shall, subject to the provisions of sections 15 (1) (f), 16 and 25 (2), after the effective date be constituted by each of the Metropolitan Substructures through a change management process.

#### **Acting Chief Executive Officer/Town Clerk**

11. (1) As soon as possible after the effective date, each of the Metropolitan Substructures shall under section 62 of the Local Government Ordinance, 1939, appoint an Acting Chief Executive Officer/Town Clerk for the Metropolitan Substructure concerned.

(2) The Acting Chief Executive Officer/Town Clerk contemplated in subsection (1) shall, for the purposes of this Proclamation perform all the functions, powers and duties assigned to a Chief Executive Officer/Town Clerk in terms of the Local Government Ordinance, 1939, the Local Government (Administration and Elections) Ordinance, 1960, the Municipal Elections Ordinance, 1970, or any other law, or resolution of the Metropolitan Substructure concerned.

#### **Employees and officers of Transitional Metropolitan Substructures**

12. (1) The employees and officers of the dissolved local government bodies mentioned in section 2 shall, subject to the provisions of sections 15 (1) (f), 16 and 25 (2), as from the effective date be transferred to the Greater Johannesburg Transitional Metropolitan Council and shall take up employment with the said Council on terms and conditions of service not less favourable than those under which they previously served.

(2) After a permanent organisational structure as contemplated in section 10 (2) has been constituted by the Metropolitan Substructures, the employees and officers referred to in subsection (1) and sections 3 (2) and 30 (4) and employees and officers employed after the effective date will, subject to the provisions of sections 15 (1) (f), 16 and 25 (2), be deployed in either the Greater Johannesburg Transitional Metropolitan Council or the Metropolitan Substructure Local Administrations contemplated in section 10 (1) in accordance with the provisions of section 10 (3) (f) (i) and (j) of the Local Government Transition Act, 1993.

(2) Die Groter Johannesburg Metropolitaanse Oorgangsraad word, behoudens die bepaling van artikel 16, by die toepassing van die Proklamasie vanaf die effektiewe datum geag dieregsopvolger van die pligte, bates, verpligte, regte en laste van die onderskeie plaaslike overheidsliggame vermeld in artikel 2, te wees.

#### **Enkele Plaaslike Administrasie vir Groter Johannesburg Metropolitaanse Substrukture**

10. (1) 'n Tydelike Enkele Plaaslike Administrasie vir elkeen van die Metropolitaanse Substrukture word, behoudens die bepaling van subartikel (2), hierby vanaf die effektiewe datum ingestel.

(2) 'n Permanente geïntegreerde organisatoriese struktuur word, behoudens die bepaling in artikels 15 (1) (f), 16 en 25 (2), na die effektiewe datum deur elkeen van die Metropolitaanse Substrukture deur 'n veranderende bestuursproses saamgestel.

#### **Waarnemende Hoof Uitvoerende Beampete/Stadsklerk**

11. (1) So spoedig moontlik na die effektiewe stel elkeen van die Metropolitaanse Substrukture kragtens artikel 62 van die Ordonnansie op Plaaslike Bestuur, 1939, 'n Waarnemende Hoof Uitvoerende Beampete/Stadsklerk aan vir die betrokke Metropolitaanse Substruktuur.

(2) Die Waarnemende Hoof Uitvoerende Beampete/Stadsklerk in subartikel (1) bedoel, oefen by die toepassing van hierdie Proklamasie, opgedra aan 'n Hoof Uitvoerende Beampete/Stadsklerk, al die funksies, bevoegdhede en pligte uit kragtens die Ordonnansie op Plaaslike Bestuur, 1939, die Ordonnansie op Plaaslike Bestuur (Administrasie en Verkiesings), 1960, die Ordonnansie op Munisipale Verkiesings, 1970, of enige ander wet, verordeninge of besluit van die betrokke Metropolitaanse Substruktuur.

#### **Werknemers en beampetes van Metropolitaanse Oorgangsubstrukture**

12. (1) Die werknemers en beampetes van die ontbinde plaaslike overheidsliggame in artikel 2 vermeld, word, behoudens die bepaling van artikels 15 (1) (f), 16 en 25 (2), vanaf die effektiewe datum oorgeplaas na die Groter Johannesburg Metropolitaanse Oorgangsraad en aanvaar diens by die genoemde Raad op bedinge en diensvoorwaardes wat nie minder gunstig is as dié waaronder hulle voorheen gewerk het nie.

(2) Nadat 'n permanente organisatoriese struktuur soos in artikel 10 (2) beoog deur die Metropolitaanse Substrukture saamgestel is, word die werknemers en beampetes in subartikel (1) en artikels 3 (2) en 30 (4) vermeld en werknemers en beampetes wat na die effektiewe datum in diens geneem is, behoudens die bepaling van artikels 15 (1) (f), 16 en 25 (2) toegewys aan óf die betrokke Metropolitaanse Substruktuur se Plaaslike Administrasie beoog in artikel 10 (1), ooreenkomsdig die bepaling van artikel 10 (3) (f) (i) en (j) van die Oorgangswet op Plaaslike Regering, 1993.

(3) No employee or officer mentioned in subsection (1) shall lose his or her employment or be entitled to claim severance benefits simply by virtue of the dissolution of the local government bodies mentioned in section 2 or his or her transfer to the Greater Johannesburg Transitional Metropolitan Council.

## CHAPTER 2

### TRANSITIONAL METROPOLITAN COUNCIL

#### Establishment of Transitional Metropolitan Council

13. A Transitional Metropolitan Council, hereunder called the Greater Johannesburg Transitional Metropolitan Council, is hereby established as contemplated in section 7 (1) (b) (ii) of the Local Government Transition Act, 1993, as from the effective date, by which Greater Johannesburg Transitional Metropolitan Council shall, subject to the provisions of section 15, be deemed to be a local authority in terms of the Local Government Ordinance, 1939.

#### Area of Greater Johannesburg Transitional Metropolitan Council

14. The area of the Greater Johannesburg Transitional Metropolitan Council comprises the areas of jurisdiction of the Metropolitan Substructures mentioned in section 1 (1).

#### Functions, powers and duties of Greater Johannesburg Transitional Metropolitan Council

15. (1) The functions, powers and duties of the Greater Johannesburg Transitional Metropolitan Council shall be as follows:

- (a) The powers and duties set out in Schedule 2 to the Local Government Transition Act, 1993.
- (b) As set out in sections 12 (1) (b), 10A, 12 (1) (a) and (10) and 14 of the Regional Services Councils Act, 1985 (Act No. 109 of 1985).
- (c) All other local government functions, powers and duties of the dissolved local government bodies mentioned in section 2, subject to the provisions of section 16.
- (d) The determination of an overall policy framework for the metropolitan area.
- (e) The Reconstruction and Development Programme for the metropolitan area.
- (f) The management of the process of winding down the dissolved local government bodies mentioned in section 2, with the objective of achieving an equitable utilisation of the asset base and infrastructure of the entire metropolitan area, including the transfer of assets and liabilities, administrations and employees and officers of the dissolved local government bodies.

(3) Geen werknemer of beampie in subartikel 1 vermeld sal sy of haar werk verloor of geregtig wees om uittreevoordele te eis slegs op grond van die ontbinding van die plaaslike owerheidsliggome in artikel 2 vermeld of sy of haar oorplasing na die Groter Johannesburg Metropolitaanse Oorgangsraad nie.

## HOOFSTUK 2

### METROPOLITAANSE OORGANGSRAAD

#### Instelling van Metropolitaanse Oorgangsraad

13. 'n Metropolitaanse Oorgangsraad, hieronder die Groter Johannesburg Metropolitaanse Oorgangsraad genoem, word hierby, soos beoog in artikel 7 (1) (b) (ii) van die Oorgangswet op Plaaslike Regering, 1993, vanaf die effektiewe datum ingestel, welke Groter Johannesburg Metropolitaanse Oorgangsraad, behoudens die bepalings van artikel 15, geag word 'n plaaslike bestuur ingevolge die Ordonnansie op Plaaslike Bestuur, 1939, te wees.

#### Gebied van Groter Johannesburg Metropolitaanse Oorgangsraad

14. Die gebied van die Groter Johannesburg Metropolitaanse Oorgangsraad bestaan uit die regsgebiede van die Metropolitaanse Substrukture in artikel 1 (1) vermeld.

#### Funksies, bevoegdhede en pligte van Groter Johannesburg Metropolitaanse Oorgangsraad

15. (1) Die funksies, bevoegdhede en pligte van die Groter Johannesburg Metropolitaanse Oorgangsraad is soos volg:

- (a) Die bevoegdhede en pligte soos uiteengesit in Bylae 2 by die Oorgangswet op Plaaslike Regering, 1993.
- (b) Soos uiteengesit in artikels 12 (1) (b), 10A, 12 (1) (a) en (10) en 14 van die Wet op Streeksdiensterade, 1985 (Wet No. 109 van 1985).
- (c) Alle ander plaaslike regeringsfunksies, bevoegdhede en pligte van die ontbinde plaaslike owerheidsliggome in artikel 2 vermeld, behoudens die bepalings van artikel 16.
- (d) Die bepaling van 'n geheel beleidsraamwerk vir die metropolitaanse gebied.
- (e) Die Heropbou en Ontwikkelingsprogram vir die metropolitaanse gebied.
- (f) Die proses van bereddering van die ontbinde plaaslike owerheidsliggome in artikel 2 vermeld, met die oogmerk om 'n billike aanwending van die bate grondslag en infrastruktuur van die geheel metropolitaanse gebied te bereik, insluitend die oordrag van bates en laste, administrasies en werknemers en beampies van die ontbinde plaaslike owerheidsliggome.

- (g) The management of the whole transition process and the creation of the necessary administrative capacities at the Council and the Metropolitan Substructure levels.
- (h) The determination of minimum levels of service delivery.
- (i) Ensuring that the Metropolitan Substructures have adequate finances.
- (j) The approval of the overall budget for the metropolitan area in consultation with the Metropolitan Substructures.
- (k) The determination of the contributions to be paid by the Metropolitan Substructures, to enable it *inter alia* to fulfil its Reconstruction and Development Programme redistribution responsibilities.

(2) The Greater Johannesburg Transitional Metropolitan Council shall appoint Administrator Bodies consisting of between two and eight persons on a 50/50 statutory/non-statutory-basis for each of the dissolved local government bodies mentioned in section 2, in order to—

- (a) undertake any duties delegated to them to give effect to the vesting of staff, assets, liabilities, rights and obligations in the Greater Johannesburg Transitional Metropolitan Council and the Metropolitan Substructures;
- (b) undertake such duties and execute those powers delegated to them by the Greater Johannesburg Transitional Metropolitan Council and which were previously executed by the administered of the said dissolved local government bodies, in order to ensure the continuation of efficient rendering of services; and
- (c) to carry onto the winding down process as contemplated in subsection (1) (f) under the management and policy control of the Greater Johannesburg Transitional Metropolitan Council.

#### **Delegation and allocation of functions, powers and duties by Greater Johannesburg Transitional Metropolitan Council**

**16.** (1) The Greater Johannesburg Transitional Metropolitan Council may, after negotiating with the relevant Metropolitan Substructures established by section 1, delegate any of its functions, powers and duties, mentioned in section 15 (1) (a) and (b) to such Metropolitan Substructures.

(2) Subject to the provisions of subsection (3), the Greater Johannesburg Transitional Metropolitan Council may, upon receipt of an application by and after negotiations with any Metropolitan Substructure allocate any of its functions, powers and duties referred to in section 15 (1) (c) to such Metropolitan Substructure.

(g) Die bestuur van die oorgangsproses as geheel en die skepping van die nodige administratiewe kapasiteite op die vlakke van die Raad en die Metropolitaanse Substrukture.

(h) Die bepaling van die minimum vlakke van dienslewering.

(i) om te verseker dat die Metropolitaanse Substrukture oor voldoende finansies beskik.

(j) Die goedkeuring van die geheel begroting vir die metropolitaanse gebied, in oorel met die Metropolitaanse Substrukture.

(k) Bepaling van die bydraes betaalbaar deur die Metropolitaanse Substrukture, om dit *inter alia* in staat te stel om sy herdistribusie-verantwoordelikheid betreffende die Heropbou en Ontwikkelingsprogram na te kom.

(2) Die Groter Johannesburg Metropolitaanse Oorgangsraad sal Administratorliggame aanstel wat uit tussen twee en agt persone bestaan, op 'n 50/50 statutêre/nie-statutêre-liggome grondslag, vir elkeen van die ontbinde plaaslike owerheidsliggome in artikel 2 vermeld, ten einde—

(a) enige pligte aan hulle gedelegeer te onderneem om die vestiging van personeel, bates, laste, regte en verpligte te weeg te bring in die Groter Johannesburg Metropolitaanse Oorgangsraad in die Metropolitaanse Substrukture;

(b) sodanige pligte te onderneem en sodanige bevoegdhede uit te voer as wat aan hulle deur die Groter Johannesburg, Metropolitaanse Oorgangsraad gedelegeer is en wat voorheen deur die administrasies van sodanige ontbinde plaaslike owerheidsliggome uitgevoer is, ten einde die voortsetting van effektiewe lewering van dienste te verseker; en

(c) die proses van beredding soos bedoel in subartikel (1) (f) onder die bestuur en beleidskontrole van die Groter Johannesburg Metropolitaanse Oorgangsraad uit te voer.

#### **Delegasie en opdra van funksies, bevoegdhede en pligte deur Groter Johannesburg Metropolitaanse Oorgangsraad**

**16.** (1) Die Groter Johannesburg Metropolitaanse Oorgangsraad kan, na onderhandeling met die betrokke Metropolitaanse Substrukture by artikel 1 ingestel, enige van sy funksies, bevoegdhede en pligte in artikel 15 (1) (a) en (b) vermeld aan sodanige Metropolitaanse Substrukture deleger.

(2) Behoudens die bepalings van subartikel (3), kan die Groter Johannesburg Metropolitaanse Oorgangsraad, by ontvangs van 'n aansoek van en ná onderhandeling met enige Metropolitaanse Substruktuur, enige van sy funksies, bevoegdhede en pligte in artikel 15 (1) (c) vermeld aan sodanige Metropolitaanse Substruktuur opdra.

(3) In the event of disagreement between the Greater Johannesburg Transitional Metropolitan Council and the Metropolitan Substructure concerned regarding the allocation of any functions, powers and duties contemplated in subsection (2) the mechanism mentioned in section 18 shall apply.

(4) The process of negotiation shall also include the transfer of assets, liabilities, rights and obligations to the Metropolitan Substructures and the transfer of employees and officers to the administrations of the Metropolitan Substructures, as contemplated in section 9 and 10, respectively.

#### **Criteria for allocation of functions, powers and duties**

**17.** (1) The powers to exercise any particular function shall be allocated to a Metropolitan Substructure on the basis of such Substructure presenting a management plan which addresses the following matters:

- (a) Organisational structure.
- (b) Financial plan and budget.
- (c) Administrative, operational and institutional capacity required.
- (d) Implementation programme.
- (e) How the relevant functions, powers and duties will enhance the implementation of the Reconstruction and Development Programme within the area of jurisdiction of the Metropolitan Substructure concerned.

(2) The Greater Johannesburg Transitional Metropolitan Council may refuse the allocation of functions, powers and duties if it can show such transfer of functions, powers and duties to be unreasonable.

#### **Mechanism for dispute resolution**

**18.** (1) If the Greater Johannesburg Metropolitan Council and a Metropolitan Substructure are not able to reach agreement on the delegation or allocation of functions, powers and duties in terms of section 16, or on any matter pertaining to revenue sources or on any budgetary matter contemplated in section 19 and 20, respectively, or if either party feels that insufficient progress is being made, the relevant party may formally declare a dispute and inform the Chief Executive Officer/Town Clerk appointed in terms of section 26 or under section 62 of the Local Government Ordinance, 1939, of the Greater Johannesburg Transitional Metropolitan Council in writing that a dispute has been declared.

(2) The said Chief Executive Officer/Town Clerk shall inform the Greater Johannesburg Transitional Metropolitan Council of such decision and shall send the declaration of the dispute to an arbitrator,

(3) In die geval van meningsverskil tussen die Groter Johannesburg Metropolitaanse Oorgangsraad en die betrokke Metropolitaanse Substruktur betreffende die opdra van enige funksies, bevoegdhede of pligte soos in subartikel (2) bedoel, geld die meganisme in artikel 18 vermeld.

(4) Die proses van onderhandeling sluit ook in die oordrag van bates, laste, regte en verpligtinge aan die Metropolitaanse Substrukturen en die oordrag van werkneemers en beampies aan die administrasies van die Metropolitaanse Substrukturen, soos beoog in onderskeidelik artikels 9 en 10, in.

#### **Kriteria vir opdra van funksies, bevoegdhede en pligte**

**17.** (1) Die bevoegdheid om enige besondere funksie uit te voer sal aan 'n Metropolitaanse Substruktur opgedra word op die grondslag dat sodanige Substruktur 'n bestuursplan voorlê wat die volgende aanspreek:

- (a) Organisatoriese struktuur.
- (b) Finansiële plan en begroting.
- (c) Administratiewe, operasionele en institusionele kapasiteit benodig.
- (d) Implementerings program.
- (e) Hoe die betrokke funksies, bevoegdhede en pligte die implementering van die Heropbou en Ontwikkelings Program binne die regsgebied van die betrokke Metropolitaanse Substruktur sal bevorder.

(2) Die Groter Johannesburg Metropolitaanse Oorgangsraad kan die opdra van funksies, bevoegdhede en pligte weier indien dit kan aantoon dat sodanige opdra van funksies, bevoegdhede en pligte onredelik is.

#### **Meganisme vir besluit in dispuut**

**18.** (1) Indien die Groter Johannesburg Metropolitaanse Oorgangsraad en 'n Metropolitaanse Substruktur nie in staat is om ooreenkoms te bereik op die delegasie of opdra van funksies, bevoegdhede en pligte in terme van artikel 16, of op enige aangeleentheid betreffende die toekenning van inkomstebonne of enige begrotingsaangeleentheid in onderskeidelik artikel 19 en 20 bedoel, nie, of enige party voel dat onvoldoende vordering gemaak word, kan die betrokke party formeel 'n dispuut verklaar en die Hoof Uitvoerende Beämpte/Stadsklerk, aangestel in terme van artikel 26 of kragtens artikel 62 van die Ordonnansie op Plaaslike Bestuur, 1939, van die Groter Johannesburg Metropolitaanse Oorgangsraad skriftelik verwittig dat 'n dispuut verklaar is.

(2) Die genoemde Hoof Uitvoerende Beämpte/Stadsklerk verwittig die Groter Johannesburg Metropolitaanse Oorgangsraad van sodanige besluit en stuur die verklaring van die dispuut aan 'n arbiter aangestel

appointed by the Member for Housing and Local Government of the Provincial Executive Council in consultation with the Provincial Committee: Provided that the terms of reference of the arbitrator shall be determined by the said Chief Executive Officer/Town Clerk in consultation with the parties concerned.

(3) The parties in dispute shall thereafter table their respective cases within five working days of the dispute being declared to the said Chief Executive Officer/Town Clerk of the Greater Johannesburg Transitional Metropolitan Council, who shall then request the arbitrator to arbitrate on the matter.

(4) The Greater Johannesburg Transitional Metropolitan Council shall provide reasons for the refusal of the delegation or allocation of functions, powers and duties to a Metropolitan Substructure.

(5) The arbitrator may call for oral clarification and further information during the process of arbitration.

(6) The arbitrator shall after he or she is satisfied that all the necessary information is on hand, give a binding decision within 10 working days.

(7) The arbitrator shall give reasons for his or her decision.

(8) A Metropolitan Substructure shall have the right to redeclare a dispute at any time.

(9) The costs of the arbitrator shall be borne by the parties concerned.

### **Revenue sources**

**19.** (1) The revenue sources shall, subject to sections 16 and 17 and with due regard to the fact that the delegation or allocation of functions, powers and duties from the Greater Johannesburg Transitional metropolitan Council to the Metropolitan Substructures have financial and budgetary implications, be allocated as follows:

(a) To the Greater Johannesburg Transitional Metropolitan Council:

- (i) The levies mentioned in paragraph 23 of Schedule 2 of the Local Government Transitional Act, 1993.
- (ii) Service charges or levies.
- (iii) Contributions from Metropolitan Substructures as contemplated in section 15 (1) (h).
- (iv) Intergovernmental and other grants.
- (v) Loans.
- (vi) Donations.

(b) To the Metropolitan Substructures:

- (i) Service charges.
- (ii) Intergovernmental grants through the Greater Johannesburg Transitional Metropolitan Council.

deur die Lid vir Behuising en Plaaslike Regering van die Provinciale Uitvoerende Raad in oorleg met die Provinciale Komitee: Met dien verstande dat die opdrag aan die arbiter deur die genoemde Hoof Uitvoerende Beämpte/Stadsklerk in oorleg met die betrokke partye bepaal word.

(3) Die partye in disputuut lê daarna hulle onderskeie kante van die saak binne vyf werksdae vanaf die verklaarde disputuut aan die gemelde Hoof Uitvoerende Beämpte/Stadsklerk van die Groter Johannesburg Metropolitaanse Oorgangsraad voor, wie daarna die arbiter versoek om oor die aangeleentheid te arbitreer.

(4) Die Groter Johannesburg Metropolitaanse Oorgangsraad verskaf redes vir die weiering van die delegasies of opdra van funksies, bevoegdhede en pligte aan 'n Metropolitaanse Substruktuur.

(5) Die arbiter kan om mondelinge opklaring of om verdere inligting gedurende die proses van arbitrasie versoek.

(6) Die arbiter gee, nadat hy of sy tevrede is dat al die nodige inligting voorhande is, 'n bindende beslissing binne 10 werksdae.

(7) Die arbiter gee redes vir sy of haar beslissing.

(8) 'n Metropolitaanse Substruktuur het die reg om te eniger tyd 'n disputuut her te verklaar.

(9) Die koste van die arbitrasie sal deur die betrokke partye gedra word.

### **Inkomste bronre**

**19.** (1) Die inkomste bronre word, behoudens artikels 16 en 17, en met behoorlike inagneming van die feit dat die delegasie of opdra van funksies, bevoegdhede en pligte van die Groter Johannesburg Metropolitaanse Oorgangsraad aan die Metropolitaanse Substrukture finansiële en begrotings implikasies het, soos volg toegeken:

(a) Aan die Groter Johannesburg Metropolitaanse Oorgangsraad:

- (i) Die heffings in paragraaf 23 van Bylae 2 by die Oorgangswet op Plaaslike Regering, 1993, vermeld.
- (ii) Dienstegelde of heffings.
- (iii) Bydraes van Metropolitaanse Substrukture soos in artikel 15 (1) (h) bedoel.
- (iv) Interregerings en ander toekennings.
- (v) Lenings.
- (vi) Donasies.

(b) Aan die Metropolitaanse Substrukture:

- (i) Dienstegelde.
- (ii) Interregerings toekennings deur die Groter Johannesburg Metropolitaanse Oorgangsraad.

(iii) Contributions from the Greater Johannesburg Transitional Metropolitan Council.

(iv) donations and grants.

(2) The levying of rates and taxes shall be in accordance with the criteria for the allocation of functions, powers and duties in section 17.

#### Budgets

**10.** (1) The budget for the metropolitan areas shall, notwithstanding the provisions of section 58 of the Local Government Ordinance, 1939, be made up of both the Greater Johannesburg Transitional Metropolitan Council's and Metropolitan Substructures' budgets.

(2) The budget mentioned in subsection (1) shall be formulated by the Greater Johannesburg Transitional Metropolitan Council based on the 1994/95-budgets of the dissolved local government bodies mentioned in section 2 in consultation with the Metropolitan Substructures.

(3) The inability of a Metropolitan Substructure to make an input regarding the budget mentioned in subsection (2) shall not delay the process: Provided that—

(a) the budget shall be approved by the Greater Johannesburg Transitional Metropolitan Council in consultation with the Metropolitan Substructures;

(b) the Greater Johannesburg Transitional Metropolitan Council shall make allocations to the seven Metropolitan Substructures to enable the Metropolitan Substructures to exercise the functions, powers and duties mentioned in section 4 or delegated or allocated in terms of section 16;

(c) expenditure may be authorised by the Greater Johannesburg Transitional Metropolitan Council in respect of expenses incurred by the dissolved local government bodies mentioned in section 2 and by the Metropolitan Substructures in respect of their functions, powers and duties.

(4) The 1995/96-Metropolitan Substructures' budgets shall be prepared on the basis of guidelines developed by the Greater Johannesburg Transitional Metropolitan Council and shall be subject to the approval of the Greater Johannesburg Transitional Metropolitan Council.

#### Councillors

**21.** (1) The Greater Johannesburg Transitional Metropolitan Council comprises 100 Councillors.

(2) The persons mentioned in Annexure P, and duly nominated under paragraph 5 of Schedule 1 to the Local Government Transition Act, 1993, are hereby as from the effective date appointed as Councillors of the Greater Johannesburg Transitional Metropolitan Council.

(iii) Bydraes van die Groter Johannesburg Metropolitaanse Oorgangsraad.

(vi) Donasies en toekennings.

(2) Die heffing van tariewe en belastings geskied ooreenkomstig die kriteria vir die opdra van funksies, bevoegdhede en pligte in artikel 17 vermeld.

#### Begrotings

**20.** (1) Die geheel begroting vir die metropolitaanse gebied word, ondanks die bepalings van artikel 58 van die Ordonnansie op Plaaslike Bestuur, 1939, opgemaak uit beide die begrotings van die Groter Johannesburg Metropolitaanse Oorgangsraad en van die Metropolitaanse Substrukture.

(2) Die begroting in subartikel (1) vermeld word deur die Groter Johannesburg Metropolitaanse Oorgangsraad geformuleer gegrond op die 1994/1995-begrotings van die ontbinde plaaslike overheidsliggeme in artikel 2 vermeld in oorleg met die Metropolitaanse Substrukture.

(3) Die onmag van 'n Metropolitaanse Substruktur om 'n inset betreffende die begroting in subartikel (2) vermeld te lewer, vertraag nie die proses nie: Met dien verstaande dat—

(a) die begroting word deur die Groter Johannesburg Metropolitaanse Oorgangsraad goedgekeur, in oorleg met die Metropolitaanse Substrukture;

(b) die Groter Johannesburg Metropolitaanse Oorgangsraad maak toekennings aan die sewe Metropolitaanse Substrukture ten einde die Metropolitaanse Substrukture in staat te stel om die funksies, bevoegdhede en pligte in artikel 4 vermeld, gedelegeer of opgedra in terme van artikel 16, uit te oefen;

(c) uitgawes kan deur die Groter Johannesburg Metropolitaanse Oorgangsraad gemagtig word betreffende uitgawes opgeloop deur die ontbinde plaaslike overheidsliggeme in artikel 2 vermeld en deur die Metropolitaanse Substrukture betreffende hulle funksies, bevoegdhede en pligte.

(4) Die 1995/96-begroting van die Metropolitaanse Substrukture word voorberei op die grondslag van riglyne by die Groter Johannesburg Metropolitaanse Oorgangsraad ontwikkel en is onderworpe aan die goedkeuring van die Groter Johannesburg Metropolitaanse Oorgangsraad.

#### Raadslede

**21.** (1) Die Groter Johannesburg Metropolitaanse Oorgangsraad bestaan uit 100 Raadslede.

(2) Die persone in Aanhengsel P vermeld, en wat behoorlik kragtens paragraaf 5 van Bylae 1 by die Oorgangswet op Plaaslike Regering, 1993, benoem is, word hierby as Raadslede van die Groter Johannesburg Metropolitaanse Oorgangsraad aangestel.

(3) Any casual vacancy arising on the Greater Johannesburg Transitional Metropolitan Council after the effective date shall be reported to the Member for Housing and Local Government of the Provincial Executive Council within 30 days, which vacancy shall, notwithstanding the provisions of sections 20 and 36 of the Municipal Elections Ordinance, 1970, be filled by the competent authority from the list of additional candidates in order of preference as contemplated in paragraph 5 of Schedule 1 to the Local Government Transition Act, 1993, as contained in Annexure Q.

#### **Chairperson and Deputy Chairperson**

22. The Greater Johannesburg Transitional Metropolitan Council shall, within seven days after the effective date, at a special meeting of the Council, in the manner prescribed for the election of a mayor and a deputy mayor in section 16 of the Local Government Ordinance, 1939, elect a Chairperson and a Deputy Chairperson for the Greater Johannesburg Transitional Metropolitan Council from the Councillors mentioned in section 21 (2).

#### **Meetings and decision making procedure**

23. Sections 20, 21, 22, 23, 24, 26, 27, 31, 32 and 33 of the Local Government Ordinance, 1939, shall *mutatis mutandis* apply to the principles and procedures of meetings of the Greater Johannesburg Transitional Metropolitan Council.

#### **Executive Committee**

24. (1) The Greater Johannesburg Transitional Metropolitan Council shall, at the special meeting contemplated in section 22, notwithstanding the provisions of the Local Government (Administration and Elections) Ordinance, 1960, under section 16 (6) of the Local Government Transition Act, 1993, elect from its members an Executive Committee.

(2) The Greater Johannesburg Transitional Metropolitan Council shall at the special meeting contemplated in section 22 elect from the members of the Executive Committee a Chairperson and a Deputy Chairperson for the Executive Committee.

(3) The provisions of sections 1 and 55 to 61 of the Local Government (Administration and Elections) Ordinance, 1960, shall, for the purposes of this Proclamation, be applicable *mutatis mutandis* to the Executive Committee contemplated in subsection (1).

#### **Administration of Greater Johannesburg Transitional Metropolitan Council**

25. (1) An Administration is hereby as from the effective date established for the Greater Johannesburg Transitional Metropolitan Council.

(2) All the functions, powers and duties of the Greater Johannesburg Transitional Metropolitan Council shall initially be executed by the administrations of the dissolved local government bodies mentioned in section 2 and the employees and officers mentioned in section 3 (2) and 30 (4) respectively under the direction of the Greater Johannesburg Transitional Metropolitan Council.

(3) Enige toevallelike vakature wat na die effektiewe datum op die Groter Johannesburg Metropolitaanse Oorgangsraad ontstaan, moet binne 30 dae aan die Lid vir Behuising en Plaaslike Regering van die Provinciale Uitvoerende Raad gerapporteer word, welke vakture, ondanks die bepalings van artikels 20 en 36 van die Ordonnansie op Municipale Verkiesings, 1970, deur die bevoegde gesag gevul moet word uit die lys van bykomende kandidate in orde van voorkeur soos beoog in paragraaf 5 van Bylae 1 by die Oorgangswet op Plaaslike Regering, 1993, soos in Aanhangsel Q vervat.

#### **Voorsitter en Ondervoorsitter**

22. Die Groter Johannesburg Metropolitaanse Oorgangsraad verkies binne sewe dae na die effektiewe datum op 'n spesiale vergadering van die Raad, op die wyse voorgeskryf vir die verkiesing van 'n burgemeester en 'n onderburgemeester in artikel 16 van die Ordonnansie op Plaaslike Bestuur, 1939, 'n Voorsitter en 'n Ondervoorsitter vir die Groter Johannesburg Metropolitaanse Oorgangsraad uit die Raadslede vermeld in artikel 21 (2).

#### **Vergaderings en besluitnemingsprosedure**

23. Artikels 20, 21, 22, 23, 24, 26, 27, 31, 32 en 33 van die Ordonnansie op Plaaslike Bestuur, 1939, is *mutatis mutandis* van toepassing op die beginsels en prosedures van vergaderings van die Groter Johannesburg Metropolitaanse Oorgangsraad.

#### **Uitvoerende Komitee**

24. (1) Die Groter Johannesburg Metropolitaanse Oorgangsraad verkies tydens die spesiale vergadering beoog in artikel 22, ondanks die bepalings van die Ordonnansie op Plaaslike Bestuur (Administrasie en Verkiesings), 1960, kragtens artikel 16 (6) van die Oorgangswet op Plaaslike Regering, 1993, uit sy lede 'n Uitvoerende Komitee.

(2) Die Groter Johannesburg Metropolitaanse Oorgangsraad verkies tydens die spesiale vergadering beoog in artikel 22 uit die lede van die Uitvoerende Komitee 'n Voorsitter en 'n Ondervoorsitter vir die Uitvoerende Komitee.

(3) Die bepalings van artikels 1 en 55 tot 61 van die Ordonnansie op Plaaslike Bestuur (Administrasie en Verkiesings), 1960, is, by die toepassing van hierdie Proklamasie, *mutatis mutandis* op die Uitvoerende Komitee in subartikel (1) beoog van toepassing.

#### **Administrasie van Groter Johannesburg Metropolitaanse Oorgangsraad**

25. (1) 'n Administrasie word hierby vanaf die effektiewe datum vir die Groter Johannesburg Metropolitaanse Oorgangsraad ingestel.

(2) Al die funksies, bevoegdhede en pligte van die Groter Johannesburg Metropolitaanse Oorgangsraad word aanvanklik uitgevoer deur die administrasies van die ontbinde plaaslike owerheidsliggardie in artikel 2 vermeld en die werknemers en beampies in onderskeidelik artikels 3 (2) en 30 (4) onder die beheer van die Groter Johannesburg Metropolitaanse Oorgangsraad.

(3) The provisions of section 10 (2) shall *mutatis mutandis* apply to a permanent integrated organisational structure for the Greater Johannesburg Transitional Metropolitan Council.

#### **Acting Chief Executive Officer/Town Clerk**

26. (1) As soon as possible after the effective date, the Greater Johannesburg Transitional Metropolitan Council shall, under section 62 of the Local Government Ordinance, 1939, appoint an Acting Chief Executive Officer/Town Clerk for the Greater Johannesburg Transitional Metropolitan Council.

(2) The Acting Chief Executive Officer/Town Clerk contemplated in subsection (1) shall, for the purposes of this Proclamation perform all the functions, powers and duties assigned to a Chief Executive Officer/Town Clerk in terms of the Local Government Ordinance, 1939, the Local Government (Administration and Elections) Ordinance, 1960, the Municipal Elections Ordinance, 1970, or any other law, or resolution of the Greater Johannesburg Transitional Metropolitan Council.

#### **Local authority contemplated in Sixth Schedule of Local Government Ordinance, 1939**

27. The Greater Johannesburg Transitional Metropolitan Council shall as from the effective date be a local authority as contemplated in Part 1 of the Sixth Schedule to the Local Government Ordinance, 1939.

#### **Authorized local authority**

28. (1) The Greater Johannesburg Metropolitan Transitional Council shall, under section 2 of the Town-planning and Townships Ordinance, 1986 (Ordinance No. 15 of 1986), as from the effective date, be an authorized local authority for the purposes of Chapters II, III and IV of the said Ordinance.

(2) The Greater Johannesburg Metropolitan Transitional Council shall, under section 3 of the Division of Land Ordinance, 1986 (Ordinance No. 20 of 1986), as from the effective date, be an authorized local authority for the purposes of Chapter IV of the said Ordinance.

#### **By-laws, regulations, statutory notices, resolutions and delegations**

29. Subject to the provisions of this Proclamation, all by-laws, regulations, statutory notices, resolutions and delegations of the dissolved local government bodies mentioned in section 2 which immediately before the effective date were in force in any area of the said dissolved local government bodies, shall remain in force in such area, subject to any repeal or amendment of such by-laws, regulations, statutory notices, resolutions and delegations by the Greater Johannesburg Transitional Metropolitan Council.

(3) Die bepalings van artikel 10 (3) is *mutatis mutandis* van toepassing op 'n permanente, geïntegreerde organisatoriese struktuur vir die Groter Johannesburg Metropolitaanse Oorgangsraad.

(2) Die Waarnemende Hoof Uitvoerende Beampte/Stadsklerk in subartikel (1) bedoel, oefen by die toepassing van hierdie Proklamasie al die funksies, bevoegdhede en pligte uit opgedra aan 'n Hoof Uitvoerende Beampte/Stadsklerk kragtens die Ordonnansie op Plaaslike Bestuur, 1939, die Ordonnansie op Plaaslike Bestuur (Administrasie en Verkiesings), 1960, die Ordonnansie op Munisipale Verkiesings, 1970, of enige ander wet, verordening of besluit van die Groter Johannesburg Metropolitaanse Oorgangsraad.

#### **Plaaslike bestuur in Sesde Bylae by Ordonnansie op Plaaslike Bestuur, 1939, beoog**

27. Die Groter Johannesburg Metropolitaanse Oorgangsraad word vanaf die effektiewe datum geag 'n plaaslike bestuur soos beoog in Deel 1 van die Sesde Bylae by die Ordonnansie op Plaaslike Bestuur, 1939, te wees.

#### **Gemagtigde plaaslike bestuur**

28. (1) Die Groter Johannesburg Metropolitaanse Oorgangsraad word, kragtens die bepalings van artikel 2 van die Ordonnansie op Dorpsbeplanning en Dorpe, 1986 (Ordonnansie No. 15 van 1986), vanaf die effektiewe datum 'n gemagtigde plaaslike bestuur vir doel-eindes van Hoofstukke II, III en IV van genoemde Ordonnansie.

(2) Die Groter Johannesburg Metropolitaanse Oorgangsraad word, kragtens die bepalings van artikel 3 van die Ordonnansie op die Verdeling van Grond, 1986 (Ordonnansie No. 20 van 1986), vanaf die effektiewe datum 'n gemagtigde plaaslike bestuur vir doel-eindes van Hoofstuk IV van genoemde Ordonnansie.

#### **Verordeninge, regulasies, statutêre kennisgewings, besluite en delegasies**

29. Behoudens die bepalings van hierdie Proklamasie bly alle verordeninge, regulasies, statutêre kennisgewings, besluite en delegasies van die ontbindende plaaslike owerheidsliggame vermeld in artikel 2 wat onmiddellik voor die effektiewe datum van krag was in enige gebied van die genoemde plaaslike owerheidsliggame, van krag in sodanige gebied, behoudens enige herroeping of wysiging van die verordeninge, regulasies, statutêre kennisgewings, besluite en delegasies deur die Groter Johannesburg Metropolitaanse Oorgangsraad.

## CHAPTER 3

### REGIONAL SERVICES COUNCIL

#### Diseestablishment of Central Witwatersrand Regional Services Council

**30.** (1) The Central Witwatersrand Regional Services Council shall, as from the effective date, be disestablished in terms of section 10 (3) (h) of the Local Government Transition Act, 1993, in respect of the area of the Greater Johannesburg Transitional Metropolitan Council mentioned in section 14.

(2) The Greater Johannesburg Transitional Metropolitan Council shall, as from the effective date be the successor-in-law of the Central Witwatersrand Regional Services Council.

(3) All resolutions, delegations and statutory notices of the Central Witwatersrand Regional Services Council pertaining to the area described in section 14, shall, as from the effective date, be deemed to be resolutions, delegations and statutory notices of the Greater Johannesburg Transitional Metropolitan Council until amended or repealed by the Greater Johannesburg Transitional Metropolitan Council.

(4) All the personnel employed by the Central Witwatersrand Regional Services Council, shall, subject to the provisions of section 10 (3) (f) (i) and (j) of the Local Government Transition Act, 1993, as from the effective date be transferred to the Greater Johannesburg Transitional Metropolitan Council.

(5) The provisions of section 12 (3) shall apply *mutatis mutandis* to the employees mentioned in subsection (4).

## CHAPTER 4

### INDUSTRIAL COUNCIL

#### Industrial Council

**31.** (1) The Industrial Council for the Central Witwatersrand Municipal Undertaking established in accordance with the provisions of the Labour Relations Act, 1956 (Act No. 28 of 1956) and as referred to in Government Notice No. R. 679 published in *Government Gazette* No. 8639 of 31 March 1983, shall hereby, notwithstanding the other provisions of this section, and subject to the approval of the Minister of Manpower, be deemed to be dissolved and its registration be deemed to be cancelled in accordance with section 34 of the said Act, and an Industrial Council for the Local Government Undertaking in the area of the Greater Johannesburg Transitional Metropolitan Council, hereinafter called the Industrial Council for the Local Government Undertaking of the Greater Johannesburg Metropolitan Area, shall hereby be deemed to be established in such area in accordance with the

## HOOFSTUK 3

### STREEKSDIENSTERAAD

#### Ontbinding van Sentraal Witwatersrand Streeksdiensteraad

(5) Die bepalings van artikel 12 (3) geld *mutatis mutandis* vir die werknemers in subartikel (4) vermeld.

### NYWERHEIDSRAAD

#### Nywerheidsraad

**31.** (1) Die Nywerheidsraad vir die Sentraal Witwatersrand Plaaslikebestuursonderneming ingestel ooreenkomstig die bepalings van die Wet op Arbeidsverhoudinge, 1956 (Wet No. 28 van 1956), word hierby, soos na verwys in Goewermentskennisgiving No. R. 679 gepubliseer in *Staatskoerant* No. 8639 van 31 Maart 1993, ondanks die ander bepalings van hierdie artikel, en onderworpe aan die goedkeuring van die Minister van Mannekrag, geag ontbind te wees, en die registrasie daarvan soos gekanselleer te wees ooreenkomstig artikel 34 van die genoemde Wet en 'n Nywerheidsraad vir die Plaaslike Bestuursonderneming vir die gebied van die Groter Johannesburg Metropolitaanse Oorgangsraad, hierna die Nywerheidsraad vir die Plaaslikebestuursonderneming van die Groter Johannesburg Metropolitaanse Gebied genoem, word hierby geag ingestel te wees vir die

provisions of the Labour Relations Act, 1956, on the date that the said Minister grants his approval therefor, hereinafter called the transfer date.

(2) The jurisdiction of the Industrial Council for the Local Government Undertaking in the Province of the Transvaal established in accordance with the provisions of the Labour Relations Act, 1956 (Act No. 28 of 1956), and as referred to in Government Notice No. R. 679 published in *Government Gazette* No. 8639 of 31 March 1983 shall hereby notwithstanding the other provisions of this section, and subject to the approval of the Minister of Manpower, be deemed to be limited in accordance with the provisions of section 34 of the said Act as from the transfer date so as to exclude all areas, undertakings, industries, trades or occupations that fall within the jurisdiction of the Industrial Council for the Local Government Undertaking of the Greater Johannesburg Metropolitan Area established in terms of subsection (1).

(3) All pending matters before the Industrial Council for the Central Witwatersrand Municipal Undertaking shall, after the transfer date, be disposed of by the Industrial Council for the Central Witwatersrand Municipal Undertaking as if it has not been dissolved in terms of subsection (1).

(4) All pending matters before the Industrial Council for the Local Government Undertaking in the Province of the Transvaal shall after the transfer date, be disposed of by the Industrial Council for the Local Government Undertaking in the Province of the Transvaal as if it had not been dissolved in terms of subsection (2).

(5) The employer(s) and trade union party(s) to the Industrial Council for the Central Witwatersrand Municipal Undertaking and the Industrial Council for the Local Government Undertaking in the Province of the Transvaal, shall retain the rights and remain bound by the obligations that, immediately prior to the transfer date, are contained in any agreements of those councils: Provided that such rights and obligations shall continue in existence only until they are amended by or in accordance with law.

(6) The assets, liabilities, rights and obligations of whatever nature of the Industrial Council for the Central Witwatersrand Municipal Undertaking which existed before the transfer date, shall on the said date be transferred to the Industrial Council for the Local Government Undertaking of the Greater Johannesburg Metropolitan Area which Industrial Council shall for the purposes of this Proclamation be the successor-in-law of the Industrial Council for the Central Witwatersrand Municipal Undertaking. An administrator shall be appointed by the Industrial Registrar to effect the transfer expeditiously.

(7) The assets, liabilities, rights and obligations in relation to that portion of the Industrial Council for the Local Government Undertaking in the Province of the Transvaal which falls within the jurisdiction of the Industrial Council for the Local Government Undertaking of the Greater Johannesburg Metropolitan Area, which existed before the transfer date, shall be transferred to the Industrial Council for the Local Government Undertaking of the Central Witwatersrand Metropolitan Area. An administrator shall be appointed by the Industrial Registrar to effect the transfer expeditiously.

## CHAPTER 5

### GENERAL

#### Suspension of laws

32. The provisions of any law which relate to the establishment, dissolution or combination of a local authority or the alteration of the area thereof are, for the purposes of this Proclamation and subject to the provisions of sections 8 and 11 (6) (a) of the Local Government Transition Act, 1993, hereby suspended.

#### Effective date

33. This proclamation shall come into operation on 3 December 1994.


