### NOTICE 3539 OF 1997

#### SOUTH AFRICAN SCHOOLS ACT, 1996 (ACT NO. 84 OF 1996)

#### NOTICE OF DETERMINATION OF THE NUMBER OF MEMBERS OF GOVERNING BODIES OF PUBLIC SCHOOLS FOR LEARNERS WITH SPECIAL EDUCATION NEEDS

I, Mary Ellen Metcalfe, Member of the Executive Council for Education, hereby give notice in terms of section 24(2) of the South African Schools Act, 1996 (Act No. 84 of 1996) that I have determined the number of members in each category of membership of governing bodies of public schools for learners with special education needs.

## Definitions

1. In this Notice, unless the context indicates otherwise—

- (i) “Appropriate field” means a field of special needs education which is appropriate to a school for special education, as contemplated in section 2(1)(e);
- (ii) “Category of disability” means a category of disability manifested amongst learners enrolled at a school for special education, as contemplated in section 2(1)(d).

## Numbers of members of governing bodies of schools for learners with special education needs

2. (1) In addition to the members contemplated in regulations 4, 5 and 6 of the Governing Body Regulations for Public Schools, 1997, applicable within the Gauteng Province, a governing body of a school for learners with special education needs shall have the following members—

- (a) one representative of each sponsoring body of the school, appointed or elected in terms of this Notice;
- (b) one representative of each organisation of parents of learners with special education needs which has an interest in the school, appointed or elected in terms of this Notice;
- (c) one representative of each organisation of disabled persons which has an interest in the school, appointed or elected in terms of this Notice;
- (d) one disabled person for each category of disability which is manifested among learners enrolled at the school; and
- (e) one expert in appropriate fields of special needs education.

(2) The Member of the Executive Council, must, within 30 days of publication of this Notice, and after consultation with the governing body of a school for learners with special education needs, determine in respect of that school, the number of—

- (a) categories of disability; and
- (b) appropriate fields.

(3) The total number of members in the categories contemplated in paragraphs (a) to (e) of subsection (1) shall be at least one less than the total number of members contemplated in regulations 4, 5 and 6 of the Governing Body Regulations for Public Schools, 1997, applicable within the Gauteng Province.

(4) A governing body shall not be deemed to be improperly constituted if it is not reasonably practicable that a member in the categories contemplated in paragraphs (a) to (e) of subsection (1) be so elected.

## Appointment of members

3. (1) An organisation or sponsoring body may apply in writing to the Member of the Executive Council, within 30 days of publication of this Notice, to be represented on the governing body of a school for learners with special education needs, in terms of paragraphs (a), (b) or (c) of section 2(1).

(2) An application contemplated in subsection (1) shall set out the reasons why the organisation or sponsoring body believes it should be represented on the governing body.

(3) Subject to section 2(3), the Member of the Executive Council shall, within 30 days after the expiry of the period for applications contemplated in subsection (1), and after consultation with the governing body of the school concerned, grant or refuse the application.

(4) If the Member of the Executive Council refuses an application in terms of subsection (3), he or she shall provide the applicant organisation or sponsoring body with written reasons for doing so.

(5) If the Member of the Executive Council grants an application in terms of subsection (3), the applicant organisation or sponsoring body shall be entitled to appoint its own representative on the governing body according to its own internal procedures.

(6) After the appointment of representatives contemplated in subsection (5)—

- (a) the organisation or body shall notify the principal in writing of the name of the representative appointed to the governing body; and
- (b) the principal shall notify the District Electoral Officer in writing of the name of such representative.

### **Nomination of disabled persons and experts**

4. (1) If there is a vacancy on a governing body in respect of any category of disability or appropriate field, any member of a governing body may nominate a person in that category or field for election as a member of the governing body, as contemplated in section 2(1)(d) or (e), by—

- (a) lodging a nomination form with the principal not more than seven days and not less than one day before an ordinary meeting of the governing body, which form shall be duly completed by the proposer and the candidate; or
  - (b) proposing a person as a member during the meeting contemplated in paragraph (a), and lodging with the Chairperson a nomination form duly completed by the proposer and the candidate.
- (2) At the meeting contemplated in subsection (1), the Chairperson shall—
- (a) notify the members of the nominations;
  - (b) inform the members that an election will take place at the next ordinary meeting of the governing body; and
  - (c) invite the members to nominate additional candidates for election in accordance with the provisions of subsection (3).
- (3) Any member may nominate an additional candidate for election by—
- (a) lodging a nomination form with the principal not more than seven days and not less than one day before the next ordinary meeting following the meeting contemplated in subsection (1), which form shall be duly completed by the proposer and the candidate; or
  - (b) proposing a person as a member during the next ordinary meeting following the meeting contemplated in subsection (1), and lodging with the Chairperson a nomination form duly completed by the proposer and the candidate.

### **Election of disabled person members and expert members**

5. (1) At the next ordinary meeting following the meeting contemplated in section 4(2), the members of the governing body with voting rights shall, by secret ballot and in separate rounds of voting, in respect of the relevant category of disability or appropriate field, elect one member from the validly nominated candidates for the relevant category of disability or appropriate field.

(2) Every voting member of the governing body shall be entitled to vote and shall have one vote in respect of each candidate, with a maximum number of votes equal to the number of members to be elected in each round of voting.

(3) After the election of members contemplated in subsection (2)—

- (a) the principal shall notify each elected member in writing of his or her election as a member of the governing body; and
- (b) the principal shall notify the District Electoral Officer in writing of the name of each elected member.

**Nomination of organisations and bodies**

6. (1) If, at any time after the expiry of the period contemplated in section 3(3), taking into account the number of members already appointed and the number of categories and fields determined in terms of section 2(2)(a) and (b), section 2(3) permits the election of further members to a governing body for a school for learners with special education needs, any member of a governing body may nominate an organisation or body in the categories set out in paragraphs (a) to (c) of section 2(1) to be represented on the governing body by—

- (a) lodging a nomination form with the principal not more than seven days and not less than one day before an ordinary meeting of the governing body, which form shall be duly completed by the proposer and the candidate organisation or body; or
  - (b) proposing an organisation or body as a member during the meeting contemplated in paragraph (a), and lodging with the Chairperson a nomination form duly completed by the proposer and the candidate organisation or body.
- (2) At the meeting contemplated in subsection (1), the Chairperson shall—
- (a) notify the members of the nominations;
  - (b) inform the members that an election will take place at the next ordinary meeting of the governing body; and
  - (c) invite the members to nominate additional candidates for election in accordance with the provisions of subsection (3).
- (3) Any member may nominate an additional candidate for election by—
- (a) lodging a nomination form with the principal not more than seven days and not less than one day before the next ordinary meeting following the meeting contemplated in subsection (1), which form shall be duly completed by the proposer and the candidate organisation or body; or
  - (b) proposing an organisation or body as a member during the next ordinary meeting following the meeting contemplated in subsection (1), and lodging with the Chairperson a nomination form duly completed by the proposer and the candidate organisation or body.

**Election of organisations and bodies**

7. (1) At the next ordinary meeting following the meeting contemplated in section 6(1)(a), the members of the governing body shall, subject to section 2(3), determine how many additional organisations and bodies, if any, are to be represented on the governing body in terms of each of paragraphs (a) to (c) of section 2(1).

(2) The members of the governing body with voting rights shall immediately proceed, by secret ballot and in separate rounds of voting, to elect the determined number of organisations and bodies from the validly nominated candidates for each of the categories of paragraphs (a) to (c) of section 2(1).

(3) Every voting member of the governing body shall be entitled to vote and shall have one vote in respect of each candidate, with a maximum number of votes equal to the number of members to be elected in each round of voting.

(4) If elected in terms of subsection (2), the organisation or body shall be entitled to appoint its own representative on the governing body according to its own internal procedures.

(5) After the appointment of representatives contemplated in subsection (4)—

- (a) the organisation or body shall notify the principal in writing of the name of the representative appointed to the governing body; and
- (b) the principal shall notify the District Electoral Officer in writing of the name of such representative.

### Alteration of provisions of Notice

8. The Member of the Executive Council may alter the provisions of this Notice in respect of a particular school for learners with special education needs, or in respect of such schools generally.

**KENNISGEWING 3539 VAN 1997****Woordomskrywing****1. In hierdie Kennisgewing, tensy uit die samehang anders blyk, beteken—**

- (i) **"Gepaste veld"** 'n veld van onderwys vir buitengewone behoeftes wat gepas is vir 'n skool vir spesiale onderwys, soos bedoel in artikel 2(1)(e);
- (ii) **"Kategorie van gestremdheid"** 'n kategorie van gestremdheid wat gemanifesteer word in leerders wat by 'n skool vir spesiale onderwys ingeskryf is, soos bedoel in artikel 2(1)(d).

**Aantal lede van beheerliggame van skole vir leerders met buitengewone onderwysbehoeftes**

**2. (1)** Afgesien van die lede soos beoog in regulasies 4, 5 en 6 van die Regulasies vir Beheerliggame van Openbare Skole, 1997, van toepassing in die Provincie Gauteng, moet 'n beheerliggaam van 'n skool vir leerders met buitengewone onderwysbehoeftes die volgende lede hê—

- (a) een verteenwoordiger van elke borgliggaam van die skool, wat kragtens hierdie Kennisgewing aangewys of verkies word;
- (b) een verteenwoordiger van elke organisasie van ouers van leerlinge met buitengewone onderwysbehoeftes wat 'n belang by die skool het, wat kragtens hierdie Kennisgewing aangewys of verkies word;
- (c) een verteenwoordiger van elke organisasie van gestremde persone wat 'n belang by die skool het, wat kragtens hierdie Kennisgewing aangewys of verkies word;
- (d) een gestremde persoon vir elke kategorie van gestremdheid wat gemanifesteer word onder leerders wat by die skool ingeskryf is; en
- (e) een deskundige in gepaste velde van buitengewone behoeftes onderwys.

**(2)** Die Lid van die Uitvoerende Raad moet binne 30 dae van publikasie van hierdie Kennisgewing, en na oorlegpleging met die beheerliggaam van 'n skool vir leerders met buitengewone onderwysbehoeftes, met betrekking tot daardie skool die aantal—

- (a) kategorieë van gestremdheid; en
- (b) gepaste velde bepaal.

**(3)** Die totale aantal lede in die kategorieë beoog in paragrawe (a) tot (e) van subartikel (1) moet ten minste een minder wees as die totale aantal lede beoog in regulasies 4, 5 en 6 van die Regulasies vir Beheerliggame van Openbare Skole, 1997, wat van toepassing is in die Provincie Gauteng.

**(4)** 'n Beheerliggaam word nie geag onbehoorlik saamgestel te wees as dit nie redelik prakties uitvoerbaar is dat 'n lid in die kategorieë beoog in paragrawe (a) tot (e) van subartikel (1) aldus verkies is nie.

**Aanwysing van lede**

**3. (1)** 'n Organisasie of borgliggaam kan binne 30 dae van publikasie van hierdie Kennisgewing skriftelik aansoek doen by die Lid van die Uitvoerende Raad om verteenwoordig te word op die beheerliggaam van 'n skool vir leerders met buitengewone onderwysbehoeftes, kragtens paragrawe (a), (b) of (c) van artikel 2(1).

**(2)** 'n Aansoek in subartikel (1) beoog moet die redes uiteensit waarom die organisasie of borgliggaam van mening is dat dit op die beheerliggaam verteenwoordig moet word.

**(3)** Behoudens artikel 2(3) moet die Lid van die Uitvoerende Raad binne 30 dae nadat die tydperk vir aansoeke soos beoog in subartikel (1) verstryk het, en na oorlegpleging met die beheerliggaam van die betrokke skool, die aansoek goedkeur of van die hand wys.

**(4)** As die Lid van die Uitvoerende Raad 'n aansoek van die hand wys kragtens subartikel (3), moet hy of sy aan die aansoeker organisasie of borgliggaam skriftelike redes daarvoor verskaf.

(5) As die Lid van die Uitvoerende Raad 'n aansoek goedkeur kragtens subartikel (3), is die aansoeker organisasie of borgliggaam geregtig daarop om hul eie verteenwoordiger op die beheerliggaam aan te wys ooreenkomsdig hul eie interne prosedure.

(6) Na die verkiesing van die verteenwoordigers in subartikel (5) beoog—

- (a) moet die organisasie of liggaam die prinsipaal skriftelik in kennis stel van die naam van die verteenwoordiger wat op die beheerliggaam aangewys is; en
- (b) moet die prinsipaal die Distriksverkiesingsbeampte skriftelik in kennis stel van die naam van die verteenwoordiger.

### Nominasie van gestremde persone en deskundiges

4. (1) As daar 'n vakature ontstaan op 'n beheerliggaam met betrekking tot enige kategorie van gestremdheid of gepaste veld, kan enige lid van 'n beheerliggaam 'n persoon in daardie kategorie of veld nomineer vir verkiesing as 'n lid van die beheerliggaam soos beoog in artikel 2(1)(d) of (e), deur—

- (a) 'n nominasievorm by die prinsipaal in te gee hoogstens sewe dae en minstens een dag voor 'n gewone vergadering van die beheerliggaam, welke vorm behoorlik ingevul moet word deur die voorsteller en die kandidaat; of
- (b) 'n persoon as kandidaat voor te stel tydens die vergadering in paragraaf (a) beoog, en 'n nominasievorm wat behoorlik ingevul is deur die voorsteller en die kandidaat, by die Voorsitter in te gee.
- (2) By die vergadering in subartikel (1) bedoel, moet die Voorsitter—
  - (a) die lede in kennis stel van die nominasies;
  - (b) die lede inlig dat 'n verkiesing sal plaasvind by die volgende gewone vergadering van die beheerliggaam; en
  - (c) die lede uitnooi om verdere kandidate vir verkiesing te nomineer ooreenkomsdig die bepalings van subartikel (3).
- (3) Enige lid kan 'n addisionele lid vir verkiesing nomineer deur—
  - (a) 'n nominasievorm by die prinsipaal in te gee hoogstens sewe dae en minstens een dag voor die volgende gewone vergadering na die vergadering in subartikel (1) beoog, welke vorm behoorlik ingevul moet word deur die voorsteller en die kandidaat; of
  - (b) 'n persoon as lid voor te stel tydens die volgende gewone vergadering na die vergadering in subartikel (1) beoog, en 'n nominasievorm wat behoorlik ingevul is deur die voorsteller en die kandidaat, by die Voorsitter in te gee.

### Verkiesing van gestremde lede en deskundige lede

5. (1) By die volgende gewone vergadering na die vergadering in artikel 4(2) beoog, moet die stemgeregtigde lede van die beheerliggaam deur middel van geheime stemming en in afsonderlike stemrondes een lid vanuit die behoorlik benoemde kandidate vir die betrokke kategorie van gestremdheid of gepaste veld verkies ten opsigte van die betrokke kategorie van gestremdheid of gepaste veld.

(2) Elke stemgeregtigde lid van die beheerliggaam is geregtig op een stem ten opsigte van elke kandidaat, met 'n maksimum aantal stemme gelyk aan die aantal lede wat in elke stemronde verkies moet word.

(3) Na die verkiesing van lede in subartikel (2) beoog—

- (a) moet die prinsipaal elke verkose lid skriftelik in kennis stel van sy of haar verkiesing as lid van die beheerliggaam; en
- (b) moet die prinsipaal die Distriksverkiesingsbeampte skriftelik in kennis stel van die naam van elke verkose lid.

## Nominasie van organisasies en liggeme

6. (1) As artikel 2(3) te eniger tyd nadat die tydperk in artikel 3(3) verstryk het, die verkiesing van verdere lede van die beheerliggaam van 'n skool vir leerders met buitengewone onderwysbehoeftes toelaat, met inagneming van die aantal lede wat reeds aangewys is en die aantal kategorieë en velde wat bepaal is kragtens artikel 2(2)(a) en (b), kan enige lid van 'n beheerliggaam 'n organisasie of liggaaam in die kategorieë wat in paragrawe (a) tot (c ) van artikel 2(1) uiteengesit word, nomineer om op die beheerliggaam verteenwoordig te word deur—

- (a) 'n nominasievorm by die prinsipaal in te gee hoogstens sewe dae en minstens een dag voor 'n gewone vergadering van die beheerliggaam, welke vorm behoorlik ingevul moet word deur die voorsteller en die kandidaat organisasie of liggaaam; of
  - (b) 'n organisasie of liggaaam as lid voor te stel tydens die vergadering in paragraaf (a) beoog, en 'n nominasievorm wat behoorlik ingevul is deur die voorsteller en die kandidaat organisasie of liggaaam, by die Voorsitter in te gee.
- (2) By die vergadering in subartikel (1) bedoel, moet die Voorsitter—
- (a) die lede in kennis stel van die nominasies;
  - (b) die lede inlig dat 'n verkiesing sal plaasvind by die volgende gewone vergadering van die beheerliggaam; en
  - (c) die lede uitnooi om verdere kandidate vir verkiesing te nomineer ooreenkomstig die bepalings van subartikel (3).
- (3) Enige lid kan 'n addisionele kandidaat vir verkiesing nomineer deur—
- (a) 'n nominasievorm by die prinsipaal in te gee hoogstens sewe dae en minstens een dag voor die volgende gewone vergadering na die vergadering in subartikel (1) beoog, welke vorm behoorlik ingevul moet word deur die voorsteller en die kandidaat organisasie of lid; of
  - (b) 'n organisasie of liggaaam as lid voor te stel tydens die volgende gewone vergadering na die vergadering in subartikel (1) beoog, en 'n nominasievorm wat behoorlik ingevul is deur die voorsteller en die kandidaat organisasie of liggaaam, by die Voorsitter in te gee.

## Verkiesing van organisasies en liggeme

7. (1) By die volgende gewone vergadering na die vergadering in artikel 6(1)(a) beoog, moet die lede van die beheerliggaam, behoudens die bepalings van artikel 2(3), bepaal hoeveel addisionele organisasies en liggeme, indien enige, op die beheerliggaam verteenwoordig moet word kragtens paragrawe (a) tot (c ) van artikel 2(1).

(2) Die stemgeregtigde lede van die beheerliggaam moet onverwyld deur middel van geheime stemming en in afsonderlike stemrondes die bepaalde aantal organisasies en liggeme verkies vanuit die behoorlik benoemde kandidate vir elk van die kategorieë van paragrawe (a) tot (c ) van artikel 2(1).

(3) Elke stemgeregtigde lid van die beheerliggaam is geregtig op een stem ten opsigte van elke kandidaat, met 'n maksimum aantal stemme gelyk aan die aantal lede wat in elke stemronde verkies moet word.

(4) As 'n organisasie of liggaaam verkies word kragtens subartikel (2), is die organisasie of liggaaam daarop geregtig om hul eie verteenwoordiger op die beheerliggaam aan te wys ooreenkomstig hul eie interne prosedure.

(5) Na die verkiesing van die verteenwoordigers in subartikel (4) beoog—

- (a) moet die organisasie of liggaaam die prinsipaal skriftelik in kennis stel van die naam van die verteenwoordiger wat op die beheerliggaam aangewys is; en
- (b) moet die prinsipaal die Distriksverkiesingsbeampte skriftelik in kennis stel van die naam van die verteenwoordiger.

### **Wysiging van bepalings van Kennisgewing**

**8. Die Lid van die Uitvoerende Raad kan die bepalings van hierdie Kennisgewing wysig ten opsigte van 'n bepaalde skool vir leerders met buitengewone onderwysbehoeftes of ten opsigte van sulke skole in die algemeen.**

- (a) kemedi e tee go tšwa go sebopego se sengwe le se sengwe seo se thekgago sekolo ka tšelete, yeo e kgethilwego goba e beilwe ka go latela Nothisi ye;
- (b) kemedi e tee go tšwa go mokgatlo wo mongwe le wo mongwe wa batswadi ba baithuti bao ba nago le dinyakwa tša thuto tše di tlwaelegilego, wo o nago le kgahlego go sekolo, ba beilwe goba ba kgethilwe ka go latela Nothisi ye;

(2) Leloko la Khansele Phethiši le swanetše gore mo matšatšing a 30 tša Nothisi, le ka morago ga go bonana le sebopego sa taolo sa sekolo sa baithuti bao ba nago le dinyakwa tša thuto tše di kgethegilego, le bee palo ya—

- (a) magoro bogole; le
- (b) lefelo la maleba, sekolong seo.

3. (1) Mokgatlo goba sebopego seo se thekgago ka mašeleng, se ka dira kgopelo ka lengwalo go Leloko la Khansele Phethiši, pele go feta matšatši a 30 a Nothisi, ya gore se emelwe go sebopego sa sekolo sa baithuti bao ba nago le dinyakwa tše di kgethegilego, ka go latela diparagrafo tša (a), (b) goba (c) tša karolo ya 2(1).

(2) Kgopelo efe goba efe yeo e akantšwego go karowana ya (1) e tla hlaloša mabaka a gore ke eng mokgatlo goba sebopego seo se fanago ka thekgo se dumela gore se swanetše go emelwa go sebopego sa taolo.

(3) Ka tlase ga karolo ya 2(3), Leloko la Khansele Phethiši le tla re mo matšatšing a 30 ka morago ga go fela ga nako yeo e beetšwego dikgopelo, bjalo ka ge go akantšwe go karolwana ya (1), le ka morago ga go bonana le sebopego sa taolo sa sekolo seo se amegago, la amogela goba la ganana le kgopelo yeo.

(4) Ge Leloko la Khansele Phethiši le ganana le kgopelo ka go latela karolwana ya (3), Leloko le tla fa badirakgopelo mabaka ao a ngwadilwego a sephetho sa lona.




*Where is the largest amount of meteorological information in the whole of South Africa available?*
