

NOTICE 4598 OF 2001

TO ELICIT COMMENTS FROM INTERESTED PERSONS REGARDING THE INTENTION TO DECLARE TECHNICAL COLLEGES IN THE GAUTENG PROVINCE AS PUBLIC FURTHER EDUCATION AND TRAINING INSTITUTIONS AND FURTHER TO ELICIT COMMENTS REGARDING THE MERGER OF SPECIFIC DECLARED FURTHER EDUCATION AND TRAINING INSTITUTIONS INTO MERGED FURTHER EDUCATION AND TRAINING INSTITUTIONS

- I, Ignatius Patrick Jacobs, Member of the Executive Council, responsible for Education in the Gauteng Province, herewith give notice of my intent—
 - (a) to declare the following colleges as Further Education and Training Institutions;
 - Albertor College for Vocational Education as Alberton College for Further Education and Training;
 - Alexandra Technical College as Alexandra College for Further Education and Training;
 - Atteridgeville Technical College as Atteridgeville College for Further Education and Training;
 - · Benoni Technical College as Benoni College for Further Education and Training;
 - · Boksburg College as Boksburg College for Further Education and Training;
 - Brakpan College as Brakpan College for Further Education and Training;
 - Carletonville Technical College as Carletonville College for Further Education and Training;
 - · Centurion College as Centurion College for Further Education and Training;
 - · Dobsonville College as Dobsonville College for Further Education and Training;
 - Eastside Technical College as Eastside College for Further Education and Training;
 - George Tabor Technical College as George Tabor College for Further Education and Training;
 - Germiston College as Germiston College for Further Education and Training;
 - · Highveld Technical College as Highveld College for Further Education and Training;
 - · Isidingo Technical College as Isidingo College for Further Education and Training;
 - · Johannesburg Technical College as Johannesburg College for Further Education and Training;
 - · Kempton College as Kempton College for Further Education and Training;

I intend to make my decision to declare these institutions as further education and training institutions by not later than 11 September 2001:

- (b) to determine that I deem it in the best interest of education and the institutions concerned that the governance of the following cluster of institutions will be vested in single councils once they are declared as Further Education and Training Institution as contemplated in paragraph (a) above. A single council will be appointed in accordance with the notice of composition for such council and which notice will be published in the *Provincial Gazette* not later than 11 September 2001. A single council will be appointed for each of the following cluster of declared institutions:
 - (i) Alexandra, Johannesburg, Parktown, Eastside and Highveld;
 - (ii) Pretoria, Mamelodi and Soshanguve;
 - (iii) Pretoria West, Atteridgeville and Centurion;
 - (iv) Isidingo, Springs, Tlamoha, Brakpan, Benoni and Lazarus Nhlapo;
 - (v) Kempton, Germiston, Boksburg, Alberton and Usizo;
 - (vi) Carletonville and Randfontein:
 - (vii) Dobsonville, Roodepoort, Molapo, George Tabor and Krugersdorp;
 - (viii) Lekoa, Vereeniging and Vanderbijlpark.

(c) to merge the clusters of declared Further Education and Training Institutions concerned as contemplated in paragraph (b) (i) to (b) (viii), into eight Further Education and Training Institutions for the Gauteng Province. I intend to make my decision to merg these institutions by not later than 1 January 2002. The Interim Councils of the merged institutions will be appointed in accordance with the notice of composition for the merged institutions as contemplated in section 8 (4) of the Further Education and Training Act, No. 98 of 1998, which will be published in the *Provincial Gazette* not later than 1 January 2002.

In the Notice of Declaration as contemplated in paragraph (a), I will give further opportunity to respond concerning the merger of these institutions.
