



## GENERAL NOTICE

### NOTICE 1337 OF 2002

#### **DEPARTMENT OF FINANCE AND ECONOMIC AFFAIRS GAUTENG PROVINCE**

#### **INVITATION BY THE MEMBER OF THE EXECUTIVE COUNCIL: FINANCE AND ECONOMIC AFFAIRS, GAUTENG PROVINCE, FOR NOMINATIONS TO THE CONSUMER COURT**

1. A call for nominations to the Consumer Affairs Court is hereby made in terms of section 14 of the Gauteng Consumer Affairs (Unfair Business Practices) Act 7 of 1996 by the Member of the Executive Council responsible for Finance and Economic Affairs.
2.
  - (i) All interested persons are hereby invited to submit their written nominations for appointment of members to the Consumer Affairs Court.
  - (ii) Members of the court shall be appointed by the responsible Member of the Executive Council in concurrence with the standing committee of Economic Affairs.
  - (iii) A court shall consist of five persons, namely a chairperson, who shall be a retired judge of the Supreme Court; or an attorney, advocate, retired magistrate or lecturer in law at a university, with not less than 10 years cumulative experience in one or more such capacities; and four additional members having special knowledge or experience of consumer advocacy, economics, industry or commerce.
  - (iv) No person shall be appointed or remain a member of the court if he or she is not a fit and proper person or –
    - is not a citizen of the Republic resident in the Province;
    - is a public servant;
    - at the relevant time is, or during the proceeding 12 months was, an office-bearer or employee of any party, movement, organisation or body of a party political nature;
    - is an unrehabilitated insolvent;
    - has at any time convicted, whether in the Republic or elsewhere, of theft, fraud, forgery or uttering a forged document, perjury, an offence under this Act or the Corruption Act, 1992 (Act No. 94 of 1992), or any offence involving dishonesty; or

- has at any time been removed from an office of trust on account of misconduct.
- (v) Nominations should be submitted not later than 25 June 2002.
- (vi) The nomination must include the following information:

Full name of person and a certified copy of I.D, detailed C.V, motivation for nomination(not exceeding 1 page) and a letter from the person nominated agreeing to serve as a member of the Court.

#### **DEPARTEMENT FINANSIES EN EKONOMIESE SAKE GAUTENG PROVINSIE**

#### **UITNODIGING DEUR DIE LID VAN UITVOERENDE RAAD: FINANSIES EN EKONOMIESE SAKE, GAUTENG PROVINSIE, VIR BENOEMING VAN LEDE TOT DIE VERBRUIKERSHOF**

1. Benoeming word hiermee aangevra vir lede van die Verbruikershof in terme van artikel 14 van die Gauteng Verbruikersake (Onregverdige Skakepraktyke) Wet NR 7 van 1996, deur die Lid van die Uitvoerende Raad verantwoordelik vir Finansies en Ekonomiese Sake.
2.
  - (I) Alle belanghebbende partye word genooi om so gou as moontlik geskrewe benoemings in te dien vir lede van die Verbruikershof.
  - (ii) Lede van die hof sal aangestel word deur die verantwoordelike Lid in samewerking met die Staande Komitee vir Ekonomiese Sake.  
Die Hof sal uit vyf persone bestaan, naamlik 'n voorsitter, wat 'n afgetrede regter van die Hooggereghof sal wees; of 'n prokureur, advokaat, afgetrede landdros of dosent in die regte by 'n universiteit, met nie minder as 10 jaar kumulatiewe ondervinderding in een of meer van sodanige kapasiteete nie; en vier addisionele lede wat spesiale kennis of ondervinding het van verbruikersvoorspraak, ekonomie, nywerheid of handel.
  - (iii) Geen persoon sal aangestel word of 'n lid van die hof bly indien hy of sy nie 'n gesikte en gepaste persoon is nie of:-
    - nie 'n burger van die Republiek is wat in die Provinsie woonagtig is nie;
    - 'n staatsdiensamptenaar is nie;
    - gedurende die relevante tyd of gedurende die voorafgaande 12 maande 'n ampsdraer of werknemer van enige party, beweging organisasie of liggaam van 'n party-politieke aard is of was nie;
    - 'n ongerehabiliteerde insolvent is nie;
    - te eniger tyd skuldig bevind is aan, of dit ook in die Republiek of elders was, aan diefstal, bedrog, vervalsing of uitgee van 'n vervalste dokument, meineed, 'n oortreding van hierdie Wet of die Wet op Korruksie,

- 1992, (wet Nr. 94 van 1992), of enige oortreding wat oneerlikheid insluit, of
- te eniger tyd vanuit 'n amp van vertroue verwyder is weens wangedrag.

(iv) Die benoeming moet die volgende inligting insluit:

Die volle name van die persoon en 'n gesertifiseerde afskrif van die persoon se identiteitsdokument, 'n volledige Curriculum Vitae, 'n motivering vir benoeming ( moet nie een bladsy oorskrei nie) en 'n brief van die persoon wat benoem word waarin hy/sy instem om as lid van die Verbruikershof te dien.

(V) Nominasies moet gedoen word nie later nie as 25 Junie 2002.





