



GOVERNMENT: MUNICIPAL DEMARCATION ACT, 1998 READ  
WITH SECTION 2 OF THE LOCAL GOVERNMENT: CROSS-  
BOUNDARY MUNICIPALITIES ACT, 2000  
(Gauteng/North West)

Under section 21 of the Local Government: Municipal Demarcation Act, 1998 (Act No. 27 of 1998) the Municipal Demarcation Board has re-determined the municipal boundaries of Moretele Local Municipality (NW371), Bojanala District Municipality (DC37) and City of Tshwane Metropolitan Municipality, by excluding a portion of Portion 8 of the farm Boschplaas 091 (JR), from the municipal area of Moretele Local Municipality (NW371) and Bojanala District Municipality (DC37) and by including the Portion in the municipal area of City of Tshwane Metropolitan Municipality.

This re-determination is subject to the concurrence of the legislatures of the provinces involved, and authorisation by national legislation provided for in section 2 of the Local Government: Cross-Boundary Municipalities Act, 2000.


