

GAUTENG HOUSING ACT, 1998

FIRST AMENDMENT OF THE REGISTRATION OF SOCIAL HOUSING INSTITUTIONS REGULATIONS, 2003

The Member of the Executive Council responsible for Housing has under section 25 of the Gauteng Housing Act, 1998 (Act No. 6 of 1998), made the regulations in the Schedule.

Amendment of Regulation 3 of the Regulations

- 1. Regulation 3 of the Regulations is hereby amended by the substitution for the general part of subregulation (2) of the following subregulation:
 - "(2) The [information] registration officer and the deputy [information] registration officer must possess most of the following skills and knowledge"

Amendment of Regulation 9 of the Regulations

- 2. Regulation 9 of the Regulations is hereby amended by the substitution for subregulation (2) of the following subregulation:
 - "(2) The registration officer may, when registering institutions, distinguish between-

- (a) [tertiary] tier 1 institutions, which act as promoters or capacitors of social housing and assist other institutions by providing support and capacity;
- (b) [secondary] tier 2 institutions, which have sufficient internal capacity to function as an institution; and
- (c) [primary] tier 3 institutions, which in the normal course of their business, need to enter into agreements or partnerships with registered [primary] tier 3 or [secondary] tier 2 institutions, to acquire capacity to carry out their core business."

Amendment of Regulation 10 of the Regulations

- 3. Regulation 10 of the Regulations is hereby amended by the addition of subregulation (4) after subregulation (3):
 - "(4) The decision of the MEC is final and binding on the parties.".

Amendment of Regulation 12 of the Regulations

4. Subregulation 12 (3) of the Regulations is hereby amended by the substitution for the word "they" where it occurs in paragraphs (e); (f); (h); (i); (k); (n); (o); and (p) of the phrase "the institutions".

5. Schedule 2 of the Regulations is hereby amended by the substitution of the
