



LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998

AMENDMENT OF NOTICE ESTABLISHING THE CITY OF JOHANNESBURG METROPOLITAN MUNICIPALITY

SCHEDULE

Notice No. 6766 of 2000, published in the *Gauteng Provincial Gazette Extraordinary* No. 141 dated 1 October 2000, as amended, is hereby further amended by amending the Schedule thereto as follows:

AMENDMENT OF PART 2

Amendment of clause 7

Clause 7 is hereby amended by the substitution therefor of the following clause:

- "7. Any or all of the following office bearers may be designated by the City of Johannesburg Metropolitan Municipality as full-time councillors:
- (a) The Speaker;
 - (b) the Executive Mayor;
 - (c) Members of the Mayoral Committee; and
 - (d) a single whip for the Council."
