

EXTENSION OF NOTICE NO 2911 OF 2003 / GAZETTE NO: 402
DEPARTMENT OF PUBLIC TRANSPORT, ROADS AND WORKS

GAUTENG PUBLIC PASSENGER ROAD TRANSPORT ACT (ACT NO.7 OF 2001)

APPLICATION OF SPECIAL MEASURES IN THE AREA OF JURISDICTION OF THE GREATER EAST RAND (EKURHULENI) METROPOLITAN MUNICIPALITY.

I, Khabisi Mosunkutu, Member of the Executive Council for Public Transport, Roads and Works in the Province of Gauteng, being of the opinion that it is necessary to normalize the situation in the area caused by violence, unrest and instability in the mini-bus taxl industry, that in the interests of passengers and on basis of recent reports that indicates that the situation in terms instability, unrest has been restored on certain taxl route operations. I therefore hereby declare the area of jurisdiction of the Greater East Rand (Ekurhuleni), Metropolitan Municipality in terms of section 93(3) of the Gauteng Public Passenger Road Transport Act, 2001 (Act No. 7 of 2001) to be an area where the special measures provided for in section 93(3) will be applicable.

- The following routes and ranks will be closed for minibus taxl-type service for a period commencing at 00h01 on Tuesday, 7TH October 2003 to 00h01 21st October 2003.
- **1.1.1 GE0355 Brakpan to Germiston** described as follows; Station Road, Voortrekkers Street, Hendrick Potgleter straight Airport Road, Leeuwkop Road, M46, Boksburg Road, Railway street, in Germiston, Plantation Street into Germiston Station Taxi Rank and return.
- **1.1.2 GEO356 Brakpan to Johannesburg** described as follows; Alberton Rd, Heldelberg Rd, N17 off ramp, Pretoria Rd, M2, Harrow Road, Anderson Street, Troye Street, Commissioner street, Von Weileigh Street, Klein Street, Plein Street, Wanderes street, offload cnr Wanderes & Noord Street and return. Vice Versa
- **1.1.3 GEO364 Brakpan to BENONI** described as follows; Station Road, M56, New in Fontein Road, R23, Rangeview Road, Lancaster Road, Dagenham Street, Bolton, Luton into Benoni Station Taxi Rank and return.
- **1.1.4 GEO365 Brakpan to Springs** described as follows; From Brakpan Station Taxi Rank to Spring Taxi Rank and return.

1.2 RANKS

- **1.2.1 Johannesburg Taxi Rank Inside Brakpan main Taxi Rank** Situated at the corner of Station Road and Victoria Street.
- 2. No person may undertake mini-bus taxi-type services on the routes and ranks as specified in regulation 1 during the indicated period. Any person who does so will commit an offence and will be liable for conviction to imprisonment for a period not exceeding six months or a fine not exceeding R10 000, or both a fine and imprisonment.
- 3. Regulations 1 may be withdrawn earlier by a notice in the Government Gazette in a case of reports and information received indicating that the security situation of participants in the taxl industry as well as passengers in the above area has been normalized. In this regard reports in respect of the progress to reach an agreement between the various participants in the taxl industry, supported by satisfactory supporting mechanisms to ensure that discipline in the industry can practically be enforced, will be taken into account when the normality / abnormality of the situation and the question whether regulation is still necessary as assessed by the MEC for Public Transport, Roads and Works (Gauteng Provincial Government) on a daily basis.

APPLICATION OF SPECIAL MEASURES IN THE AREA OF JURISDICTION OF THE GREATER EAST RAND (EKURHULENI) METROPOLITAN MUNICIPALITY.

I, Khabisi Mosunkutu, Member of the Executive Council for Public Transport, Roads and Works in the Province of Gauteng, having already declared the area of Ekurhuleni Metropolitan Municipality, as an area where it is, in my opinion, necessary to normalise the situation in the area caused by violence, unrest and instability in the taxl industry and in the interest of passengers, and having also made known by General Notice my Intentions to close routes and ranks as described in the Schedule to the General Notice in terms of Section 93(3) of the Act. I have duly considered the representations and other information brought to my attention. I am of the opinion that the situation is still abnormal and the closure of ranks and routes as mentioned hereinafter is absolutely necessary to normalise the situation, I now make the regulations in terms of Section 93 (2) of the Act, contained in the schedule hereto.

- 1.1.1 GE0387 Zonkizizwe to Thokoza described as follows;
 From Zonkizizwe Taxi Rank via Heidelberg Road to old Vereening Road to Khumalo Street in Thokoza and return to Zonkizizwe Taxi Rank with the same route.
- 1.1.2 GEO388 Zonkizizwe to Palmridge described as follows;
 From Zonkizizwe Taxi Rank vla Heidelberg Road to Rletfontein Road to Palmridge and back to Zonkizizwe Taxl Rank with the same route
