



### NOTICE 2009 OF 2004

#### ROAD TRAFFIC ACT 1996 (ACT NO. 93 OF 1996)

##### NOTICE OF REGISTRATION OF TESTING STATION (SECTION 39) AND AUTHORITY TO APPOINT EXAMINERS OF VEHICLES (SECTION 3A(1)(f))

I, Sarel Johannes van Deventer, (Acting) Manager (Vehicle and Driver Licensing) authorized under section 91 of the Road Traffic Act, 1996, (Act No. 93 of 1996)-

- (1) hereby give notice in terms of section 39 of the Road Traffic Act, 1996, of the registration of Bateleur Germiston testing station with infrastructure number 49512C3J , as a B-grade with 2.5m height restriction testing station; and
  - (2) hereby determine under section 3A(1)(f) of the Road Traffic Act, 1996, Bateleur Germiston testing station , with infrastructure number 49512C3J to be an authority which may appoint a person as an examiner of vehicles, on condition that -
    - (a) such a person has obtained a diploma in the examination for examiners of vehicles at a centre approved by the Minister of Transport; and
    - (b) appointment takes place subject to the condition that vehicles may only be examined at Bateleur Germiston testing station.

##### KENNISGEWING VAN REGISTRASIE VAN TOETSSTASIE (ARTIKEL 39) EN MAGTIGING OM ONDERSOEKERS VAN VOERTUIE AAN TE STEL (ARTIKEL 3A(1)(f))

Ek, Sarel Johannes van Deventer, (Waarnemende) Bestuurder (Voertuig en Bestuurders Licensieëring), ingevolge artikel 91 van die Padverkeerswet, 1996 (Wet No. 93 van 1996), gemagtig, -

- (1) gee hiermee, ingevolge artikel 39 van die Padverkeerswet, 1996, kennis van die registrasie van Bateleur Germiston toetsstassie , met infrastruktuurnummer 49512C3J, as 'n B-Graad met 2.5m hoogte beperkings 2.5m hoogte toetsstasie; en
- (2) bepaal hiermee kragtens artikel 3A(1)(f) van die Padverkeerswet, 1989, dat Bateleur Germiston toetsstassie, met infrastruktuurnummer 49512C3J met 2.5m hoogte beperkings 'n instansie is wat 'n persoon as 'n ondervroegter van voertuie kan aanstel, op voorwaarde dat -
  - (a) so 'n persoon 'n diploma in die eksamen vir ondervroegters van voertuie by 'n sentrum wat deur die Minister van Vervoer goedgekeur is, verwerf het; en
  - (b) aanstelling geskied onderworpe aan die voorwaarde dat voertuie slegs by Bateleur Germiston toetsstassie, ondervroeg mag word.
