



**NATIONAL ROAD TRAFFIC ACT 1996 (ACT NO. 93 OF 1996)
AND ROAD TRAFFIC ACT, 1989 (ACT NO. 29 OF 1989)**

**NOTICE OF REGISTRATION OF TESTING STATION (SECTION 39) AND AUTHORITY TO
APPOINT EXAMINERS OF VEHICLES (SECTION 3(1) (e))**

I, Sarel Johannes van de Venter (Acting) Director (Vehicle and Driver Licensing), authorized under section 91 of the National Road Traffic Act, 1996 (Act No. 93 of 1996) -

- (1) hereby give notice in terms of section 39 of the National Road Traffic Act, 1996, of the registration of A Plus testing station, with infrastructure number 49512CZ1, as a B-Grade testing station; and
 - (2) hereby determine under section 3 (1) (e) of the Road Traffic Act, 1989 that A Plus testing station, with infrastructure number 49512CZ1, is an authority which may appoint a person as an examiner of vehicle, on condition that -
 - (a) such a person has obtained a diploma in the examination for examiners of vehicles at a centre approved by the Minister of Transport; and
 - (b) appointment takes place subject to the condition that vehicles may only be examined at A Plus testing station.

Ek, Sarel Johannes van Deventer (Waarnemende) Direkteur (Voertuig- en Bestuurderslisensiëring), ingevolge artikel

91 van die Nasionale Padverkeerswet, 1996 (Wet No. 93 van 1996) gemagtig -

- (1) gee hiermee, ingevolge artikel 39 van die Nasionale Padverkeerswet, 1996, kennis van die registrasie van A Plus toetsstasie, met infrastruktuurnummer 49512CZ1, as 'n B-Graad toetsstasie; en
- (2) bepaal hiermee kragtens artikel 3 (1) van die Padverkeerswet, 1989, dat A Plus toetsstasie, met infrastruktuurnummer 49512CZ1, 'n instansie is wat 'n persoon as 'n ondersoeker van voertuie kan aanstel, op voorwaarde dat -
 - (a) so 'n persoon 'n diploma in die eksamen vir ondersoekers van voertuie by 'n sentrum wat deur die Minister van Vervoer geadgekteur is, verwerf het; en
 - (b) aanstelling geskied onderworpe aan die voorwaarde dat voertuie slegs by A Plus toetsstasie, ondersoek mag word.
