



LOCAL AUTHORITY NOTICE 336

PROCLAMATION

In terms of section 49(1) of the Deeds Registries Act, 1937 (Act 47 of 1937), read with section 88(1) of the Town Planning and Townships Ordinance, 1986 (Ordinance 15 of 1986), I hereby extend the boundaries of Darrenwood Extension 2 township to include the Remainder of Portion 306 of the farm Klipfontein No. 203-I.Q., subject to the conditions set out in the Schedule hereto.

SCHEDULE

1. CONDITIONS OF EXTENSION

(1) DESCRIPTION OF LAND

The said Remainder of Portion 306 Klipfontein No. 203-I.Q. shall be known as Erf 305 in the township of Darrenwood Extension 2.

(2) ENGINEERING SERVICES

The erf owner shall make the necessary arrangements with the Local Authority in regard to the provision of engineering services in terms of Section 88(3)(b)(i) of Ordinance 15 of 1986.

(3) DISPOSAL OF EXISTING CONDITIONS OF TITLE

All erven shall be made subject to existing conditions and servitudes, if any, but excluding the following:

- (a) Condition A on page 3 of Certificate of Consolidated Title T 30927/2001 being a right to lead water.
- (b) Condition B2 on page 3 of the said CCT T 30927/2001 being a servitude of right of way.
- (c) Condition B3 on page 4 of the said CCT T 30927/2001 being restrictions on subdivision and use of the land.
- (d) Conditions C1, C2 and C3 on page 4 and 5 of the said CCT T 30927/2001 which do not affect Erf 305.
- (e) Condition D1 on page 5 of the said CCT T 30927/2001 being a right of way.
- (f) Condition D4 on page 6 of the said CCT T 30927/2001 being restrictions on subdivision and use of the land.
- (g) Condition E2 on page 7 of the said CCT T 30927/2001 being restrictions on subdivision and use of the land.
- (h) The servitudes of right of way created by Notarial Deed K 4844/2005 S and endorsed on page 11 of the said CCT 39027/2001 which do not affect Erf 305.

2. CONDITIONS OF TITLE**CONDITIONS IMPOSED BY THE ADMINISTRATOR IN TERMS OF THE PROVISIONS OF THE TOWN-PLANNING AND TOWNSHIPS ORDINANCE 1986 (ORDINANCE 15 OF 1986)****ALL ERVEN**

- (1) The erf is subject to a servitude, 2 m wide, in favour of the local authority, for sewerage and other municipal purposes, along any two boundaries other than a street boundary and in case of a panhandle erf, an additional servitude for municipal purposes 2 m wide across the access portion of the erf, if and when required by the local authority. Provided that the local authority may dispense with any such servitude.
- (2) No building or other structure shall be erected within the aforesaid servitude area and no large-rooted tree shall be planted within the area of such servitude or within 2 m thereof.
- (3) The local authority shall be entitled to deposit temporarily on the land adjoining the aforesaid servitude such material as may be excavated by it during the course of the construction, maintenance or removal of such sewerage mains and other works as is in its discretion may deem necessary and shall further be entitled to reasonable access to the said land for the aforesaid purpose subject to any damage done during the process of the construction, maintenance or removal of such sewerage mains and other works being made good by the local authority.

2. TITELVOORWAARDES**VOORWAARDES OPGELE DEUR DIE ADMINISTRATEUR INGEVOLGE DIE BEPALINGS VAN DIE ORDONNANSIE OP DORPSBEPLANNING EN DORPE, 1986 (ORDONNANSIE 15 VAN 1986)****ALLE ERWE**

- (1) Die erf is onderworpe aan 'n servituut 2m breed, vir riolerings- en ander munisipale doeleinades, ten gunste van die plaaslike bestuur, langs enige twee grense, uitgesonderd 'n straatgrens en, in die geval van 'n pypsteelerf, 'n addisionele servituut vir munisipale doeleinades 2m breed oor die toegangsgedeelte van die erf, indien en wanneer verlang deur die plaaslike bestuur.
