TRANSPORT FORUM.


1. I, Mbazima Shilowa, Premier of the Gauteng Province under section 21 of the Intergovernmental Relations Framework Act, 2005 (Act No.13 of 2005) hereby establish the Gauteng Intergovernmental Transport Forum as detailed in the Schedule.

2. In accordance with section 21(3) of the Intergovernmental Relations Framework Act, 2005 (Act No.13 of 2005), I disestablish the Gauteng Transport Consultative Forum and Transport Co-ordination Committee established in terms of section 35 and 36 respectively of the Gauteng Transport Framework Revision Act , 2002 (Act No. 8 of 2002)

SCHEDULE

Objects of the Gauteng Intergovernmental Transport Forum

1. The objects of the Gauteng Intergovernmental Transport Forum (hereinafter referred to as "the Forum") are to provide a joint platform to discuss transport-related policies and needs in the Province in accordance with the objects of the Global City Region Perspective by –
 - (a) establishing and maintaining an effective consultative forum between local and provincial political representatives holding transport and planning portfolios;
 - (b) facilitating the identification of collective needs; and
 - (c) giving strategic input on the planning and provision of transport infrastructure and services within the Province.

Composition of the Gauteng Intergovernmental Transport Forum

2. The Forum consists of -
 - (a) the MEC responsible for transport in the Province who is the chairperson of the Forum;
 - (b) the MEC responsible for planning in the Province;
 - (c) the Members of the Mayoral Committees responsible for the following functions at local government-
 - (i) Transport and
 - (ii) Planning.
 - (d) any other relevant Member of the Executive Council or Mayoral Committee that may be invited by the Chairperson from time to time.

Meetings and Administrative Matters

3. (1) The MEC for Transport in the Province –
 - (a) convenes the meetings of the Forum, and

- (b) determines the agenda for meetings of the Forum.
- (2) suggestions for inclusion in the agenda for meetings may be submitted to the MEC in terms of a framework determined by the MEC.
- (3) the Department of Public Transport, Roads and Works is responsible for providing administrative and other support services to the Forum.

Reports to the Premier's Intergovernmental Forum

4. The forum-

- (a) must report at least annually to the Premier's Intergovernmental Forum on progress regarding the implementation of the objects of the Forum, and
 - (b) may report to the Premier's Intergovernmental Forum on matters of provincial interest that have arisen in the Forum.
