Under the powers vested in me by section 23(2) (b) of the Local Government: Municipal Demarcation Act, 1998 (Act No. 27 of 1998) and section 6 (3) (b) of the Local Government Municipal Structures Act, 1998 (Act No. 117 of 1998), I Qedani Dorothy Mahlangu, Member of the Executive Council responsible for Local Government in the Province of Gauteng, hereby determine that the re-determination of the municipal boundaries of the municipalities as indicated by the Municipal Demarcation Board in the notices as published in the Gauteng Provincial Gazettes, and on the dates set out in the Schedule hereto, and after the Independent Electoral Commission's Notice No's. 2485 & 2486 as published in the Gauteng Provincial Gazette Extraordinary No's 180 & 181 dated 3 July 2008.
